INAUGURAL ADDRESS BY PRESIDENT KEN FARN ROTARY SERVING HUMANITY

Club Structure: Board Of Directors: (8 returning & 7 new)

Work of our club is divided in to 70 committees, manned by close to 700 club membersso the majority of members are significantly involved in the work of our club!

Membership:

We currently have 152 active members and 11 honorary members = 163. A healthy 3 to 4% growth has been our experience. Extra emphasis has been placed on new member recruitment and mentoring, to keep club vibrant and growing. Women make up approximately 15 % of our active membership, but is expected to grow to 20% in the next couple of years. We have 5 committees focused on Membership issues. Because membership is so important, I plan to meet with the chairs of these 5 committees in the next few weeks to discuss goals, operating procedures and need for good communication between these committees.

Also under Membership: **Millennium Associates** Chaired by **Geoff Hughes**, a new venture for our club and building block for membership in our club. The committee will reach out in a systematic way to 25 to 40 yr. olds to encourage them to get involved in meaningful ways that will give back to the community.

Financial Matters: As our club has grown in size, accounting procedures have had to change with it. CRA is a big part of our financial reporting process in order to maintain our "Charitable Society" status. The Provincial Government is also more involved, so when we apply for Lotteries like 50/50 at Country Thunder or Casino License, they are requiring a lot of information including up-to-date financials and Audited Statements. So the job of financial management, which has always been important, continues to grow, in our everyday activities! We have been privileged to have Art Borzel doing our financials for many years (25+ years). Art has created accounting systems that have allowed us to become a "Charitable Society" and his legacy is good financial systems that we can grow with.

Larry Kennedy inherited the role of Treasurer from Art a few years ago and will remain in that role for the foreseeable future, but the role is also changing. We are very pleased that **Larry Stein** has accepted an "Assistant Treasurer" role, beginning this year, allowing Art Borzel to back away from responsibilities he has shared as Assistant Treasurer. Art continues to be a valuable resource for both of our "Larry's" and is still available, but his daily office hours are short.

Financial Summary: We have a substantial Financial Reserve, capable of funding club operations for a year. Each year we only spend the previous year's earnings. What is earned this year, will be available for spending next year. Legacy Projects are an Exception, because of their Multi-Year funding structure and are approved separately by membership.

Revenue Forecast:

CRCF: \$115,000 to be split 50/50 with SIS Scholarship Foundation and re-Investment back into CRCF **2016 Dream Home & Split 'em 50 Lottery**: estimated at \$475,000. Dream Home proceeds will be lower than last year, but with the Split 'em 50 added we will come out close to last year's results. Which is a significant considering the rainy weather and soft economy.

SIS Golf Tournament: estimated at \$25,000 net of expenses

Country Thunder Lottery at \$50,000

a) Community Service: 50/50 Lottery @ \$50,000 b) Club Service: Bar Sales & Service @ \$100,000

Casino: Scheduled for second quarter of 2017. Revenue estimated at: \$70,000-\$75,000

APPLICATION OF FUNDS:

SIS Scholarship Fund: should receive approx. \$225,000. <u>Goal</u> \$3.2M - \$4.0M ASAP (Golf @ \$125,000, CRCF @ \$55,000 & Personal Donations @ \$45,000)

World Community Service: will receive estimate at: \$100,000

Small Grants: Community: Est. @ \$100,000 and **Large Grants: Community:** To be Determined. Last year's \$100K Grant was rolled back and applied to Rotary Greenway project to give more flexibility to fund the Rotary Bethany Partnership's "Rotary Atrium Garden" this year.

Rotary Mattamy Greenway: @ \$100,000 (Last Payment of \$1.0M - 5 year commitment)

Rotary Bethany Partnership: RI has for several years identified a need to support senior's care. The biggest health issue for seniors is Alzheimer's disease and related Dementia, which is a leading cause of disability among seniors today. In Calgary alone there are more than 13,000 seniors living with dementia and yet there are only about 2,000 dementia care beds. This shortfall will double in the next few years. For the past two years several Rotary Clubs, including Calgary South, have worked to develop a Legacy Pro-

ject within Calgary's Seniors Care Services. We have created the Rotary Bethany Partnership with the goal of raising \$1,000,000 to build an indoor garden atrium in a new seniors facility in Bethany's Riverview Senior's Campus of Care. The atrium will be named The Rotary Atrium Garden.

This is our first initiative in Senior's Care and will yield long-term exposure for Rotary. Once Agreements are done, Rotary will become the "lead" donor for Bethany's \$5.0 M public fund raiser. Rotary's name will help Bethany raise financial support and we will gain significant public exposure before the project is completed and for many year thereafter.

Club Activities:

Community Volunteering: Without Feed the Hungry this year, Harry Pelton will be looking to find a new community project to focus on and we look forward to hearing from him in that regard. If you have suggestions speak to Harry.

Youth Services: Support for youth continues to be an important cornerstone for Rotary so we are attempting to shore up these committees with energetic people who are passionate about getting youth involved in community. **YEX** – is a hugely successful international program for senior high school students. Under Ron Prokosch's leadership we have made a difference in many students lives.

High School Partnerships such as St. Mary's have not gotten the traction we want in recent years and will be reviewed with the committee and director to find mutually acceptable ways forward.

Stay in School Scholarship: Stay-In-School Scholarship program remains a cornerstone in our youth development strategy.

Goal is to support a 40 student population base, while growing our financial resources to \$4.0 M from \$3.2M - Current scholarship remains at \$7,500 per year - max 4 years payout.

Social Committee: Toby Oswald Felker Chairperson 17 members

We need a new chair for the Radium Weekend Event as Lynn is stepping back due to his responsibilities with Stampede Lotteries. Thank you Lynn for your support and hard work on this committee.

Social Committee's Philosophy

Control Costs & Reduce Ticket Prices while maintaining Quality, Ramp up the FUN in all events, Broaden Appeal to all Members. Our goal is to make sure we are having fun so the hard work of fundraising is worthwhile.

Closing: Our Finances look to be in good shape, the hard work of Fund Raising is almost behind us So let the fun begin with the Olde Tyme Country Picnic.

Instead of the Club making a donation to the SIS Scholarship Fund, I will donate \$100 to the Fund, to express my gratitude for allowing me to represent Calgary South this year, as your president.



TIME IS RUNNING OUT TO PARTICIPATE IN THIS GREAT FUNDRAISER

Charlie Goldsborough is running rostering, quick on the heels of Dream Home, but with great benefit to both our club, and to the funds we can contribute to charities.

Everyone is asked to invite family and friends to volunteer if they are interested – it's a great benefit to volunteer because even if they only do one shift, they will get a bracelet that let's them into the full 3 days of the festival.

There are 3 possible jobs: bartending, selling tickets and giving wristbands to everyone over 18. Most shifts are in the bartending and ticket selling. Not difficult – only 3 types of hard liquor: rum rye and vodka, and then beer. All beverages are paid with a ticket so no handling of cash. Jiggers and spouts provided and lots of opportunities for breaks.

Ticket selling is a sit down job. For those serving alcohol or selling alcoholic tickets, you need your ProServe certification. Imagine the "cool factor" when you tell your kids and grandkids that you are a licensed bartender! And it's good for five years, so you will have bragging rights to 2021.

Getting the ProServe is a two step process.

First, register and get an individual registration number at: $\underline{www.proserve.aglc.ca}$. Click on "create an account". The event venue will be "unknown", as will the employer.

After registering, let **Don Taylor** or **Charlie Goldsborough** know.

Send them your name, email address & 12 digit registration number found at the top of your Personal Information page. Don or Charlie will let AGLC know that you are a part of Rotary Country Thunder group so you can complete the course for free.

AGLC will contact you in 2 days to let you know you have been cleared to take the course. You will have up to 30 days to complete it and it takes 2 – 2.5 hours.

The deadline for this process is August 15 – if you register after that you will need to pay the \$26.50.

Past President Murray is having "ProServe" sessions during the week at 2:30 pm in his boardroom. Bring a lap top and register for proserve for this great cause.

All the Country Thunder committee members have taken the course so they can help you. Plus, **Murray Flegel** has offered his boardroom if you arrive with your laptop to ensure it is a painless process for you.





















Special Edition of Hannah's Happenings: "The second return"

A record field of 148 golfers formed 37 teams for the 2016 SIS Golf Tournament at Cottonwood Golf and Country Club on July 28th, and raised approximately \$140,000 for the SIS Program.

The day dawned with grey skies to the east, but clear to the west and by 10 AM the heat of the day was already starting to build. The afternoon was sunny, hot and humid and golfers were treated to a near-perfect day, with lots of food and drink to help them along. As always, one of the favourite features of the tournament was Michael Zacharki's fish and chips facility on the course, where Mike and Bill Sumner saw few quiet moments as golfers lined up for the delicious halibut and chips from Mike's Creative Catering. Halo's Restaurant was also on site, repeating last year's very popular barbequed bacon-wrapped shrimp, and Spolombo's Sausage also had a line-up (as usual) for their barbequed Italian sausages.

When not eating, golfers attended to the business at hand, but the Toyota and Lexus automobiles offered for a hole-in-one on the Par 3s were safe, as was the \$1,000,000 prize offered in the Peloton Shoot-out for the 12 golfers scoring closest to the pin on the four Par 3s.



Once inside the action got more frantic as auctioneer Ken Copithorne deftly relieved bidders on tens of thousands of dollars, and draws for held from the "Tub Draw" raffle tickets that had been sold by our volunteers throughout the day.








HIKING CLUB: AUG 5TH 2016



The canyon itself is very deep with amazing blue water.














At the Paint Pots there is ochre being produced by the minerals in the stream.


This is one of three impressive paint pots which are all different colours.
