- ♦ The word Hanukkah means "dedication."

- Gifts were not always given for Hanukkah. The tradition was to give money. It became more common to exchange gifts as the Christmas tradition became more popular
- Hanukkah is not the most important Jewish holiday
- Over 17.5 million jelly donuts are consumed in Israel throughout Hanukkah





















Dilan thanked Rabbi Krygier for enriching our club with a broadening message of inclusion. It was something new, interesting and fun. Thank You.






#### **IN CLOSING: President Stokke:**

#### **NEWS ARTICLE:**

Past President Keith Davis sent the following news article over for inclusion in the bulletin. News Release: Stampede Lotteries / RCCSP

Calgary, Alberta, December 2, 2021 - The Holiday Spirit arrived early for many Calgarians today when the Calgary Stampede Lotteries Committee presented a cheque to the Rotary Club of Calgary at Stampede Park in the amount of \$598,801 for distribution to Calgary charities.

The money was earned by the Rotarians working in partnership with Stampede Lotteries to raise money for Calgary charities. Stampede Lotteries will retain a similar amount for its own charitable giving, distributing many hundreds of thousands of dollars to Stampede-supported charities.

Two other partners in Stampede Lotteries are the Kinsmen Club of Calgary and the Calgary Show Band Parents Association, both of which also earned significant amounts of money for charitable purposes.

The Rotary Dream Home/Stampede Lotteries' working relationship began 38 years ago and ranks among the oldest and most successful charities in Calgary. The Dream Home lottery is licensed to the Calgary Stampede, but the organization and workforce to carry out the lottery is handled by hundreds of Rotarians and the women and men who volunteer to cumulatively work thousands of 'man hours' every year to stage the event.

Jim Bladon, Rotary Dream Home Committee Chair for the 2021 Dream Home, said the millions of dollars that have been raised by the lottery over the years has changed the lives of many Calgarians and organizations that then funnel the money to scores of charitable organizations in Calgary.

"Over the life of the Dream Home Lottery we have helped out hundreds of organizations and many thousands of Calgarians with the money we have earned through our partnership with Calgary Stampede Lotteries," he said. "We and others in the City of Calgary have much to be thankful for from this association with Stampede Lotteries. We couldn't do it without them, or without our many hundreds of volunteers who pitch in every year."

Bladon provided examples of organizations which have benefitted from the Stampede Rotary Dream Home lottery in the past few years, including The Libin Cardiovascular Institute, Ronald McDonald House, Southern Alberta Brain Injury Society, SAIT Scholarship Program, Calgary Interfaith Food Bank, Rotary Youth Exchange Program, Canadian Diabetes Association, Rotary Challenger Park, Southern Alberta Urology Centre & Chair, Learning Disabilities Association of Alberta, Feed the Hungry, and many more.

The Rotary Club of Calgary at Stampede Park is the second-oldest Rotary Club in Calgary, having been formed in 1958. It is also the second largest Rotary club in Calgary with more than 120 members.

The <u>Calgary Stampede Lotteries</u> has been a special part of the Calgary Stampede for more than 60 years, supporting local charities and making a positive contribution to our community.

Every year proceeds from the Lottery are directly reinvested in the community through Calgary Stampede and their service club partners: Kinsmen Club of Calgary, Rotary Club of Calgary at Stampede Park and the Calgary Marching Show Band Association
