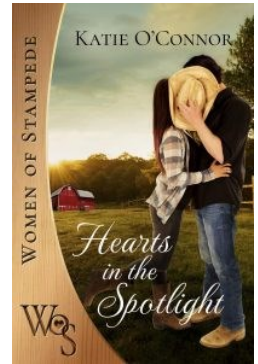

*God bless Brett Wyatt and his enormous heart. She watched him chat to the crowd for a moment, making merry as if he'd done nothing special. Her breathing grew tight and happiness flowed through her. Her hand flew to her mouth to hide her smile.*

*Sweet heaven, she loved him. She wrapped her arms around herself in a hug, savoring the feeling, reveling in the emotional moment. It wasn't often one fell in love, and it was even more rare that you knew the exact moment. She'd treasure this moment, this concert and this man for the rest of her life.*

It's knowing that there are loving and generous people out there, like Stephanie and Brett that inspire me to write. Of course, there are overheard conversations and flashes from movies or television that inspire me to wonder what would happen if I did this instead?

As a bonus, writing a story and making it all up is a bit like telling a glorious whopper of a lie and getting away with it. And really, who doesn't want to do that. Come on, admit it. Just once, you'd like to tell the biggest lie ever and not get caught.

But stories are more than lies. They hold truths, universal truths in many cases. Properly written, they can give us insights into our own lives, or the lives of those around us. They bring us ideas we might not have considered before, sometimes they enlighten us and change our minds about long held beliefs.

As for me, my message is simple. My stories are about family and friends. Overcoming odds. Growing lives. Nurturing love and having second chances. But the biggest message I hope to portray is hope. Hope for the future, for all of us. Love and hope are two of the qualities you'll find in all the novel in the Women of Stampede series.

Shelley Kassian and I came up with the idea of writing a series that would keep our love of romance and the Calgary Stampede alive all year. Our desire was to promote Stampede and our glorious city. It's an enormous project to write a book and have it ready for publication in only seven months. It's an even bigger commitment to organize the ladies, read their rough drafts and offer constructive criticism and encouragement all while writing your own story. This is the task Shelley and I took on.

What we wanted to accomplish with this project is to mentor newer authors through the process of writing, revising, editing and independently publishing a novel. Carol Furst and Nicole Roy were unpublished. Both had written a first novel, but neither had secured a publishing contract.

The series is about women who are in some fashion associated with Stampede. We've got characters from all walks of life and countless career paths. Strong independent women who fall in love with strong independent men and in doing so become stronger together. The series was very successful with two books landing onto the Calgary Herald's top ten fiction books during Stampede. Mine was #8. Nicole's was #4.

How does the Women of Stampede series fit in with The Rotary Club?

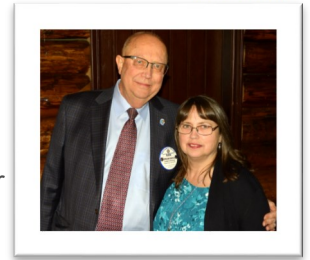
A portion of the proceeds from my story, *Hearts in the Spotlight*, book one of the series, is being donated to Ronald McDonald House in Edmonton in appreciation for all the help they gave my family during our stay there. My first granddaughter was born with a minor heart defect and complete tracheal rings. As I understand it, tracheal rings are supposed to be soft at the back. Hers were not. They were solid all around. Her trachea was grossly undersized, making it difficult for her to breath and swallow.

In a lengthy procedure the doctors at the Stollery Children's Hospital cut her trachea apart, sliced it and re-joined it to make it wider. While they were in there, cut one artery free of the heart, removed a piece of it and refastened it. Throughout this procedure, we were housed by Ronald McDonald House. They looked after all our needs and gave us a warm, supportive place to unwind. They really are a home away from home. We still communicate with several families we met during our stay.

We'd have been lost without the help of RMH. Their support is why I graciously and gratefully donate a portion of my proceeds to their fabulous organization. I'll be dropping a check off at their office on my next trip to Edmonton.

Our story has a happy ending, my granddaughter just turned six and is enjoying fabulous health and growth. On Valentine's day and every time I hold her in my arms, I'm reminded of the importance of family, love and friendship. Thank You.

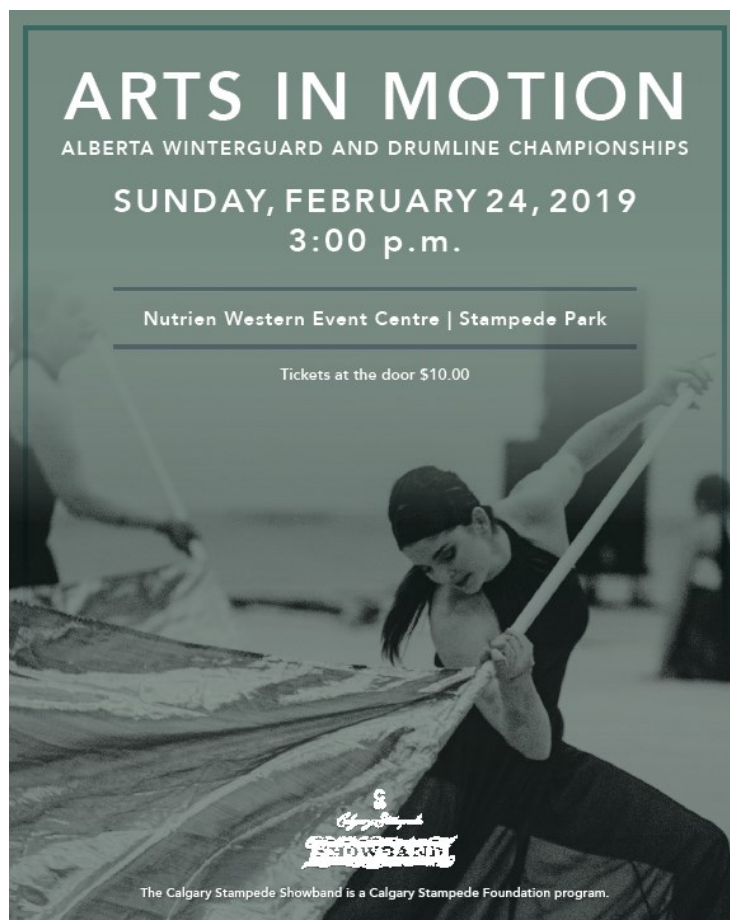
