Lotteries Update: Knowing we would be focused on the Calgary Stampede today, **President Elect Craig Stokke** was asked if there were any updates from the Stampede Lotteries Committee that he is allowed to share with us. I am happy provide an update on behalf of Stampede Lotteries. The big news of course is that there will be a Stampede Lotteries and a Rotary Dream Home in 2021.



At this point we do not know what on-park sales will look like. Of course with COVID, the Stampede will look to the direction of AHS and the government. But fortunately, under the direction of Dana

Peers and Steve McDonough, the Stampede has some very smart and committed people down at Headquarters and I have no doubt that they will do everything in their power to present the most amazing Stampede possible.

With that said, Stampede Lotteries is putting extra emphasis on online ticket sales this year - what we commonly call the Advance Ticket Campaign or the ATC. Dana Hunter and her team are actively preparing for a March 17th launch of the ATC - making it the earliest and longest campaign ever. This will maximize sales and ensure the public is aware that we are back and returning for 2021.

Until it becomes clearer what the on-park sales opportunities are going to be, Lotteries is planning three different on-park scenarios - three different Stampedes if you will. With that, I am very grateful that our Club is highly represented on the Lotteries committee - we have a ton of experience in this club - and I would like to take a moment to acknowledge some of our Club members who are working hard to make sure we succeed:

<u>Thank you</u> to Chad Hason, Dana Hunter, Jack Thompson, Keith Davis, Larry Kennedy, Larry Stein, Lynn Grant, and Neill Magee. And of course Jim Bladon and Kevin Macleod will be ready to fire up the Dream Home committee when the time is right. If I did forget anyone, I'm sure I'll hear about it, and yes, I'll buy you a beer.

The theme of this year's campaign revolves around the notions of Great, Greater, and Greatest, which Chad and his marketing team will use to help tell the message of the heritage and importance of the Stampede Lotteries to the Calgary community. The theme also fits well as for 2021 as we will be introducing refreshed prizes and ticket packages that are expected to boost revenue from the online portion of the lottery and protect revenues in the event the 2021 Stampede ends up restricting our ability to meet traditional in-person sales numbers.

We are excited and grateful for the Stampede's support - and I have no doubt we will have a very successful campaign this year regardless of which on-park scenario pans out.

One last thing, construction on the interior of the Dream Home will resume at end of March and we will provide further updates as they become available.





LEGACY PROJECT UPDATE:

Past President Sherry Austin began by saying: Today, we are going to learn there is so much more to the Calgary Stampede than 14 days in July. Welcome to our guests from the Calgary Stampede Foundation, who will be more formally introduced later. I want to say a particular hello to **Steve McDonough**, President and Chairman of the Board of the Calgary Stampede. Steve's father, Terry, was a longtime member of our Club, so we consider Steve part of our Rotary family and wish he would join us more often.

During 2017-2018 Rotary year, under the direction of then **President Bill Le Clair, Sherry Austin** and **Bob**

Brawn formed a partnership and began discussions with the Stampede Foundation to develop a Legacy Project for one million dollars over 5 years.

As discussions progressed and the two organizations learned more about one another, our focus became youth and education. In December, 2018, our Club pledged our one million contribution to two areas of focus with the Stampede Foundation. One area was related to the development of much needed shared space for youth-serving leaders and community partners whereby the old 'Oliver House' would be renovated for this purpose. The other area was related to the development of a new bursary program to provide access to education programs offered by the Stampede for financially challenged youth which has officially become the 'Rotary Accessibility Fund'.

Through substantial dialogue with the Stampede Foundation, Bob and I developed a deep respect and enduring friendship with the people who lead the development of the Education Campus and the education programs offered on behalf of the Stampede. With the cancellation of the Stampede and our Dream Home in 2020, the Stampede Foundation has graciously renegotiated and extended our Legacy Project Agreement.

Today, you will be receiving an update on how your donation has made an impact on youth in need

who are trying to access education programs at the Stampede. It is my pleasure to introduce the Executive Director of the Stampede Foundation - **Sarah Hayes**, the Manager of Philanthropy and Community Investment – **Sandra Lunder**, and the Manager of Bands – **Ryan Hancock**, who will share the experiences of youth who have accessed our 'Rotary Accessibility Fund'.

Sandra Lunder: First of all, we were thanked for the always warm welcome. The Club's enthusiasm and generosity, both in spirit and financial is always appreciated. Also, the **late Warren Connell** was acknowledged and his friendship with Rotary, and RCSSP, in particular, was recognized. He was always a supporter of the relationship between our two organizations.

Two things that we should look forward to -

- A great 2021 Stampede is being planned, so get ready.
- The 2024 Stampede which will see the new BMO expansion in place. This \$500 million, one million sf facility will put Calgary in the top tier of convention destinations, create 1,800 full time jobs during construction and when in operation, and add \$235 million to Alberta's annual GDP. It will host the 2025 Rotary International Convention









Ryan Hancock is a Stampede Show Band alumni and current manager of Bands. The Show Band is a six time World Champion, the most decorated band in history. He spoke to how the Rotary Accessibility Fund is providing opportunities to kids from all over Calgary to participate and continue in the Band programs. Twenty nine students have been helped to date, and the support is greatly appreciated by student and families.



Current band programs have had to adapt to the health requirements in


place, but training and practicing sessions have continued. Prior to November, in person sessions were allowed, with proper protocols in place, but in November these were halted and on line sessions had to be put in place. These have been surprisingly effective and well received. Teaching and rehearsing a marching band virtually has been a real learning experience. Small in person sessions have started again as restrictions are eased.

Educational programs concentrate on Stampede history and the culture of Alberta. They are based on Four Pillars (quite relatable to Rotary principles) –

- Western hospitality
- Pride of place
- Commitment to community
- Integrity

On line, virtual classes have been in place since the lockdowns commenced, and have provided an unexpected benefit. With virtual classes, it is possible to have up to 3 class rooms in attendance at a time, instead of just having one classroom in physical attendance. This has expanded their reach and will be utilized in the future.

The third aspect of the Stampede Foundation mandate is the development of the Stampede Youth Campus.







The Stampede Youth Campus has been under construction for some time. Located in the north east corner of the Park, the following features have been completed – TransAlta Performing Arts Studio, Calgary Arts Academy, Doherty Hall, and Enbridge Plaza. The Calgary Opera Community Arts Centre is being planned, and the SAM Centre is nearly fully funded and will be under construction this year. The latter will house the Stampede Museum and Archives. The architecture will reflect our western heritage and ambience.

Oliver House, which will house the Rotary Leadership Centre is currently being upgraded and renovated and should be open in late 2021. This is the building which is part of our Legacy Project.

Past President Bill LeClair thanked the speakers. It was great to see some familiar faces again. As President in 2017/18 he wanted to establish a Legacy Project that brought two great brands together, and he is very gratified that this partnership was brought to fruition in this great project. He is looking forward to when we can all meet face to face again.

From the podium, **President Penny.** I want to firstly express my gratitude to **Sherry Austin** and **Bob Brawn**, who is not attending today, for their vision and for all the effort they put into working with the Stampede



Foundation to create the concept we are supporting as our current Legacy Project. This work took place during **Bill LeClair's** year as President and under his guidance. I know there were others involved, but Sherry, Bob and Bill carried the torch for our Club.

As we have heard today, it is not only a project we can be proud of, but it is also a partnership we can be proud of.

Also, I want to express my gratitude to our guests from the Stampede Foundation. Thank you for everything you do to make our community better and for the update you have shared today. You have given us something to "toast" and say "cheers" to on National Drink Wine Day.

Thank you for recognizing Warren Connell, who was a great friend to RCSSP

In recognition of your presentation and your participation in our meeting today, our Rotary Club has donated \$100 to the Calgary Rotary Clubs Foundation. Investment income earned on these and other endowed funds will be reinvested in the future towards impactful projects such as the Oliver House project and the youth bursary.

I also want to take this opportunity to share how much we miss meeting on the Stampede Grounds. Your hospitality team treats us very well and makes us feel very special.

You will need to be in your seats early and bring your popcorn, or going again with today's theme, bring some wine to toast all three of these special people.

So as we close today's meeting, thinking about national battery day and national drink wine day, and thinking about these two are related, I did some research. There were a number of articles describing how to convert bad wine, or "plunk" into good wine, by using electricity to artificially age the wine. This is accomplished by passing the wine through two electrodes.

It kinda sounds like something some of my relatives might do on the farm out behind the granary, after they had already consumed a fair amount of plunk or wine. It sounds like something which in later years, we remember as a "shoulda worked" story.

Bylaws Update re Alberta Societies' Act

This report refers to Bylaw requirements from Service Alberta regarding our Rotary Club. It must be emphasized that this is not a new review of our Bylaws and no sections of the Bylaws have been opened. This is simply an update based upon Service Alberta Societies Act requirements.

For background information, a comprehensive review of our Bylaws was initiated in 2017/18 under the leadership of then President Bill LeClair and continued through 2018/19 under then President Ron Prokosch and concluded in 2019/20 during then President Chas' year. This work is an extension of that done during these past three years and thus, the Constitution, Bylaws, and Governance Committee from that time period was reconstituted and completed the work they conducted on behalf of our Club – **Sherry Austin, Larry Stein, Terry Allen and Bill Le-Clair**.

It is important to commend Larry, Bill and Terry for their excellent work in bringing this matter to a successful conclusion. They have expended much time and effort in this regard. Bill's legal searches and analytic skills, Larry's work as scribe and analyst, and Terry's knowledge of the past and his analytic skills were invaluable to sort through a decades long Registry trail.

On March 3, 2020, our Rotary Club ratified the Board approved Bylaws that had undergone revision during the three year period by over 95%. As per the Societies Act, these Bylaws were then forwarded to 'Corporate Registry, Service Alberta' to update our file and for official registration. Our Bylaws were first registered with the Society in 1994 and, to our knowledge, we have never received any feedback in the intervening years.

However, that all changed on December 2, 2020 whereby we received a letter from the Registry stating that to register our new set of Bylaws, we had to use the terminology and process contained in the Societies' Act. Rotary International wording was no longer sufficient. This has happened to other clubs as well.

Please refer to the email received at 2:00 pm today with all of the attached documents. Highlighted in yellow are the sections we must include in our Bylaws to satisfy Alberta Registry and the Societies' Act.

We must be registered to continue our fundraising activities. Thus, it is imperative that our membership vote on these revised Bylaws by means of a 'Special Resolution' as outlined by Secretary Larry having recently received Board approval. There are no Club decisions to be made; these changes are mandated.

Secretary Larry Stein will serve as Scrutineer.

Keeping in Touch

One thing we hear repeatedly when speaking with members of our Club is the fact that they miss chatting with their friends. Many are lonely and feel a need for the social interaction Rotary provides. Your Member Mentoring Committee has therefore decided to experiment with "The Party Line", an online ZOOM chat group that will get together twice a month for an hour to do nothing more than "chew the fat" on any topic(s) you may desire.

What is a Party Line?

Long ago in Canada, before the internet, cell phones, television, or even 'dial' telephones, telephone service was provided to many people via a "party line", particularly in rural areas. Many telephones shared a single telephone line, so only one conversation could take place at a time. Each home had a particular "ring pattern", wherein the telephone would ring in a specific pattern for your home. The Davis farm in Saskatchewan, for example, had a ring pattern of two long rings, one short, then one long. That was your cue to answer the telephone. In an emergency such as a prairie fire, a farm accident, etc. three long rings on the telephone was a signal for everyone to pick up their phone to get the news or an emergency call-out. It was surprisingly effective in the absence of other forms of instant communication.

Party Lines were not a secure form of communication. Other people who shared the phone line would often secretly listen to your conversation, so any confidential news was usually, quickly shared with the community. Those people were referred to as "Rubber Neckers" (who knows why?). But on the Rotary Party Line it's a free-for-all with full participation by all.

How Does the RCCSP Party Line Work?

Twice each month, at 7:00 PM, a one-hour party line will be open on ZOOM, hosted by the Member Mentoring Committee. Participants register in advance and then simply 'dial in' online to participate, just like attending a regular Rotary meeting. A topic may be suggested by the moderator, or it can simply be a free-wheeling 'gab fest'. It can be any topic(s) you wish, but please avoid party politics, religion or internal Rotary politics.


