President Chas began by saying that my talk today will not involve power points, charts or graphs. I thought I would simply speak to you in regard to the status of our club at mid year.

When I gave my inaugural address back in August, I made mention then of what I call the glue of the club. I certainly would like to touch on that while also updating you all as to where the board is on some issues that have been on our agenda.

As all of you know we have finalized changing the name of our Club but that doesn't stop there. The entire purpose of changing the name was for me the first step in the broader arena of marrying the value of our club to its current and ongoing status within the city's charitable organizations.

What I'm saying is the vision in adopting our new name was to recognize what we have become and in turn, take advantage of the tremendous impact of our cemented association with the Calgary stampede. In discussions with President elect Penny- as part of our strategic plan - we will seek to not only maximize the value of that partnership but strengthen our ties to it in various ways. We are that Club in this town.

We have made strong strides towards that important relationship through our current legacy project - the restoration of the Oliver House which will share a prominent place with our prominent name - especially when the new Calgary Flames arena is completed. The depth of opportunities we can consider - just with the Stampede - is huge - let alone what we could broker.

Now, I choose not to speak at great length about our dream home lottery total of this year. For a few reasons. Firstly; it is a number that is quite well-known and a number that - amazingly- we have become somewhat accustomed to! Over \$660,000 will go to various charities. Secondly and more importantly to me is that any kind of Dream Home Announcement should be reserved for all of those folks that were on the Dream Home Committee headed by Chair Jim Bladon. Especially in this case - as Jim outlined to you late last year that in spite of all the changes that were made to the format of selling that it was a record year. I fully expect that will continue in President-Elect Penny Leckie's year as well as President-Nominee Craig Stokke.

Through the efforts of the people in those committees and the efforts of everyone that I look out and see here today we will continue the success of an extraordinary fundraiser which is the envy of any Rotary club that I've ever mentioned it to. With that in mind also comes a huge responsibility and one that we should take very seriously. That is the fact that without the contributions of all of us no matter how small or how great - This incredible fundraiser will likely not continue. It is truly and quite literally our golden nest egg.

It must be watched, tended, nurtured in order for it to continue successfully. I can tell you that there is discussion among members of this club and - in fact - a growing number of members of this club that we become cognizant of what the future may hold for this fundraiser. By that I mean what does it look like in 5 years? 10 years? If we are not diligent in monitoring what may be shifting trends then we are sure to regret it. That said, there may be no change however - again - it is our golden egg and we must care for it faithfully. The bottom line is so far we've done a hell of a job! Let's keep it up!

You've heard me talk about this before but it bears repeating. The burden of completing the review of our financial reporting is complete. This new method of record keeping will usher in a new era of competency, clarity and capability for years to come. The work by the firm of Buchanan Barry has been nothing short of phenomenal. I have expressed my personal thanks to Marty Barry who led his group in bringing our reporting up to date. However, I reserve my highest praise for those that led our group in this very important endeavor. And I speak of our treasurer **Don Mintz** as well as our president elect **Penny Leckie**. Ladies and gentlemen without the sincere dedication of these two individuals in particular - there is no way on God's good earth that this would have been accomplished. I assure you this club owes a great deal to the efforts of those two individuals and I applaud them right now!

I am also pleased to announce that - most likely in my year - we will have completed another great task. That is the review of our clubs bylaws. Now for all of you that think this is a fairly rudimentary exercise, please listen up. Past President **Sherry Austin**, Past President **Terry Allen** and current Club Secretary **Larry Stein** among others have been at this for the better part of 3 years. I want to thank them for their commitment to seeing this through as it allows us to remain current with Rotary International as well as the subtle but necessary changes of our Club as we grow. This too was a complicated task that involved much deliberation and I thank my fellow board members for their important part in terms of bringing us up-to-date. I can tell you that over the next couple of months we will be able to formally ask that membership review the changes to the bylaws so that we may ratify them and finally have them Incorporated. I know Past President **Ron Prokosch** is as happy as anyone in this Club to see this completed. I'm pleased for him and all of us as it is important work that is vital to our Club. And there you have it. An update on some of the accomplishments in our club and a bit of a gauge on where we stand in completing them.

So let's talk glue shall we? As I mentioned in August if I had a goal this year as your President I wanted to improve the glue that holds us together as members of this club. We are making progress there. The obvious progress lies intertwined in the accomplishments that I've just outlined to you. We don't have a successful dream home - we cannot complete the work of financial reporting - and club bylaws unless we have glue. In those cases the glue is the dedication of the individuals that participate. In those cases the glue is the dedication to trying to better the club for those that will come after us. It is a sense of pride - a sense of commitment a sense of duty to a club that has provided so much for so many for so long. This is not hyperbole. It is simply fact.

I would be completely remiss and perhaps suffer something worse than that - if I didn't mention The Stay In School Golf Tournament. It was a long time ago being on **Bryan Targett's** committee and seeing his vision come to fruition. If I recall correctly we started with a modest donation from a brokerage firm that believed in the vision of the tournament. We were also incredibly fortunate to have had a most generous and involved sponsor in Ann McKenna Owner of supreme windows. She believed as much as anybody in this project and her unending and most generous support ensured the success of the tournament.

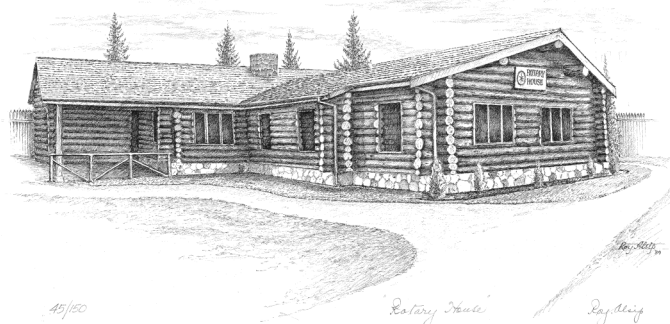
We will enter our 20th year this year with an amount in trust of just shy of \$4 million. The glue here is dedication of a number of people that have held this in its highest regard and pledged to be mentors to some very lucky students. Again participation in this Event as a sponsor volunteer player or a combination of all three has yielded extraordinary results. We are on the verge of self funding our commitment to the students in our program. Now, it is not for me to announce when that day will ultimately arrive because I'm not here to steal any thunder from those people that have worked so incredibly hard to produce such a successful endeavor. They have enriched the lives of many students and it is really remarkable when you consider what has been accomplished. Well done.

There are a couple of items that I want to briefly touch on that remain to be accomplished on my watch.

One that I will talk to you about now the other I can only hint at right at this time.

I can talk about our dear Log Cabin. The update here is that it is status quo. While that's positive its just not good enough.

For me there are only three outcomes to the fate of this cabin.

The option of number two is untenable. I promise you to work to my utmost to see that never happens.

That leaves us options number one or three. Number one is easy and self explanatory. I am working on number three.

I intend to have in our collective back pockets a plan of action that we can present to whatever governing body advises us that our cabin must be moved. It will outline in detail how this can be accomplished and save our most unique meeting place.

Second item that remains an accomplished is on a more personal level. I'm not trying to be coy it's just that discretion at this point requires that I not give out too many details. Suffice it to say that it is about the glue of this club and when I think about it now it might be the most meaningful example representing that glue within the Club. I hate to leave you hanging like that but that's all I can tell you right now. Except that it is imminent. So stay tuned!

In closing my fellow Rotarians, I want to encourage you to continue to work together as much as you possibly can. ***None of us is as smart as all of us.*** We achieve the most when we take advantage of the strength of this club. Ideas, passion dedication come from all of us. The potential of this club is unparalleled.

You know, the position of President of this club is unique in many ways. Perhaps though the most unique is the perspective one gains when they're in this position. The perspective I've gained is that I've seen what this club is capable of. I can honestly tell you that even when I was a board member I had no idea. There is massive dedication, incredible passion, true comradery, powerful vision on display to me on literally a daily basis. I would venture that any Past President would echo these very same thoughts.

So I want to leave you with one final request. I want you to turn your attention away from me. For just a moment I want all of you to look at those sitting with you around your table. Do it for me now.

Ladies and gentlemen these faces are those faces that care about you in this club. These are the people that make this club go and these will be the people that make and carry this club into the future.

The faces that you look at right now are the faces that will join you, enable you, support you to shape and enhance the best Club in town.

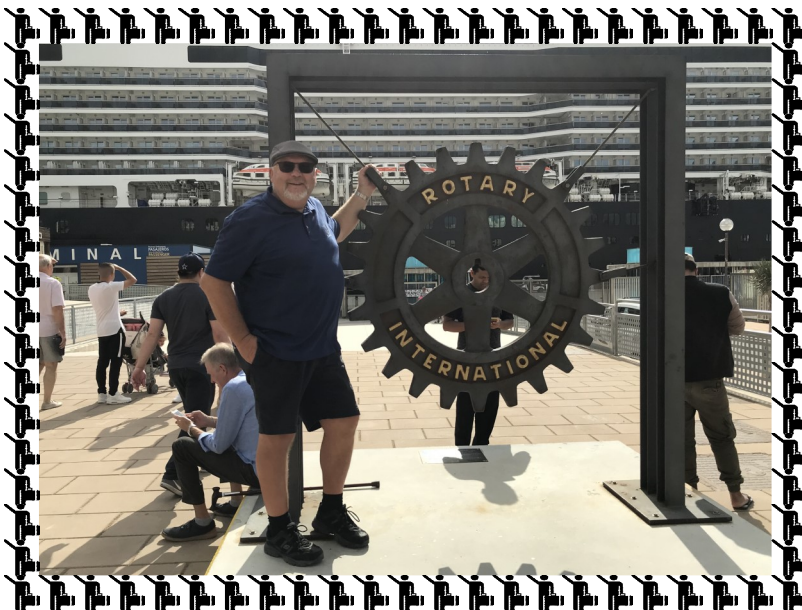

Campers set up their own businesses and use real money which they borrow from actual bankers. The last day is "Business Day" at the camp, where campers have the opportunity to open and operate their businesses. The youth also get to participate in many fun recreational activities throughout their week at camp.

RAYEC accepts 60 youth age 13-15 each year based on their applications. This camp is FREE to attend for the campers that are selected, thanks to the generous support of our partners and sponsors. 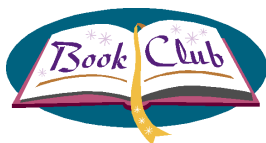

Lois ADAM February 11, 1930 - December 23, 2019

It is with much sadness that we announce the passing of Lois, beloved wife of George Adam of Calgary, AB, on Monday, December 23, 2019 at the age of 89. Our Mom lived a truly amazing and full life. Lois Thew was born in Bredenbury, Saskatchewan and for most of her childhood, grew up in a house with no central heating or indoor plumbing with her 9 older brothers and sisters. She moved to Alberta with her family and attended high school in Calgary while working in a chocolate shop. After public school she studied nursing at the Royal Alex Hospital in Edmonton and was employed as a Registered Nurse in Alberta after graduating in 1953. In June of 1955 she completed a five-week intense training class and was hired by Trans Canada Airlines to be one of the first "Air Stewardesses" in the country. She met our dad, George, and they were soon engaged. Due to rules at the time she had to leave her job as it was a requirement for flight attendants to be nurses, as well as unmarried. George and Lois were married on September 26, 1956. They started their family and built the house in 1958 that is still the family home. They recently celebrated their 63rd anniversary in September of this year, at that same address. George and Lois had 4 children, 3 grandchildren, very special neighbours, countless friends and colleagues. They travelled a great part of the world, both as part of George's career as a Civil Engineer with Con-Force and Genstar, and with family and friends. For over 50 years, summer travel by trailer was a tradition. After renting trailers for a few years and deciding to purchase one, an ambitious trip to the Montreal Expo was taken in 1967. Preceding and after that, there were many trips to Waterton Peace Park with the Rotarians, trips to British Columbia and within Alberta, and 38 years camping at Priest Lake, in Idaho. There were also years of enjoyable visits to the Fort Steele Campground, which created a lifetime friendship with the Young family. Mom was quite involved with the Rotary Anns of South Calgary and every summer she participated in selling tickets to the Rotary Dream Home at the Stampede. For years they were involved with the Queens and Jacks square dancing group and their annual campouts were a highlight. Born at the start of the Great Depression, Mom was way ahead of her time. She was tiny but mighty. She was 5 foot and ½ inch, and always added that ½ inch when asked. "Unable" was not in her lexicon. She was one of the first women in the area to own a car, was the electrician and plumber in the house, and attacked renovations and décor with vigor. Mom had a full time job taking care of busy kids, with piano lessons, swimming, dancing, skating, skiing, singing, choir and church, most of the traditional extra-curricular activities of the time. Her passion for life was vast. She was an extraordinary artist and seamstress, and saw magic all around her. In addition to her husband George, Lois leaves behind her four children Wayne (Joyce), Marina (Claude), Shelley (Simon) and Darren (Michelle) and 3 grandchildren, Lindsay (Matt), Krista, and Ryley. Special thanks to Dr. Brian Kim, staff at RockyView, South Calgary campus and Home Instead for their care of mom in the last 2 years. As per her wishes, there will be no formal service, and the family will hold a celebration of life at a later date.
