Bryan Targett opened with a special thanks to the Committee looking after this event; **Hugh Delaney along with Jim Smith, Paul Brick and Terry Allen**. He gave us some highlights of the Stay In School Program. The program is in its 16th year and has 52 students involved starting in Grade 6. Nine have graduated from Post-Secondary, four withdrawals and the rest are at various stages in the education.

Bryan emphasized that the success of the Stay In School Program has been due to the contributions of many Rotarians, the funds raised at the SIS Golf Tournament , in excess of \$125,000 annually and our sponsors. Let's give a big thank you to:

to work and learn". He comes from a family of 6 and is involved in a considerable list of activities and wants to be a paleontologist. Quinn has a visual challenge but never complains and has a positive attitude.

Nikita Wilson is the oldest of three children. She also is very active at school and her hobbies include photography, reading and painting. She is becoming an accomplished photographer and is interested in pursuing this further, possibly as a career.

Her school describes her as curious, motivated and engaged in the world around her.

Hugh Delaney then introduced two speakers who were to acknowledge our graduating students. **Keith Bekker** the mentor for Harman Sidhu told us that Harman could not be with us today as he had just undergone emergency surgery for an appendix. He had mentored Harman since 2006 and it was easy. Harman is very intelligent and had a spark that he still shows. He has now graduated from U of C and while it was unfortunate that he could not join us today we all wish him well in his future endeavours.






