***Welcome to the March 31st 2022 meeting of the Rotary Club of Calgary at Stampede Park. I am the Club's President, Craig Stokke***

Carbon capture is a fascinating topic, and a great opportunity for our province. However, there is a lot of misconceptions about greenhouse gasses. Not all greenhouse gasses are bad. As a matter of fact, without greenhouse gasses we likely wouldn't be able to live on Earth. Carbon dioxide traps the heat and energy it receives from the Sun close to Earth, so it doesn't all escape back into space. If it weren't for carbon dioxide, the Earth's oceans would be frozen solid. The problem is, the more carbon dioxide there is in the atmosphere, the more heat that gets trapped. And that is why scientists say the Earth's temperature is raising.

All living things on Earth contain carbon. Even people. Carbon makes up 20% of the weight of a human body, so if you weigh 150 pounds, approximately 30 pounds of you is pure carbon. Plants are almost half carbon. Diamonds are also made of carbon. Diamond formation occurs when carbon deposits deep within the earth (approximately 150 to 200 kms below the surface) are subject to high temperature and pressure for tens of thousands, or millions of years.

So, if people are made of carbon, and diamonds are made of carbon, it is no coincidence that an entrepreneur would find a way to turn human remains into diamonds. Teresa and I were watching TV one night. They were showing how a company takes cremated human remains and places them in special machines that are used to reproduce the exact conditions that exist deep beneath the earth's surface.

Under the supervision of scientists, the carbon from the cremated remains is exposed to temperatures of around 2500 degrees Fahrenheit, with pressure of about 850,000 pounds per square inch, for up to six months. In the end, you have a REAL diamond. At the end of the show I said to Teresa, you know, if you pass before me I would like to turn you into a diamond. She said "Really? That is so sweet. What would you do with me?" Her smile disappeared when I told her I would put her in a ring and give her to my new wife.

## EMERGING CARBON CAPTURE & UNDERGROUND STORAGE INDUSTRY IN ALBERTA AND CANADA

### SPEAKER INTRODUCTION: Bryan Walton:

Scott Rennie has over 20 years of engineering and leadership experience in carbon capture and storage (CCS) and oil and gas. He has built and led carbon sequestration organizations within Schlumberger (SLB) and ConocoPhillips (COP) and managed the development of 1+ MMT/yr CO<sub>2</sub> storage projects in Texas (Sweeny Refinery), Kentucky (COP/Peabody partnership), Alberta (TransAlta Pioneer), and Saskatchewan (Aquistore). At SLB, also held responsibility for leadership of the Schlumberger Carbon Services North America technical team.



Prior to co-founding Vault, he held the position of Senior Vice President of Development with responsibility for subsurface engineering, planning and budgeting at a private Canadian oil & gas company that grew from zero to over 30,000 boe/d of production and deployed over \$1 billion of capital during his tenure. In that role, also led development of a 400 MW combined cycle gas power plant project and served as President of the subsidiary developing the project. Significant commercial, capital markets, transactional, project management, and business development experience. Technically, core skill in reservoir engineering including experience with enhanced oil recovery (EOR) as well as significant experience in well design and reservoir characterization.

Scott has a Bachelor's and Master's degrees in Mechanical Engineering from Rice University and is a registered professional engineer in Alaska and Alberta. Scott is: married with 3 amazing kids, and enjoys a variety of non-motorized outdoor sports/activities when not parenting or CEO'ing.

### SPEAKER: SCOTT RENNIE

Mr. Rennie spoke to a very topical piece of the energy industry which is in the news a lot lately.

Canada is currently responsible for 1.5% of annual global GHG emissions, but on a per capita basis has the highest rate of any of the developed countries. Canada is cold, a large land mass with a relatively small population and has a lot of industry, which leads to the high rate. Over the last 20 years, Alberta GHG emissions have increased by 1% per year. The current stated Canadian target is to reduce total emissions by 45% by 2030 in order to meet a net zero by 2050 target. This will require a 5% per annum reduction in Alberta emissions over the next 10 years.

This can be viewed as a massive challenge or as an opportunity. Vault 44.01 views it as the latter. The company has experience with many large scale injection and storage projects, in the 1 MTPa range throughout Western Canada, and is involved in the planning for several proposed projects.

The CCUS chain is as follows:

- Capture from stationary production sources. Typically CO<sub>2</sub> is about 12% of the emissions stream and this must be captured and refined.
- Compressed to 1500 psi, the CO<sub>2</sub> is then transported by pipeline to injection wells.
- Injection can be into different locations
  - ♦ Oil/gas reservoirs to assist in enhanced oil recovery (EOR)
  - ♦ Depleted oil/gas reservoirs
  - ♦ Deep saline formations (3,000 meters) under sealing rock formations

The IEA calculates that the global net zero objective will only be possible if 9% of global emissions are absorbed by CCUS. This is equivalent to 2,800 MMTpa, or 55% of current global oil/gas production. Current CCUS costs can vary for \$50/T to \$250/T, depending upon location, and projects have capital costs in the billions. There is no revenue offset for these costs, except in EOR scenarios, so some incentives are required. In the US, there is a tax credit of \$50/T, but Canada currently has no incentive. The carbon tax is ineffective, but there is talk of a capital cost tax credit of up to 50%, which may or may not be forthcoming.



## EMERGING CARBON CAPTURE & UNDERGROUND STORAGE INDUSTRY IN ALBERTA AND CANADA

Alberta currently emits 130 MTpa from stationary sources, with 70 MTpa from the oil sands. The latter is the target source for CCUS projects. There a lot of companies announcing their intent to proceed, but nothing has really happened yet. Projects will only proceed if there is:

A strong regulatory system with

- ⇒ A process to lease required pore space in underground locations
- ⇒ Permission to inject and store
- ⇒ A process to pass long term liability back to the government

Alberta and Saskatchewan have some of the above in place, but eastern Canada does not. In fact, Ontario specifically prohibits underground storage. Alberta is currently proceeding with a competitive leasing program for pore space in saline deposits, which is a necessary precondition for CCUS.

- ◆ Fiscal policy clarity and sufficiency
- ◆ Regulatory clarity
- ◆ And, funding support for de-risking projects

CCUS projects are a great opportunity for Western Canada. We have expertise in implementing large scale energy projects and in subsurface geology. We know how to do it with projects already in operation – Weyburn/Midale EOR, Clive EOR, and Shell Quest and Aquistore deep saline formation injection.

We are developing a large-scale hydrogen industry and already have large agricultural and forestry industries, which are complementary to CCUS. There are a number of Canadian companies who already have the expertise it carry out these projects – Vault 44.01, Svante, Carbon Engineering, Entropy, to name a few.

If Canada does not provide the necessary incentive and regulatory policy conditions, there is a significant risk of all of this knowledge and expertise relocating to the US where conditions are more favorable.

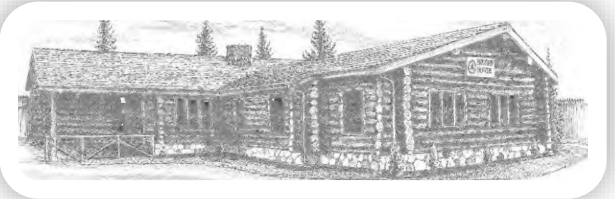
In answer to a question on the impact of CO<sub>2</sub> on the climate, Mr. Rennie provided some sobering numbers. In 1850, the concentration of GHG in the atmosphere was about 210 ppm. It is currently 410-450 ppm, and we are globally adding about 50 MMTpa of GHG to the atmosphere. So we need to keep 50 MMTpa from going into the atmosphere to just stay where we are, and even more to reduce the GHG concentration. An immense global task.

**CLASSIFICATION TALK: Pat Neuman gave her Classification Talk last week and it is listed here as it was not received in time to post last week.**

This is to be my Club Classification talk and since I am retired, I'll tell you just a bit about me..... I was born in Saskatoon, Sask and was raised on farms in Saskatchewan and Manitoba. My elementary school was in a rural one room schoolhouse..30 kids, grades one to eight. When I was in Gr 7 our family sold our farm and we moved for a short stint to Nanaimo, BC. It was a difficult year, in a Junior High school of 500, grades 7 to 9, being bullied and harassed by the city kids. My eyes were forever opened to the world!! I had one friend who was bullied and teased, due to her religious background. So, we stuck together!! The following summer we moved back to a more calming life in Northern Saskatchewan.. 2 years later in Grade 11, we moved to Regina where I completed Grade 12, and then graduated as a Registered Nurse from Grey Nuns Hospital. Two months later I married and we moved to Toronto where my husband had been relocated, 6 months prior. I worked at East General Hospital, then as a Physician's Assistant at Bloor Medical Clinic. 3 years later we transferred to Ottawa where I worked at Grace Hospital in Maternity, teaching new moms... and where in 1971 my son was born.

16 months later, we transferred back to Toronto, buying our first house in Scarborough for \$34,000!!! In 1973, my daughter was born at Mount Sinai and six months later, I back to work at Scarborough General in Emergency. In 1974 we transferred to Winnipeg, where I worked at Misericordia Hospital for 3 years. But, it was time for a change... I needed a new challenge.. My nursing career was done (the hours were crazy and I was tired of midnight shifts!) so I accepted a job as Event Coordinator for Welcome Wagon...a little part time job!!! I was quite successful and was soon asked to train others in Western Canada, as we moved once again, to Saskatoon, Sk. My marriage ended and when the opportunity came in 1984, the kids and I moved to Calgary as I was offered the job of WW Area Manager for Southern Alberta and the Kootenays of BC. It was a great experience and I loved my territory, where we rose to be the Top Area for Canada for many years. I was involved in several business organizations; served as President of the Calgary Ad and Sales Club, served as a Volunteer with the Olympics in 1988, and served as a Volunteer on the Promotions Committee for the Calgary Stampede for 15 Years. In 2000, I accepted a position in Toronto as Director of Marketing for Welcome Wagon and in 2002, on my move to Toronto, I was promoted to President. I rose to CEO, and Chairman of the Board, owning 90% of the company. My work included Marketing and Public Relations for the company, training and mentoring Management and Representatives across Canada plus hosting several wonderful Company conferences in Canada, the US and Europe. It was a Dream Job! In its 90<sup>th</sup> year in Canada, and with the pandemic in the early spring of 2020, it was impossible for the company to survive.. .. the company closed in 2020.... it just was not possible to continue with the personal visits which was our only advertising revenue. It was extremely sad to say goodbye to this company that had been my life for 43 years!! Fortunately, Rotary filled my days...a great tonic to overcome that disappointment.

It has been my pleasure to serve with many wonderful Rotarians through my 19 years in the Rotary Club of Toronto. I worked on and chaired several committees; Fellowship and Entertainment Committee, Youth and Children's Committee, and the Physically Challenged Children's Christmas party for many years. I also served on the Foundation Board, Honours and Awards Committee and Research and Appeals Committee. .. I also served on the District Youth Exchange Committee. It was my honour and privilege to serve as Club President 2017-18 ...it was a busy but amazing year as I also served as Co-Chair of Events & Entertainment on the Host Organizing Committee for the Rotary International Convention 2018, in Toronto. 2018-2021 I served as an Assistant District Governor in 7070. From 2018 to 2021 I was on the Club's Strategic Plan Committee - what an undertaking.. to see the transition come to fruition in 2021-22 has been rewarding. Being a Rotarian is rewarding by seeing the work we have done, and continue to do, our accomplishments and all the wonderful friendships made!!

For someone who has moved so much, there always is that "Start all over again" mode...the move here was so much better because of Rotary and getting to know all of you. Harold and I met in 2018.. he is originally from London and St. Thomas, On and was a member of St. Thomas Rotary Club for some years.. Our move back to Calgary was to be closer to my family; his entire family is in On. which means a few trips back to On. each year...

Thank you for welcoming me to your great club and getting me involved.... By the way, Harold and I love those Dream Home shifts!!We look forward to many more! Love Rotary Conventions and am looking forward to Houston 2022. Besides Rotary, I enjoy walking, yoga, entertaining, cooking, reading, gardening, dancing, golf, theatre, Stampeder games, hockey, church and just being with friends and family. Thank you!
