ROTARY REMEMBERS—PRESIDENT STOKKE

FACTS ABOUT CANADA'S INVOLVEMENT IN WORLD WAR II



- 1. Canada declared war on Germany on September 10, 1939, seven days after the United Kingdom did so, and more than two years before the United States entered the war (after Pearl Harbour).
- 2. 1.1 million Canadians served in the war, representing 10% of the total population at the time. This included virtually every able-bodied young man, 99% of them volunteers.
- 3. Around 42,000 Canadians died, and 55,000 were wounded during the war.
- 4. At the end of WWII—despite our relatively tiny population—Canada had the world's fourth-largest air force and the fifth largest navy. In addition, the Canadian Army was a crucial participant in D-Day (June 6, 1944), Operation Husky (July 10, 1943), and numerous other important campaigns throughout the war.

My Uncle **Edward Nalepa** served in the Canadian Military during WWII with the Regina Rifles. Heading overseas in 1942, Edward served in Holland and Germany, receiving a medal for his participation in the liberation of the Netherlands.

While in Germany, my Uncle was injured in the trenches by flying shrapnel. He returned home in 1946 aboard the Queen Mary, which is now permanently docked in Long Beach California.

Decades later, during a trip to California, my Aunt and Uncle visited the Queen Mary and my Uncle was able to find the location of his cot during his voyage. We are very proud of his service.

Our Club, the ROTARY CLUB OF CALGARY AT STAMPEDE PARK has a long and proud history of members who have served in the military. I am honoured to recognize those members, both deceased and living.

Thank you all for your service, and thank you for providing me the opportunity to honour these heroes.

that it was not going to be a long-term career! He knew that a huge tank was an easy target... Keith was single at this time, but he knew the military was not his long-term plan. Though it was real 'cool' to drive tanks, he learned more from his cohort than in any manual that could have been written. His cohort was at least 25 years older than him, and they had all served in WW2 – although they rarely talked about the trauma they experienced, it was evident. The military life really fits Keith's family. He has records of family fighting in wars in 1912, 1966, 1970, NW Rebellion, WW1, WW2 and Korea. He strongly believes in the value of wearing a poppy, it is important to teach children about the Services – and to keep the focus....

Keith was in the Military for 3 years. He completed his training in BC and Alberta (Wainwright, Chilliwack and Glenemma Range (Vernon)). He trained as a tank driver – and quickly learned Thank you, Keith – your service, and your family's service is honored.

Jim Smith

Jim is American and so his service was all based through the USA. He served 1 year in the National Guard, 4 years active duty in the Navy and 2 years in Stand-by Reserves. His active duty was in Vietnam and he spent a lot of time in the South Pacific. In the USA the 'draft' meant you served and in step your service set up the trajectory of your life.

Jim was trained as an Aviation Electrician and after his service he went to university and became and Electrical Engineer. He was in university as an older student who was working fulltime, so his experience was very different than the other younger students. He later then got a degree in Business. Jim was married after university and life then just happened! As he says 'you do what you have to, to get it done'.


