Rotary Employment Partnership: Karen Murray is employed with the Partnership which serves individuals with intellectual disabilities by providing advocacy in the areas of community recreation as well as employment opportu-

nities. She noted that October is Disability Employment Awareness month. She asked us to think about our first job and how we got that job. Usually it is through connections with family and friends. This partnership with Inclusion Alberta helps to develop those connections for their clients. The rate of unemployment for those with intellectual disabilities is 75-80%.

Their clients are isolated, especially now with the pandemic. They have very special partner-ships across Alberta to find that "hidden job market". Inclusion Alberta provides the onboard training and support as long as the job exists. There is a great economic advantage to hiring such an individual as the statistics show less turnover, higher safety standards and better

ELECTION GUIDELINES: Past President Penny Leckie:

According to the bylaws of the Rotary Club of Calgary at Stampede Park the Election Process for President-Elect Nominee and Directors is declared open this first day of **October 7**th, **2021**. The nomination process will remain open for additional candidates from the club membership through to 1:00 pm **on October 21**st, **2021** for a three (3) week period. Thereupon, acceptance of additional nominations will cease. Nominations from Rotary Club of Calgary at Stampede Park Members can be submitted for each of the following positions: **President-Elect Nominee**, **and 3 Director positions**. Nomination forms for all positions will be attached to this week's bulletin and are posted on our Club Website.

Members are requested to prepare a nomination form for each of the candidates, to be signed by the nominee showing their willingness to serve if elected and finally, signed by the first and second sponsors which are known as nominator and seconder. Again, these must be dated and submitted to the Club Secretary, Luanne Whitmarsh no later than 1:00 pm **on October 21**st, **2021**

In the event we have more nominations submitted than there are vacancies to fill, we will then have an election. Ballots will be electronically mailed to Members of the Club with a response requested within two (2) days to the attention of the Chair of the Nominating Committee.

All candidates involved in that process will have a short profile published in the bulletin prior to the election and members will be asked to return their voting ballot within two weeks of the mailing date.

President-Elect Nominee:

- * Has been a member in good standing for at least five years.
- * Has previously served on the board of directors for at least one year.
- * Has not previously held the office of President of our club.
- * Has been a member in good standing of our club having maintained 70% or higher attendance in the most recent applicable two years prior to this nomination.
- Has demonstrated a strong commitment to club activities such as committee work and fundraising activities and the completion of Dream Home shifts as expected by the club.

Director:

- * Has been an active member in good standing and has been so for a recommended period of at least 3 full years.
- * Has demonstrated a strong commitment to the objectives of Rotary throughout their tenure with the club.
- * Has maintained a 70% attendance in the previous applicable two years prior to this nomination.
- * Has demonstrated strong commitment to all club expectations for involvement in club activities such as committee work fundraising activities and completion of Dream Home shifts as required by the club.

The current Vacancies are as follows: President-Elect Nominee and three Directors. The President-Elect Nominee will serve in that capacity for a period of one year commencing July 1, 2022 until June 30, 2023. At that time; they will assume the role of President-Elect and serve for one year from July 1st 2023 to June 30, 2024. On July 1, 2024 until June 30, 2025 they will serve their term as President of our club.

Following our club's bylaws I convened a meeting of the Past Presidents of our club that took place on **October 5th**, **2021**. The Past Presidents made their selection for President-Elect Nominee in that meeting. On behalf of my fellow Past Presidents I am pleased to announce to all of you our nominee for President-Elect of the Rotary 2023 to 2024 is **Bryan Walton**

"Our current President-Elect **Jim Fitzowich** is currently courting potential Directors for the 3 Director vacancies available for the 2022-2023 Rotary year. He will announce his nominees shortly. Any nominees that Jim may announce are not intended to exclude any nominations from the general membership.

Now, the nominees that have been announced today are not intended to exclude any nominations from the general membership. Our club bylaws provide for an open election wherever there are more nominations than vacancies to fill. Each week until **October 21**st, **2021** I will announce the names of any additional nominees that are put forward from the general membership.







GUEST SPEAKER:

Speaker Introduction: Bryan Walton:

Dan Cloutier - President of Seer Management Investments (SMI) and Agro Resiliency Kit (ARK) Ltd, Dan has significant expertise in incubating high-growth technology-based companies. Seer has worked as a consulting company in energy efficiency since its inception. We have typically contracted our services under others brands as we do today with Onsite Power Partners / Crown Capital and Nexus Power Solutions over the last decade.





Dan is recognized as a leading cogeneration industry figure. For over two decades, Dan has coordinated the installation of more micro-CHP into commercial buildings than anyone else in Alberta. In Western Canada, Dan has sold and installed CHP systems for many customers.

In addition to cogeneration / combined heat and power projects Dan has been involved small-scale wind, solar and geothermal. Dan's first involvement with combined heat and power solutions was as a volunteer Board member of Cardel Place where Dan spearheaded pursuing the first Gold Leed designation in Alberta. Dan is a third generation native Albertan with a myriad of volunteer experience going back to the early 80's with Clean Calgary, the Calgary Field Naturalists, to the American Marketing Association who presented him a Special Merit Award, to 2009 when Dan was named the Calgary Northstars Hockey Associations Volunteer of the Year.

Dan asked us to think about what we need to do differently. The answer is in one sense "Back to the future". It is an evolution from the "bigger is better" mantra we have had for many years. In the past the energy and Agri communities in Alberta was made up of fiercely independent settlers, farmers and ranchers as well as wild cat drillers and junior oil and gas companies.

Currently 11 companies supply most of what is available in the grocery store. In the past it was home gardens and farmer's markets that supplied our needs.

The current supply chain issues create lots of complexity and is energy intensive. Consider how to shorten the food chain

The reason for a "Back to the Future" consideration: inflation is now at 7-8% and meat constitutes half of food at home price increases. There is a lot happening now in the agricultural and energy world-a transformation.

GUEST SPEAKER:

Dan is excited to be in a strategic alliance with an old company-Sprung. Sprung has been ahead of their time by owning and operating a greenhouse, marrying their unique membrane with technology. Dan's company provide the technology and equipment inside the Sprung greenhouses. The Sprung membrane is 3 lb. per square foot which makes it economical to create a rooftop greenhouse. There is one in downtown Calgary above the TD Bank.

We had our start in the greenhouse industry that began in the early 1980's. After several years in research and development our first major project was a joint venture between Sprung and the Government of Newfoundland with the construction of a 300,000 ft hydroponic facility that made Newfoundland self sufficient in vegetables grown year round.


Dan noted numerous opportunities in agriculture to create the best efficiencies. There is a demonstration greenhouse on the Sprung campus. They are able to grow lettuce and kale year round with surplus being sold to small health food stores. He noted that 25% of the cost of lettuce is transportation costs.

It is an old concept, now new again: how to make a small parcel of land profitable? Through vertical growing. For example, a farm field of 1/10th of an acre can yield 4500 plants. Compared to vertical gardening, that same 1/10th of an acre in a greenhouse can yield 25-50,000 plants. This is much more profitable. Dan also noted a 3,000 year-old technology to raise rainbow trout in trenches where you can grow a lot of fish and use the fish water for the plants.

Dan provided a number of examples of these types of changes to create more efficiency by using smaller spaces to produce a large crop that is fresh and available all year round.

He also noted ways to make energy more efficient and sustainable, through biofuel, algae greenhouses for new replenishment fuels and providing the example of the head office of the Manitoba Hydro Building at Portage and Main, heated by geothermal means in a very cold climate. The final slide in the presentation "Permaculture Design for our Future" sums up the key points of the presentation

It is with sadness that we announce the passing of John Fowlis of Calgary, AB, on Monday, October 4, 2021 after a brief illness, with family by his side.

CLEVEN AWARD:

This special internal award of the Rotary Club of Calgary at Stampede Park was established in 2006 to recognize the outstanding contribution of club members who take on significant responsibilities and commitments in furthering the work of our club.

The award is named the "Cleven Award" in honour of and recognition of Harry Cleven first president of the Manchester Rotary Club 1955 now known as The Rotary Club of Calgary at Stampede Park. Cleven was a very active Calgary community leader and a well-known and respected businessman. He was one of 62 people who were killed in the crash of a TransCanada Airline flight which crashed on Mt. Slesse near Chilliwack on December 9^{tth,} 1956. He made many positive contributions to the start-up and laid a strong foundation for our club.

Members are nominated by club members with a review by a committee, followed by our club Board of Directors support. Club Cleven Award nominations may be submitted by any member of the Club.

CRITERIA

- The award recognizes a strong commitment to and involvement in all club activities.
- The nominee should be an active participant in club committees, who accepts major responsibilities in the committee. They should demonstrate a strong work ethic and timely completion of commitments.
- Members of Rotary Club of Calgary at Stampede Park with membership of at least 5 years qualify for this award.
- Nominees for this award must have an attendance over the last three years of at least 75%.
- This award does not have any repeat recipients.

NOMINATION PROCESS

- Submission of a Nomination can be made by members of the Club accompanied by a supporting letter and/or by members of the Recognition and Award Committee.
- Deadlines for nominations will be published in the Bulletin.
- The Recognition and Awards Committee will receive the nominations and make recommendations to the Board for those club members who will receive this award.
- The Board is responsible for approving the recommendation of the committee.
- The Award will be presented at a time to be determined by the Board.

GUIDELINES FOR THE RECOGNITION AND AWARDS COMMITTEE

- There will be 1 to 3 recipients per year.
- Presidents and District Governors are not eligible until 5 years after serving their term.
- Members of the Recognition and Awards Committee are eligible to be nominated.
- The profile of club committees varies with the type of work, it is therefore important that the Recognition and Awards Committee ensure that all nominations which are received for this award are given equal consideration.
- The Committee will meet within two weeks of the nomination deadline to review the nominees and choose appropriate recipients which will be approved by the Board.


