Heinrich Heinz introduced Gary Lamb: Garry was born and raised in Calgary. He obtained a B.Sc in Civil Engineering from the University of Calgary in 1975 and completed his Masters of Engineering Degree in 1983. He has spent his career working in the Calgary area, primarily in the field of project management. Garry joined Alberta Transportation in May 2005 as the Urban Construction Manager for Calgary.

He is currently the Project Sponsor for all new Provincial Highway work within the City of Calgary which includes the Calgary Ring Road and Deerfoot Trail. His projects have included expansions of Calgary's Water Treatment Plants, pump stations, reservoirs, the Calgary Convention Centre, Westside Recreation Centre, the expansion of Mount Royal University and now the design and construction of the Calgary Ring Road Project.

Garry said that before MLA Clarence Copithorne, transportation planning was ongoing at municipal and province levels. He showed a 1959 map – of what the network highways and freeways would look like in Calgary.

In 1970 the city started looking at a road crossing thru Tsuu Tina land and in 1974 when it was starting to be studied, our population was 433,400. Garry shared drawings produced in 2005 that showed the plan almost identical to what is being built today. He has hosted over 1,000 people at open houses to share the plan saying that what he hears most is: "I didn't know this was happening in my neighborhood. Garry, tongue in cheek, said that yes, this is pretty top-secret stuff that the city hides on the internet.

Because of the length of the project spanning years, it is hard to keep people engaged and this is one of their biggest challenges. An example is Bridlewood – that community did not exist when plans were made, and it is therefore incumbent on the real estate industry to share future plans with home buyers.

Garry shared some pretty cool and crazy looking intersections – only to say none of them were the shapes Calgary could expect. Our ring road will be 101 km in total with a to-date cost of \$1.9B on construction. 71 km of the 101 km have been completed.

The final 31 km segment will include: 66 bridges, 20 interchanges, a railway flyover, an underpass, 4 river bridge crossings.

Where are we at now? Drawings were presented to the public in November 2016. A contract with Mountain View partnership was signed for \$1.4M. Macleod Trail will be free flow traffic as will Stony Trail. It will tie into highway 22x out of Calgary. Six square miles of land will now be developed in that area now that the final plan is in place.

The Nation is also building a road on its land that they will develop as commercial to support their own economic growth, recognizing they will gain access to the public using the new ring road.

There will be a new pedestrian bridge over Ander-

son to service the major pathway that runs from Fish Creek to Glenmore Trail. By building it now, it negates the need for a temporary pathway during ring road construction.

Southland Drive and 90 Avenue will be connected to the ring road as requested by the city. Will provide redundancy in those areas which is expected to improve access for those neighborhoods.

Sarcee Trail, Glenmore Trail and the ring road will be the most complex area because of major utility installations that exist there – AltaLink and Enmax need to be relocated. ATCO has a high pressure gas line. City has water and sewer lines. So construction involves moving a lot of infrastructure. The plan also includes relocating the Elbow river – they obviously want the river to stay in the same place as bridges are built over it. The river needs to be moved away from escarpment and realigned to the middle of the river valley.

Highway 8 will be twinned in future, but is not part of this project.

The timeline going forward is very strict. Land was received from the Nation in 2015 and has a clock of 7 years to build it and open it. If the ring road is not done by 2021, the Nation keeps the money and the city loses the land.

The RPF was issued in 2015. A contract was signed middle of 2016, and the road must be opened to traffic no later than October 21, 2021. There is confidence with all parties that this date will be met, and may actually be early.

Proposed Bylaw Changes

The following three amendments which, have been approved by the Board, will be voted on at the next meeting on January 19, 2017:

1. Article 3 Section 2 Election of Officers & Directors

Current Bylaw passed April 4, 2012

Directors

Club members nominated for this position must meet the following criteria.

- (a) Has been a member of our Rotary Club for at least three (3) years.
- (b) May not have served on the Board in the previous three (3) years in any position.
- (c) Must have demonstrated a strong commitment to the objects of Rotary throughout their tenure in the Club.
- (d) Is a member in good standing in the Rotary Club of Calgary South having maintained 70% attendance in the previous two(2) years prior to his/her nomination.
- (e) Has demonstrated a strong commitment to all Club expectations for involvement in Club activities such as committee work and fund raising activities and in particular, completion of Dream Home shifts as expected by the Club.

Proposed

Directors

(a) Is a member of the Club. It is highly recommended that the nominees have a minimum of 3 years in our Club.

2. Article 11 Section 2 Finances

Current Bylaw passed April 4, 2012

Section 2 - Bills shall be paid by cheques bearing two signatures, which shall be those of the president, treasurer and/or the assistant treasurer; or any one of them together with either the secretary or any director. The treasurer or assistant treasurer will submit a list of paid bills for approval by the Board of Directors at the next Board meeting subsequent to payment. A review by a qualified accountant shall be made once each year of all the club's financial transactions; financial statements prepared, and made available to any member on request.

Proposed Bylaw

Section 2 - Bills shall be paid by cheques bearing two signatures, which shall be those of the current President, President Elect, Past President, Club Secretary, Treasurer and, Assistant Treasurer. The Treasurer or Assistant Treasurer will submit a list of paid bills for approval by the Board of Directors at the next Board meeting subsequent to payment. A review by a qualified accountant shall be made once each year of all the club's financial transactions; financial statements prepared, and made available to any member on request.

3. Article 12 Section 6 Honourary Members

Current Bylaw passed April 4, 2012

Section 6 – Honourary Membership – <u>(This category is provided for under the Constitution of Rotary</u> International)

(a)Eligibility for Honourary Membership- Persons who have distinguished themselves by meritorious service In the furtherance of Rotary ideals and those persons considered to be friends of Rotary for their permanent support of Rotary's causes may be elected to honourary membership in this club. The term of the membership shall be determined by the Board. Persons may hold Honourary Membership in more than one club.

(b)Board Action – The names of candidates who are proposed as an Honourary member shall be submitted to the Board of Directors in writing and the election shall be in the same form and manner as prescribed for the election of an active member provided, however that such proposal may be considered at any regular or special meeting of the Board and that the Board may at its discretion waive any of the steps as set forth in Section 1 of this Article, and proceed to ballot on the proposed member. The proposed Honourary member will be considered elected unless there are more than two (2) negative votes cast by the members in attendance at the meeting.

(c)Rights and Privileges – Honourary Members shall be exempt from the payment of admission fees and dues, shall have no vote and shall not be eligible to hold any office in this club. Such members shall not hold classifications, but shall be entitled to attend all meetings and enjoy all the privileges of the club. No Honourary member of this club is entitled to any rights and privileges in any other club, except for the right to visit any other club without being the guest of a Rotarian

Section 7 – Board Recognition for Long Term Members

The President and Directors of the Rotary Club of Calgary South, may at their discretion, confer special membership status on members of the Club who are unable to maintain regular attendance due to health or family reasons. Such recognition will be initiated by the Board and the recognition of such status will be determined by the Board on an individual basis.

Proposed

Section 6 – Honourary Membership

(a)Eligibility for Honourary Membership – Friends of Rotary who have distinguished themselves by meritorious service in the furtherance of Rotary ideals and their permanent support of Rotary's causes may be elected to honourary membership in this club. Persons may hold Honourary Membership in more than one club.

(b)Board Action – The names of candidates who are proposed as an Honourary member shall be submitted to the Board of Directors in writing and the election shall be in the same form and manner as prescribed for the election of an active member. The proposed Honourary member will be considered elected unless there are more than two (2) negative votes cast by members in attendance at the meeting.

(c)Term of Award – All Honourary memberships shall be for a one year term with correspondence to clearly state such. Honourary members may be re-affirmed on an annual basis but Boards are not required to continue ratification.

(d) Rights and Privileges – Honourary Members shall be exempt from the payment of admission and dues, shall have no vote and shall not be eligible to hold any office in this club. Such members shall not hold classifications, but shall be entitled to attend all meetings and enjoy all the privileges of the club. No Honourary members of this club is entitled to any rights and privileges in any other club, except for the right to visit any other club without being the guest of a Rotarian.

Eliminate Section 7 – Board Recognition for long term members.
