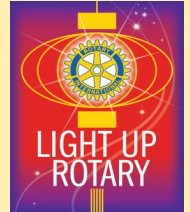

DR. DAVID CHALACK:  
CHAIRMAN of ALMA (ALBERTA LIVESTOCK AND MEAT AGENCY)



Bryan Walton introduced our guest speaker : Dr. David Chalack. Dr. Chalack, a veterinarian, has a very lengthy list of career accomplishments, awards and board appointments. Among those are: Past President of the Calgary Stampede, Dean's Advisory Council to the Schools of Veterinary Medicine, Canadian Food Inspection Agency, Alberta Economic Development and the Canadian Agriculture Hall of Fame. He is here today in his capacity as Chair of Alberta Livestock and Meat Agency (ALMA).

Dr. Chalack thanked the club for the invitation to speak and recognized several members including Roger Jarvis, former President of the Calgary Stampede and Ken Copithorne, longtime Alberta rancher.

He began his presentation with the question: "Why do we pay so much for beef?"

Since the BSE crisis of 2003, herds in Alberta have been on a continual decline. All beef exports stopped almost immediately. Many ranchers had to sell land and other capital assets just to survive. That was further compounded as rising grain prices made it more economically viable to cultivate grasslands for grain. Currently supply is down and with the growing demand for protein from emerging nations, demand is up. Dr. Chalack made the point that "if you eat, you are involved in agriculture".

The livestock sector in Alberta is the largest in the country and 3/4 of all beef processed in Canada is processed in Alberta.

ALMA is involved in research, investment and innovation including a 185 million dollar commitment to genetic research and development.

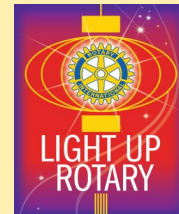

One Health is a program that looks at the interconnections of health among people, animals and the environment.

In response to a question from Al King, Dr. Chalack stated that agriculture was Alberta's largest renewable resource and second only to oil and gas in GDP and employment.

There was a question put forth at the meeting today on cattle sent to the USA for processing. Bryan sent out the answer by email later today:

Fed cattle (market weight steers and heifers) # head:

- Processed in Canada: 2.2 – 2.3 million
- Shipped for processing in USA: 350,000 (approximately 15%)

Cows and Bulls # head:

- Processed in Canada: 700,000
- Shipped for processing in the USA: 250,000 (approximately 35%)

Len Hamm thanked our speaker for providing some clarity into the livestock industry.

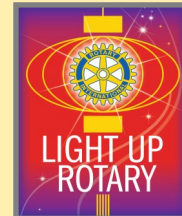

**President Al** closed the meeting with the 4 way test.

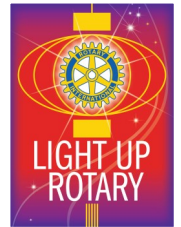

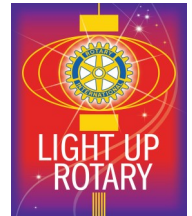


At noon, at City Hall a special ceremony will be conducted to speak to the Polio epidemic and its eradication.

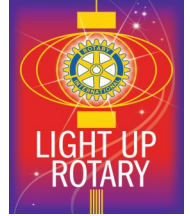

## **OCTOBER CALGARY ROTARY CLUBS FOUNDATION (CRCF) Month For Calgary South**

### **What is the Calgary Rotary Clubs Foundation?**

It is a place where all Calgary Rotary Clubs can invest their charitable funds and is overseen by a Board representing all participating clubs. Each year funds are distributed according to a pre-agreed formula to these clubs. We have about \$2.6 million invested at this time and about 5% is returned to our Club on an annual basis.

### **Why should I donate?**

There are no administrative fees for this Foundation. Every dollar you donate goes directly into the Foundation. All funds that you commit will remain in our local community to help those in need. Through your generosity you will help feed those who are hungry, help house those who are homeless, help those living with disabilities, help those who are sick, and help those who just need your support to re-build their lives so they, too, may contribute to their community.

### **How are donations recognized?**

Donor recognition begins at \$1000 and you receive a Calgary South Benefactor pin, a personalized certificate, and your name is included on the Donor Recognition Board. Each successive donation of \$1000 includes crystals on the benefaction pin.

### **What are our Club targets?**

Our goal is to raise \$4 million for this Foundation.

We would like to encourage all members to work toward becoming a Calgary South Benefactor. All donations are gratefully received and records will be kept for you.

### **How do I make a donation?**

Donations can be made by credit card, cheque, or cash. Donations may be made by corporations, families and other supporters of the work we do in our own community.

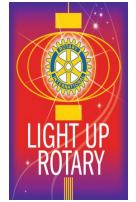

## Rotary Club of Calgary South Cleven Awards Program

This special Calgary South Club internal awards program was established in 2006 to recognize the outstanding contribution of club members who take on significant responsibilities and commitments in furthering the work of our club.

The award is named the "Cleven Award" in honour of and recognition of the first president of the Rotary Club of Calgary South chartered as the Manchester Rotary Club in 1955. Harry Cleven was a very active Calgary community leader and a well-known and respected business man. He was one of 62 people who were killed in the crash of a TransCanada Airlines flight which crashed on Mt. Slesse near Chilliwack on December 9<sup>th</sup> 1956. He made many positive contributions to the startup and a strong foundation for our Rotary Club.

We already have sixteen members in this special program and expect to induct another two or three this year. New members are nominated by club members with a review by a committee, followed by our club Board of Directors support.

We need your input for future Club Cleven Award nominees and following you will find the important criteria.

### CRITERIA

- The award recognizes a strong commitment to and involvement in all club activities.
- The nominee should be an active participant in club committees, who accepts major responsibilities in the committee. They should demonstrate a strong work ethic and timely completion of commitments.
- Members of Rotary Club of Calgary South with membership of at least 5 years qualify for this award.
- Nominees for this award must have an attendance over the last three years of at least 75%.
- This award does not have any repeat winners.

### NOMINATION PROCESS

- Nominations can be made by members of the Club through a nomination letter and/or by members of the Recognition and Award Committee.
- Deadlines for nominations will be published in the Bulletin.
- The Recognition and Awards Committee will receive the nominations and make recommendations to the Board for those Club Members who will receive this award.
- The Board is responsible for approving the recommendation of the committee.
- The Award will be presented at a time to be determined by the Board.

### GUIDELINES FOR THE RECOGNITION AND AWARDS COMMITTEE

- Normally, there will be 1 to 2 recipients per year.
- Presidents and District Governors are not eligible until 5 years after serving term.
- Members of the Recognition and Awards Committee are not eligible.
- The profile of club committees varies with the type of work, it is therefore important that the Recognition and Awards Committee ensure that all nominations which are received for this award are given equal consideration.
- The Committee will meet within two weeks of the nomination deadline to review the nominees and choose appropriate recipients which will be approved by the Board.

## Rotary Club of Calgary South: 2014 Election Process

On Oct. 9 nomination period will open for all positions to be elected this year. These positions are:

- Directors for the 2015 – 2017 Term. Four in total.
- President-Elect Nominee. This person will become the President-elect on Jul. 1, 2015 and will be President for the 2016-2017 Rotary year.
- Secretary for 2015-2017 Year.

The timeline for the election process is as follows:

1. Oct. 2: Chair of Nominating Committee will announce to club that nominations will open on Oct. 9 and will outline nomination process. The Chair (or designate) will repeat this notification at each of the meetings of Oct. 9, 16 and 23. Notification will also be published in the club Bulletin in those dates.
2. Oct. 9: Nominations will open for all positions to be elected.  
The Oct. 9 *Bulletin* will publish nomination forms. As well, an email will be sent to all Members in Good Standing containing names of members eligible for election to the position of Director, and position of President-Elect Nominee.
3. Printed copies of nomination forms will be available from the Secretary, Ted Rowsell, at each of the meetings of Oct. 9, Oct. 16 and Oct. 23
4. All completed Nomination Forms must be in the hands of Secretary Ted Rowsell no later than 12:00 Noon on Thursday, Oct. 30. Nominations MUST be received in the standard format of the Nomination Form, stating:
  - Position being sought by the Nominee
  - Name of Nominee, including signed declaration by Nominee of their willingness to stand for election and to serve if elected
  - Nominating signatures of 2 Members in Good Standing of club eligible to vote.
5. *Nominations will close at 12:00 Noon on Thursday, Oct. 30. If sufficient, or fewer number of candidates are nominated by the deadline for nominations, then the slate of candidates will be declared elected by acclamation, and Nominating Committee will be directed to appoint sufficient Directors to meet requirements (in this case, four Directors in total are required).*
6. If more candidates are nominated than positions to be filled, an election will ensue in order to collect secret ballots from all Members in Good Standing. Process will be as follows:
  - On Thurs. Nov. 6, a brief profile of each eligible candidate will be published in the *Bulletin*. It is the responsibility of each candidate to prepare an abbreviated profile in standard format, and to submit that profile to Past-President Keith Davis (Chairman, 2014 Nomination Committee). This must be done before the Nov. 6 regular meeting of Club, in order that they can be published in the Nov. 6 *Bulletin*.
  - On Monday, Nov. 10 ballots, showing names of all nominees for all positions, will be sent to all Members in Good Standing of the club. Ballots will include name of candidates, positions they are seeking election to, name of person who nominated them, and name of person who seconded that nomination.
  - All ballots must be received by the Secretary of the club not later than 12:00 Noon on Thursday, Nov. 20 in order to be counted.
  - Nominating Committee, as set out by Club bylaws, will be a committee made up of the Past Presidents of our club.  
This committee will meet on Oct. 14, 2014 to identify a candidate for the position of President-Elect Nominee and, upon the consent of that candidate, his/ her name will be made known to members of Club by the Chairman of the Nominations Committee. His/her name will also be included on the ballot as a nominee for that position. However, all Members in Good Standing of the club will also be encouraged to submit nominations for the position of President-Elect Nominee, in addition to the name put forward by the Past Presidents.

Any questions regarding this election process should be directed to me, Keith Davis, as Chair of the Nominating Committee.

The Directors be elected this year will take office on July 1, 2015 and serve until June 30, 2017.

Nominees for this position must have the following criteria:

1. Has been a member of our Rotary Club for at least three (3) years.
2. May not have served on the Board in the previous three (3) years in any position.
3. Must have demonstrated a strong commitment to the objects of Rotary throughout their tenure in the Club.
4. Is a member in good standing in the Rotary Club of Calgary South having maintained 70% attendance in the previous two(2) years prior to his/her nomination.
5. Has demonstrated a strong commitment to all Club expectations for involvement in Club activities such as committee work and fund raising activities and in particular, completion of Dream Home shifts as expected by the Club.

Please note the following conditions for nomination.

- All Nominations must be signed by a nominator and seconder who are in good standing as members of the Rotary Club of Calgary South, as well as the candidate who is being nominated for the position.
- All nominations must be in the hands of the Club Secretary, Ted Rowsell, no later than 12:00 Noon on Thursday, October 30, 2014. These may be mailed to Ted at the Rotary Office at L103C, 9705 Horton Road SW, Calgary AB T2V 2X5 or handed to him at any club meeting.
