Bulletin Chair: Bev Ostermann Editor: Corinne Wilkinson Photographer: Clive Pringle Luke DaSilva introduced our guest speaker, Shirley Purves. Shirley is the CEO of Aspen Family Services which is a valuable community asset that builds strategic community partnerships. Shirley guides leadership in collaboration process to ensure Aspen continues to make positive social impact. With more than 40 years experience in the service field, Shirley managed programs in a variety of services. She joined in 1997 when the organization was going thru significant upheaval. Today it is well-organized, non-profit and highly reputable, with 130 staff, budget of over \$12M. They are aligned to Calgary's 10-year plan to end homelessness. Active volunteer in community, background in nursing.

Shirley opened with how impressed she was with how much we care and how much we contribute without ever seeing people at the other end of our contributions.

Aspen is a community driven social service agency: meaning they have been helping Calgarians since 1984. 130 compassionate staff, partners with funders, government sponsors, donors, Rotarians, communities.

They offer over 20 programs across Calgary. Staff ensure appropriate service ensuring no gaps. Work with youth, families and community development. Use Sustainable Livelihoods Frameworks. Staff know it's important to develop assets for every area in their lives.

They have developed innovative partnerships with organizations such as Horizon Housing, Distress Centre, community, and corporations such as Enmax and Enbridge. They are currently doing a study around energy poverty. Those living in poverty pay 70 - 80% of their income to cover the utilities of the home they live in, leaving 20% of disposable income to feed and clothe their families.

### SHIRLEY PURVES: ASPEN FAMILY HOMES

1 in 10 Calgarians live in poverty and some with children. 1 in 5 Calgarians are concerned with having enough money for food. 35,000 Calgary families face difficulty affording adequate housing. Every Calgarian deserves to enjoy a vibrant inclusive community.

Impact of Aspen: more than 22,000 interactions per year connecting with community. 3,050 individual families have received clinical services. They have a presence in 236 Calgary communities and 90% success rate in vulnerable Calgarians achieving more sustainable lives. Largest case management program comes out of homelessness. Aspen is able to move a family on average in 239 days from homelessness to a home.

Aspen's Goals: From vulnerability to stability. From poverty to economic and social resilience. People to neighbourhood and community engagement.

Ultimate change: Sustainable futures and well-being. Continually there to help them keep moving even though there may be small set backs.

### **CLASSIFICATION TALK: AMY GIANG**

Classification Talk: Amy Giang: Amy thanked President Murray for introducing her to Rotary Calgary South. Amy expressed that is an honour to be amongst Calgary's most brilliant, generous and kind people. Her opening joke had Bill Gates hanging out with the Chair of General Motors. Bill expressed that if the car industry was run by the IT industry, the Chair of GM would have been driving at V32 instead of a V8, would be half the size and weight of today's cars, would be much more efficient and use no gas, and would cost about \$50. To which the Chair of GM replied "yes, if I wanted to drive a vehicle that crashes 4 times a day, that would have been fine."

After owning a mechanic shop for five years, in 2008 Amy founded the Lube Town Express chain. She expressed that most thought she had five children – 2 kids of her own and 3 stores. She was 8 months pregnant when she opened her first store in Okotoks. While some thought that was crazy, she believes passion loves hard work.



She didn't want it to be come a franchise so she combined her IT and military backgrounds, and created a store with first-class customer service.

Lube Town gives back to the community with its 5 + 5 event. Customers get \$5 off their oil change, plus Lube Town gives \$5 to a community initiative such as the one to support soccer clothing.

In 2012, the business was nominated by Okotoks Chamber for Business of the Year, and also won a service excellence award. This year they were the recipients of another award. No appointments are needed. Their house oil is the best oil – President Murray's Canadian made Boss Oil. Services are warranty approved and every change includes a 21-point inspection. Average time for an oil change is 12 minutes. Their key to speed is efficiency because they are prepared and have 2 – 4 people working on car at one time.

Accuracy is also important with each vehicle triple checked. Every store has over \$100,000 in inventory covering every oil, filter, make and model.

They offer fleet management services – saving businesses thousands of dollars by customizing to your needs. For Rotary members, Amy is offering special rates for fleets.

Amy joined Calgary South Rotary for two reasons:

#### RCCS: ELECTION PROCEDURES



On October 8<sup>th</sup>, 2015 the nomination period will open for all positions to be elected this year. These positions are:

- Three (3) Directors for the 2016/2018 Term
- President-Elect Nominee, will become President-Elect on July 1, 2016 and will be President for 2017/2018 Term
- Treasurer for the 2016/2018 Term

The timeline for the election process is as follows:

- 1. October 1<sup>st</sup>, 2015: The Chair of the Nominating Committee will announce to the club that nominations will open on October 8<sup>th</sup>, and will outline the nomination process. The Chair (or his designate) will repeat this notification at each of the meetings up to and including October 22<sup>nd</sup>. That notification will also be published in the club Bulletin newsletter in those dates.
- 2. October 8<sup>th</sup>, 2015: Nominations will open for all positions to be elected.
  - The October 8<sup>th</sup> *Bulletin* newsletter will publish nomination forms. Kathyann will send an email to all Members in good standing containing names of all members eligible for election to position of Director, and a second list of Members in good standing who are eligible for election to position of President-Elect Nominee
  - Printed copies of nomination forms in standard format will be available from Ted Rowsell, Club Secretary at each of the meetings up to and including October 22<sup>nd</sup>
- 3. All completed Nomination Forms must be in the hands of Ted Rowsell, Club Secretary no later than **12:00 Noon on October 29<sup>th</sup> 2015.** Nominations MUST be received in standard format, stating:
  - Position being sought by Nominee
  - Name of Nominee, including a signed declaration by Nominee of willingness to serve if elected
  - Nominating signatures of two Members in Good Standing of the club who are eligible to vote.
- 4. Nominations will close at 12:00 Noon on October 29<sup>th</sup>, 2015. If a sufficient, or fewer, number of candidates are nominated by the deadline for nominations, then the slate of candidates will be declared elected by acclamation, and Nominating Committee will be directed to appoint sufficient Directors to meet requirements.
- 5. If more candidates are nominated than positions to be filled, an election will ensue in order to collect secret ballots from all Members in good standing. The process will be as follows:
  - On November 5<sup>th</sup>, 2015 a brief profile of each eligible candidate will be published in the club *Bulletin*. It is the responsibility of each candidate to prepare an abbreviated profile in standard format, and to submit that profile to Past President Al Johnson 2015 Chair: Nomination Committee. This must be done before the November 5<sup>th</sup> regular meeting of the Club, in order that they can be published in the November 5<sup>th</sup> *Bulletin*.
  - On November 9<sup>th</sup>, 2015 ballots, showing names of all nominees, will be sent to all Members in good standing of the club. Ballots will include name of the candidate, position they are seeking, name of person who nominated them, and name of the person who seconded that nomination.
  - All ballots must be received by Ted Rowsell, Club Secretary no later than 12:00 Noon on November 19<sup>th</sup>, 2015 in order to be counted.
  - Nominating Committee, as set out by Club bylaws, will be a committee made up of Past Presidents of our club.
    - This committee will meet on **October 6<sup>th</sup>**, **2015** to identify a candidate for the position of President-Elect Nominee and, upon the consent of that candidate, his/her name will be made known to members of the Club by myself, 2015 Chair: Nominations Committee. His/her name will also be included on ballot as a nominee for that position. All Members in good standing of the club will be encouraged to submit nominations for the position of President-Elect Nominee, in addition to the name put forward by the Past Presidents.

#### RCCS: ELECTION PROCEDURES



#### **President-Elect Nominee**

- Must be a member of our club for at least five (5) years
- Must have served on the Board of Directors for at least one (1) year
- Must not have previously held the office of President of our club
- Is a member is good standing of our club, having maintained 70% attendance in the two years prior to nomination
- Has demonstrated a strong commitment to all club expectations for involvement in club activities, such as committee work and fund-raising activities and, in particular, completion of Dream Home shifts as expected by the club

#### Director

- Must have been a member in good standing of our club for at least three (3) years
- Must not have served in any position on the Board of Directors for the preceding three-year (3 years) period
- Must have demonstrated a strong commitment to the objects of Rotary throughout their tenure in the club.
- Is a member in good standing of the club, having maintained a 70% attendance in the previous two (2) years prior to nomination
- Has demonstrated a strong commitment to all club expectations for involvement in club activities, such as committee work and fund-raising activities and, in particular, completion of Dream Home shifts as expected by the club

#### **Treasurer**

- Must have been a member of our Club for at least three (3) years
- Has demonstrated a strong commitment to the Rotary Club of Calgary South to the objects of Rotary throughout their tenure in the club
