ISA & HUMBERTO DANTES AND BABY LOUISE:





ANNUAL GENERAL MEETING

Report submitted by President Brent Jorowski

On December 2nd, we successfully held our 2020 Annual General Meeting. I would like to thank everyone who participated. We approved the 2019/20 Financial Statements as well as the nominees for President and Vice President for 2021/22. **Congratulations to President-Elect Nancy Cosway and incoming Vice President Jeannette Brigit**, who I know will both do a great job for the club next year. In addition to taking care of this important business, we also had a chance to reflect on what has happened in the first half of this Rotary year.

This has been a very different type of year. We've had to in some cases try to find different ways, but we have continued to accomplish important things towards our objectives in making this a better club and making the world a better place. Facing challenges and continuing to persevere makes us a stronger and more resilient club.

I revisited the strategic themes discussed at the beginning of the year about sustaining and advancing this club to support the club's large variety of service activities. The first was about **administrative sustainability**, particularly when it comes to our accounting and finances, which must be kept up to a high standard, particularly for our registered charity. Co-Treasurer Jennifer Ash provided an update on some changes being made to our financial system to modernize it, make it more robust and to provide some support for our Treasurers to make the role more reasonable for volunteers to take on. We also talked about the Board looking at whether to give up our office at the RBC CC when our lease is up at the end of June 2021, and the work that the **recently established Office Committee** is doing under the leadership of Frank Cosway to inventory what we currently have in the office, what we need to keep that will require storage, what we can give away or otherwise dispose of. This is an opportunity to save about \$400/month, which is money that could probably be spent on better things, so I think we need to seriously consider it.

The second theme for strategic actions this year was to **recruit members and supporters.** The strength of our club is our active members, and member recruitment and retention are always important goals. We targeted to recruit at least 8 to 10 new members this year, and with six new members since the beginning of the year, I think we are progressing well on that front in spite of operating in this virtual world. Eva Vida provided an update on membership activities, including the recent new members information session. We also wanted to put some more focus on our public relations and internal communications to help support member attraction and retention, particularly in the face of the COVID related restrictions. Nancy Cosway provided an update on the efforts to improve our communications as well as our online presence.



Another strategic theme is **member engagement**. The question of how we keep all our members engaged in our club is always an important focus, but it's even more important given our current situation, where we can't meet face-to-face and some of the public events that had brought us together are not happening. At the beginning of the year, we talked about having regular club meetings on the 1st and 3rd Wednesday each month, and that's what we've been doing virtually. I didn't think that we'd still be having virtual meetings at this point, but here we are. And I expect the virtual meetings will continue into the new year, although there does seem to be some light at the end of the tunnel now. We also talked about augmenting these regular meetings with social meetings to promote fellowship. We had one such event at Assiniboine Park this Fall, masks and all, and on December 11th, we held our virtual Wine & Bingo event, which was a lot of fun. I'm hopeful that we'll have a few more of these types of events in the new year as well.

The Directors of Community Service (Jeannette Brigit), Youth Service (Pat Vallance), and International Service (Strini Reddy) also provided updates associated with their respective portfolios, the latter of which included some significant and recently approved Global Grants. Subsequent discussion at the meeting also covered the efforts of our Honouring Indigenous Peoples and Peace Builder Committees. The Club has a lot to be proud of and enthusiastic about in the first half of the year. I'm looking forward to continued successes and ask for your continued support.





BEST KEPT SECRET: THE PERMANENT ENDOWMENT FUND - ROTARY CLUB OF WINNIPEG SUBMITTED BY GLEN TORGERSON, CHAIR, PEF



The best kept secret of the rotary club of Winnipeg happens to be the largest source of funds for the club's projects and activities; yet little is known about it by our members.

Mighty oaks from little acorns grow; and so it is with the PEF, (our shorthand for the permanent endowment fund). we owe a debt of gratitude to Rotarian tommy sill, who, back in 1967, started the fund with a \$5,000 contribution. the initial contributors were tommy, Charlie Curtis, norm Coghlan, Burt Robinson, Jon Spalton, and Bill Anderson.

A side bit of information. there was surprise in many quarters in 1986 at the size of tom sill's estate. My memory says close to 30 million, which was used to create the sill foundation, still active today. one of its aims is to help Manitoba communities and organizations to start endowment funds. he obviously was a proponent of this type of institution to provide ongoing financial support, perhaps due to his experience from creating the PEF!

This type of fund for an individual rotary club was outlawed by rotary international when it created the rotary foundation. luckily, we were grandfathered and allowed to continue. thank you again tom sill!

The PEF is a perpetual fund. encroachment of capital is prohibited. Our goal is to transfer to the club at least 95% of income earned in the rotary year. Lately that has been between \$42,000 and \$45,000 and assets are currently \$1,234,913, as of September 30th, 2020. There is also a small fund with under \$30,000 at ig wealth management.

The PEF is administered by a board of trustees, consisting of chair, treasurer, and 5 trustees. The club president and club treasurer are ex official members of the board. The PEF board of trustees are elected at our annual meeting and then must be approved by the rotary club's community service fund Inc.'s board of directors.

Those members of the rotary club who have contributed at least \$500 to the PEF are deemed to be contributors, and eligible to attend, hold office and vote on PEF issues. The board of trustees is elected from this group as is the investment committee.

The PEF board has recognized that a new member may have difficulty in donating \$500 at one time so that a Rotarian can join the contributors by making payments over time instead of all at once.



This investment committee is comprised of a chairman, the PEF treasurer and 4 trustees, plus Rotarian frank wade of RBC wealth management, to oversee the portfolio. Their actions are governed by a set of bylaws and an investment policy document.

The fund investments themselves are held through RBC wealth management and wade wealth management group, with Rotarian frank wade assisting the PEF investment committee. There is a 60% equity maximum, and 40 % guaranteed maximum, in our investments which are targeted at income. Currently we are focussing on high paying dividend investments since gic returns are so low. Despite the unusual investment landscape, we continue to see portfolio returns in excess of \$45,000.

The bulk of the donations to the fund have come from estates of Rotarians that have seen the value of having a steady and reliable source of funding for club projects. Individual Rotarians have made steady donations throughout our history which has also helped us to grow steadily. Since the earnings of the fund are largely paid out there is little growth from that. Occasionally a capital gain can be realized if trades are made within the portfolio. However, we invest seeking steady income, so such trades are not an objective, although welcomed when they occur.

Finally, I would like to mention a smaller, but quite important, avenue for contributing to the PEF. we have a memorial fund; which is a part of the PEF. donations can be made to recognize Rotarians, or anyone, who has passed, with a donation. the donation goes to the PEF and a card is sent to the family from the club verifying this. personally, I started using this to honour fellow Rotarians, but now I use it to honour anyone that i wish to honour. Simply send the donation and the address of the family of the deceased you are honouring. You will get a tax receipt, and you build future income for the club. A win,win,win situation.

The current board of trustees for the PEF is myself as chairman, David Ross as treasurer, Ernie Shewchuk, Elly Hoogterp, Ian Seymour, Jane Markesteyn, and Ron Reider.

The current members of the PEF investment committee are; Glen Torgerson, David Ross, Ernie Shewchuk, Jane Markesteyn, Ron Reider and of course, Frank Wade.

I hope that this has given you a better picture of what the PEF is and how it fits into the operation of our rotary club of Winnipeg. I hope that you can see the value the PEF supplies to our rotary club. We need more Rotarians to become involved in the PEF and its operations. We need new and younger Rotarians to become the trustees of tomorrow.



POLIO PLUS – END POLIO NOW UPDATE:

Bill Gates: On November 19th, at 7:54 pm., Anderson Cooper was interviewing Bill Gates on CNN about the COVID Vaccines and Polio Eradication. Gates mentioned Rotary International as a part of the team that has had great success with polio vaccinations. He especially mentioned the fact that Africa was recently declared to be polio free.

Brenda Banbury's **Walk for Polio and the District 5550 Polio Plus Challenge** was successful in raising \$26,016.22 from 28 participating Clubs.

The Polio Vaccine is successful but poor sanitation can be a problem:

On a sadder note, cases in endemic countries have increased to 56 in Afghanistan and 81 in Pakistan. There are some cases of cVDPV (circulating vaccine derived polio virus) as well. You may wonder what these are So, after oral polio drops are administered, the virus in the vaccine replicates in the intestinal tract, thereby developing immunity by building up antibodies but some of the virus is excreted into the environment, hangs around, often for quite a long time and undergoes genetic changes into a form that paralyzes. This occurs primarily in areas of inadequate sanitation and where routine immunization is suboptimal so children are susceptible to the virus; the problem is low vaccination coverage, NOT the vaccine!
