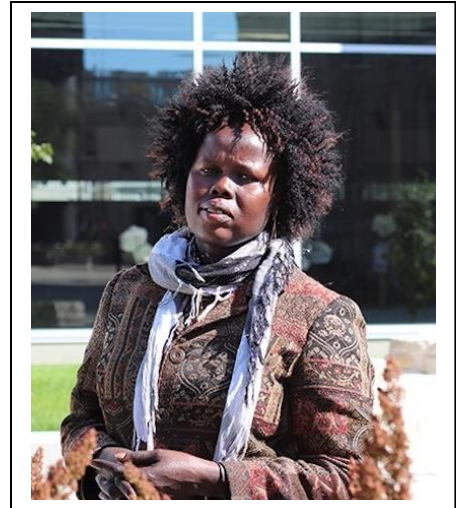

CELEBRATIONS, AWARDS & APPOINTMENTS:

Induction of New Member – Rebecca Atet Deng:

Rebecca Atet Deng was born in Sudan and is a former *lost girl of Sudan* who went to Ethiopia in the late 1980s with thousands of other war affected children. She was separated from her parents at a young age in Sudan due to the civil war. In 1991, Rebecca and other South Sudanese refugees fled Ethiopia when that country had its own civil war. She arrived in Kenya in 1992 and stayed in Kakuma refugee camp until 2005 when she finally came to Canada under the government's refugee resettlement program.



Rebecca is a single parent with two children; Monica and Daniel. To be a role model to her children, Rebecca enrolled in English as a second language, completed her high school at the Winnipeg Adult Education Center and is currently a third-year student at the University of Winnipeg where she is taking Human Rights and Conflict Resolution studies while working part time as a security guard.

Rebecca's goal is to work with children and women from war affected areas, indigenous peoples and the wider Canadian society in creating awareness on human rights issues both locally and globally. To that end, Rebecca has been a member of various community and student organizations working on human rights issues both at the University of Winnipeg and in the wider Winnipeg community.

Rebecca's life story and journey is an example of becoming a global citizen. Since leaving Sudan in 1988 as a refugee, Rebecca has been to many countries, lived with people from different cultures and received assistance from various international organizations. Her life has been shaped by different people from all over the world and she can say she is a global citizen. As such, becoming a member of Rotary International is a natural part of her mission to be part of such a great organization that promotes peace around the world and understanding of global citizenship.

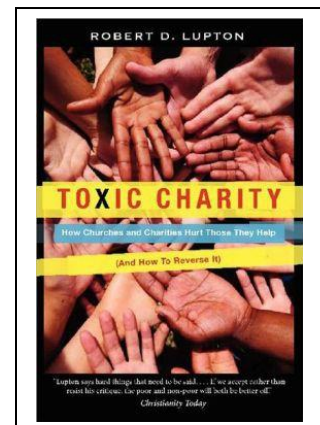


ROTARY ALUMNI AND CONNECTIONS:

GRATEFUL TO BE CANADIAN

Like so many of us, I end up compulsively watching the news shows from the States, much more than is healthy. It saddens us to realize how much chaos is taking place just to our south, and we wish there were some simple solution to their problems. Even so, this past Sunday, while I was watching Fareed Zakaria's show on CNN, I came away feeling very grateful to be Canadian. One of Mr. Zakaria's guests was a former Canadian diplomat, Scott Gilmore, who authored an essay in McLean's magazine entitled, "The American Dream has moved to Canada." I was amazed at the facts he pointed out. As you know, we Canadians, as a nation, appreciate humility and shun those who brag excessively. There are times, however, when we need to reassure ourselves that everything is O.K. This is one such time.

I was surprised to learn that the average Canadian lives 2.5 years longer than an American, 81.2 years compared to 78.2, and that 46% of Americans have college degrees compared to 59% for Canadians. Canada has world class universities, yet access to education is easier and doesn't create the student loan problems that occur in the United States. We don't have people going bankrupt because of health care costs,

so poor parts of our society can continue to thrive. In fact, according to the World Economic Forum, we are the 6th happiest people in the world, while the Americans lag behind in the 13th spot. One particularly troubling statistic was the fact that the average American is six times more likely to be incarcerated, in prison or in jail, than your average Canadian or European. Canada also ranked higher in press freedom as well as economic freedom.

As Canadians, we are so conscious of not bragging that we forget to let our youth know what a great country this is and how much we have to be proud of. After all, our young people are also aware of the disharmony among our neighbors to the south and they deserve to be re-assured that things are pretty good here.

The MC asked a different question of each panellist, who was then given 10 to 15 minutes to respond. The questions covered history, economics, relationships, challenges and barriers. Much of what was discussed was familiar, but new to many in the audience.

One point that was made strongly was that just tweaking current policies does not work; what we need is problem-solvers. Other interesting points that were brought out were: Indigenous people are every bit as entrepreneurial as the rest of the population. Some politicians buy into proposed solutions, but nothing happens; so civil servants need more information about the indigenous community. Shaun talked about his interesting article that appeared in the Winnipeg Free Press the previous day on the benefits of social enterprise, leading to reduced incarceration rates. Apparently 96 cents of every dollar earmarked for the indigenous community ends up being spent outside that community. We were told that 75 percent of jobs require a driver's licence, which is a problem for many indigenous people. Companies should all have policies regarding indigenous people, as MNP does.

Following the five presentations, questions were taken from the floor. It was a very interesting evening, ending with refreshments and networking.

“Flex Program” at Murdoch MacKay Collegiate receives grant for \$1,000.

This educational program caters to the needs of students having difficulty attending school on a regular basis as a result of personal, family or social issues. Students move through the curriculum at their own pace with the teachers assistance.

This program has been funded by the Rotary Club of Winnipeg since 2005. This grant enables the purchase of breakfast items for the students, such as bagels and cream cheese, bus tickets for students and fees for graduation registration and gown rental.

This year 80 students are enrolled in the program with two teachers, Dana and Sean. These two teachers have been with the program since the beginning.

This grant was initiated by Ernie Schell in 2005 and he has a deep interest in its success. He and Dana's parents had cottages close to each other and that is how he learned about the program.
