First Nations Treaties

Peter Zakreski introduced Tom Molloy, whom he has known since their high school days in Saskatoon. Mr. Molloy is a well known and well respected lawyer and member of the Order of Canada. He has served as the Chancellor of the University of Saskatchewan and has written a book entitled "*The World as we know it.*"

Mr. Molloy spoke of the "duty to consult" by the Crown and First Nations. In 1982 the Canadian Constitution was amended and the existing treaty rights of the First Nations were recognized and affirmed. This provided protection of the rights given to First Nations who had signed treaties with the Crown, and also protection to those First Nations who had not signed treaties. Mr. Molloy noted that the rights are not absolute. For example, in the case of hunting, fishing and trapping rights, on Crown land, the government must carry out the consultation in good

faith in order to address the concerns of the First Nation.

Mr. Molloy's presentation was well received and generated many thoughtful questions and comments from the members in attendance.
