

PROGRAM

District Governor Nominee Peter Neufeldt was called on to introduce our guest speaker Carolyn Ferguson, Senior Major Gifts Coordinator with The Rotary Foundation for Zone 24. From his introduction, we learned that Carolyn lives in Ancaster Ontario with her husband of nearly 25 years, and their two daughters and a loving dog. She is TRF's first ever employee in Canada and is a part of a team of Gift Coordinators around the world. Carolyn comes from a Rotary family as her father was the Centennial District Governor in District 6290. Her role with TRF is one talking to Rotarians



and others about leaving a legacy, a role Carolyn pursues with a passion based on her knowledge of TRF.



Carolyn brought greetings from her Rotary Club in Ancaster who meet on Thursday morning and from the Staff of The Rotary Foundation. She noted that Rotary has been “doing good in the world” for nearly 100 years, for it was in 1917 that the 6th President of Rotary, Arch C. Klumph, shared his vision that Rotary set up an endowment for this specific purpose. Other highlight events include:



- 1957 Paul Harris Fellow was created;
- 1965 established Group Study Exchange, Awards for Technical Training, and Matching Grants;
- 1978 Health, Hunger and Humanity (3H) Grants established;
- 1985 PolioPlus was implemented;
- 1999 Bequest Society was formed;
- 2004?? Arch Klumph Society
- 2013 New district, global, and packaged grant program established.

We learned that any gift to TRF does three things: i) enables TRF to give out grants; ii) eradicate polio; and, iii) it supports Peace centred programs. Carolyn spoke about the matched gifts which come as a result of a gift to

TRF, e.g. Bill and Melinda Gates Foundation match 2 to 1 gifts to PolioPlus, with a second 2 to 1 match by the Canadian Government.

Carolyn spoke about the significant developments in Polio eradication with the July 2015 announcement that the last case of polio diagnosed in Nigeria was on July 14, 2014 – this makes Africa polio free (although Nigeria will have to go a further 2 years before being certified as polio free). This leaves 2 endemic countries – Afghanistan and Pakistan, with significant head way and commitment to eradication expressed by Pakistan's President.



Rotary's six Areas of Focus have established key areas for attention by Rotarians and significant funds have been directed toward projects in the first 3.5 months of this Rotary year, e.g. \$21 million to Global Grants (in addition to millions for District grants).



Carolyn drew the work of TRF to that of riding on a bus; i) someone has to drive the bus to get to a “work site”; ii) some are workers who ride the bus to the work site; and iii) some provide fuel so the bus can get to the site. Each Rotarian fits into that chain and all are required, for without any one component, this business of “doing good in the world” is not achieved.

In her closing remarks, Carolyn commended District 5550 for taking the courageous stand of hosting a *Million Dollar Dinner*. An event that will occur during the District Conference in Gimli in May 2016. She noted that PDG Doug Mortin and DGN Peter Neufeldt were part of a team in District 5550 providing leadership for this undertaking.

President Ron called on Leo Ell, Co-Chair of the Club's Rotary Foundation Committee to make two Major Donor Presentations. Leo invited Hans and Merle Gaastra and Peter Neufeldt to join him at the podium along with Carolyn Ferguson representing The Rotary Foundation.

Leo expressed his pleasure, on behalf of The Rotary Foundation, to present Merle and Hans Gaastra with Major Donor Level 3 recognition, thanking them for their continuing commitment to the work of Rotary. Leo asked Carolyn to present the Crystal to the Gaastra's along with the Major Donor Level 3 pin for each of them.



Turning his attention to Peter Neufeldt, Leo thanked him on behalf of The Rotary Foundation, for taking this step in his commitment to the work of Foundation and invited Carolyn to present Peter with the Crystal and the Major Donor Level 1 Pin.

This was a great Rotary Foundation day. Members of Regina Eastview are proud of accomplishments and commitments of Hans, Merle and Peter and the leadership they demonstrate. We are honoured to be in your company.


