#### November 21, 2018:

The Sergeant at Arms for the evening was Bev Knutson. Rick Caron, a Rotarian (and past-District Governor) from Windsor 1918 Rotary Club, attended our meeting.

Irene Sottile proposed a toast to the Queen and Canada.

President-Elect Steven Margarit introduced the evening's speaker, Clifford Mushquash. Clifford is President-Elect of the Lakehead Rotary Club. Clifford has had a long association with figure skating, starting in his hometown of Sioux Lookout, where he began skating as a young child. While an injury curtailed his competitive figure skating activities, the knowledge gained through competition and involvement in the sport allowed him to transition into the role of judging skaters in competitions.



To qualify to become a judge requires that one has a skating background and retains Amateur status. The process of training and certification is rigorous, requiring, among other criteria, continuing development and practice.

Clifford explained that changes in the judging procedure, sparked by fraudulent scoring at the Salt Lake City Olympics, now make it virtually impossible for corrupt judges to improperly influence the results of a competition. This was done by creating a system involving

multiple individuals each responsible for part of a score in a competition. Technical Specialists rank the technical difficulty of each element of the individual skater's overall program prior to the program commencing. During the performance, a panel of judges assigns positive or negative points in their assessment of each element of the skater's program, reflecting their considered judgment as to where along the spectrum of "failed, almost met, met, exceeded or greatly surpassed" the judge's expected standard. The judge must quickly assess a variety of criteria (i.e.: smoothness, commitment to the skate edge carving the ice, starting and ending spins precisely, maintaining velocity, the intensity of acceleration, et/etc.) in a matter of seconds, quickly noting both the point score and brief justifications for their rating. The ratings of each of the technical elements is compiled with those of the other judges, the high and low scores are eliminated and the remaining scores are entered into an algorithm that modifies the difficulty ranking given to the element by the technical specialist. The sum of these adjusted difficulty rankings forms the total score for the skater. (Please note that this is the humble scribe's interpretation of the system, refer to Clifford or Skate Ontario for a more detailed explanation).

Or more simply "the Technical Specialist calls what the skater has done, the Judge assesses the quality of execution".

To illustrate the process, Clifford showed a brief video of a skater's performance while he calledout his assessment of the individual elements of the performance. This was an excellent demonstration of the speed at which the decisions must be made but also illustrated the skill with which an experienced judge could make valid assessments.

President-elect Stephen thanked Clifford for the presentation educating us about this interesting topic.

Fines: Dave Murray was fine master, soliciting contributions based on attendance at the Rotary Santa Claus Parade.

A moment of silence was held for personal reflection on Ted's contribution to the quality of all of our lives as fellow club-members.

The Rotary Santa Claus Parade was successful again this year with many children and parents lining the route. The Rotary Clubs of Thunder Bay are grateful for Goldcorp's generous sponsorship of this event and the City's decision to contribute to reduction of the policing costs. A wrap-up meeting was planned for November 22, 2018. Sante Sottile is receptive to any constructive suggestions for improvement to the event.

The Board of Directors approved a contribution of US\$3,000 as part of a Chid and Maternal International Grant in conjunction with a Minnesota Rotary Club. This contribution from a Canadian Club allows the US Club to leverage additional funding from the District.


