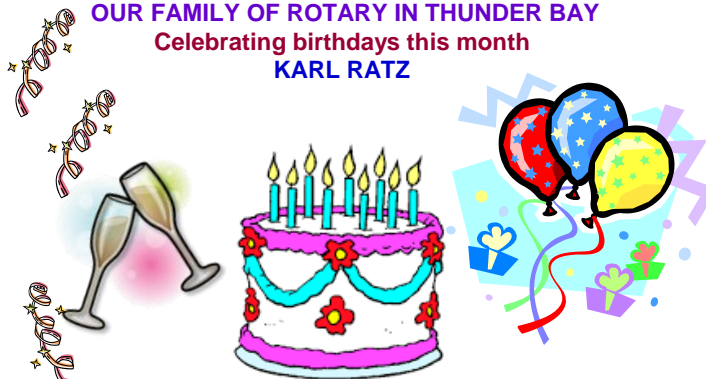

PRESENTATION:

This was our monthly Business Meeting but we welcomed our guest who wished to share news about the First Nations Natural Resources Youth Employment Program, something that our Club might want to know more about and possibly support in some way in the future. Dave Riley is with Outland, the organization that delivers the FNNRYEP program. Randy Coker worked with the FNNRYEP [First Nations Natural Resources Youth Employment Program as an instructor.



Indigenous Partnerships

Outland has been a pioneer in working with Indigenous communities across the country. They have been working side by side with Indigenous people in remote locations since their inception in 1985. They recognize the desire for meaningful employment, respect for culture and environment and control of their communities' futures. They emphasize cultural awareness. They use local suppliers, support local communities and involve Indigenous people as employees and partners throughout their operations. Their commitment is to:

- Create jobs and training opportunities in the community
- Develop sustainable business partnerships in high-growth industries
- Share ongoing revenue streams
- Bring tangible economic benefits to the community
- Follow the toughest safety and environmental standards
- Develop new business partnerships including remote workforce housing and remote workforce catering.

Youth Training Programs

Outland's range of training and employment initiatives illustrates a strong social consciousness with respect to the traditional lands and communities on or adjacent to our operations. Outland is an industry leader in facilitating effective capacity building environments for Indigenous youth. They are committed to developing their northern workforce to reflect the imminent demographic shifts in Canada's northern populations.

- Youth development and mentoring programs
- Cooperative capacity building training and work initiatives
- Post-training employment opportunities available in Outland's operations

First Nations Natural Resources Youth Employment Program

The First Nations Natural Resources Youth Employment Program (FNNRYEP) is a local, community driven initiative that works towards equity and opportunity for Indigenous youth. Through the collective efforts of their partners and using natural resource management as a platform, the FNNRYEP focuses on developing work skills, life skills, and encouraging youth to achieve an adult life of prosperity, self-sufficiency, and personal growth.

Since 2000 the FNNRYEP has been successfully providing holistic, hands-on education, employment and training opportunities for Aboriginal youth between ages 16 and 18. The FNNRYEP offers an on-the-land, culturally relevant, multi-year learning experience in a live-in bush camp environment. With the support of their partners, Indigenous communities, and dedicated staff, the FNNRYEP has employed over 390 youth from 50 Indigenous communities; translating into 929 summer job placements in Ontario.

The program boasts many social, economic and educational benefits for youth including competitive wages, relationship development, team building, increased confidence, strong work ethic, healthy habits, and experiential learning. Ultimately, they are setting the foundation for youth to have a productive and happy adult life whether on or off reserve. They are seeing graduates contributing to their communities by participating in band leadership, administration, social services, local industry and entrepreneurship. Every year they see what the power of investing in Indigenous youth can do. Unlocking the potential of this underfunded, underrepresented population has limitless benefits to all Canadians.

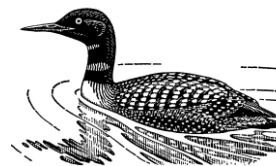
INTERNATIONAL PROJECT - LIFESONG:

The 37th annual TERRY FOX RUN takes place around the world on Sunday, September 17th and Terry's many friends and supporters will gather in Thunder Bay by St. Ignatius High School to honour his legacy and continue his "Marathon of Hope".

Hundreds of participants are expected and registration begins on site at 1:00 p.m. and the Run gets underway at 2:00 p.m.

Lakehead Rotarians will once again co-ordinate the Run lead by Rotarian Don Morrison. Rotary volunteers and friends will work the registration tables, provide water at stations around Boulevard Lake, and serve up Terry Fox Run Certificates and Stickers at the end of the Run as well as refreshments for the "runners". All ages participate in the Run including babes in strollers, cyclists, roller-blade skaters, first-time joggers, and experienced marathoners. It's a non-competitive event and everyone completes the course at their own pace.
