What You Missed August 5, 2016

The room was filled with sunshine. talk of summer, and beautiful music as Rotarians and guests gathered for lunch. President Susan welcomed

everyone and offered a powerful invocation focused on giving. "We are all children of chance. To give is to love". PP Steve Smith welcomed two visiting Rotarians and guests.

F&E is hosting a "Paddle Down the Humber" event on Saturday, August 27th. The 68th Annual Golf Tournament will take place on Thursday, August 18th. Two more foursomes and additional prizes are needed. Good wishes were given to Jack Robertson who celebrated his birthday on August 4th. This was President Susan's first opportunity to welcome two new members; Sarah Larbi and Mumtaz Iqbal.

Saleem Kassum introduced today's guest speaker "Super Stephanie" Christensen, the Executive Director of ShelterBox Canada, by commenting that she has been serving all of her life. Stephanie's opening remarks recognized that Rotary is the largest supporter of ShelterBox in the world. She said there are 19.3 million people currently displaced by disasters. ShelterBox's mission is to leave no family without shelter. Recently, Project 2025 has been initiated to innovate and adapt to meet the needs expected to result from climate change. Stephanie reiterated that the partnership with Rotary is crucial to the work they do. The partnership with RI has recently been extended for another three years. Rotarians were recently instrumental on the ground in Sri Lanka to help deal with the catastrophic impacts of major landslides.

Stephanie said ShelterBox are continually evaluating the success of their projects by returning to disaster sites, adapting and expanding, based on the result of the evaluations. The ShelterBox remains the heart of what they do. There are five

different types of tents (e.g., cold weather, hot weather). However, the ShelterBox is only one of eight offerings. There are Shelter Kits with the materials to repair or re-build homes. Stephanie related the story of Alisa in Malawi. She is blind and cares for her three siblings. It would have been devastating for her to resettle in an unfamiliar place, so the Shelter Kit enabled her home to be rebuilt. ShelterBox also has a School Box, containing the supplies for 50 children. It is intended to help children get back to school. It's being used in Syria currently. As another example, ShelterBox was recently in Fiji to help those who'd lost everything due to the largest cyclone in the Southern Hemisphere. In Fiji, 2,000 boxes and 1,000 kits were distributed across five different islands. Stephanie said: "The kits are invaluable. They not only provide a temporary home, but a hope to restart".

The cost of a ShelterBox is \$1,200, which includes the content, shipping and installation. Each kit includes two solar lights. Tents are manufactured in the UK and Vietnam and stored in 18 different countries to enable prompt shipment to disaster areas. ShelterBox works in partnership with Rotary and the UN, in the UN cluster system. Often ShelterBox goes to places where other organizations don't go. Typically a ShelterBox will be needed for approximately six months, but in refugee camps, the length of time is significantly longer. Before kits are put in camps, infrastructure services (water, sanitation, and food) are confirmed.

After the Q&A, Stephanie closed by saying that the partnership with Rotary is the best way to give during disasters and she hopes the partnership will be expanded. Steve Smith won the Ace of Clubs draw and took home a bottle of wine. President Susan concluded the meeting with a great Michelle Obama story.
