Susan Howson is a third-generation Rotarian. Growing up with parents who believed in giving back to their communities – preferably through Rotary – it was a natural step to join The Rotary Club of Toronto in 1991. Women had only recently been allowed to Rotary and Susan was one of the first 10.

After graduating from Western University in 1976 with a BA in history, Susan joined Wood Gundy's clerical staff. In the following nine years, she completed a range of security courses, enabling her to rise through departments that included Compliance, Foreign Exchange and Money Market. In 1985, she left Wood Gundy to spend the summer deciding what to do next.

After a discussion with George Beck (a member of The Rotary Club of Toronto and a close family friend) on the options available in the investment industry, George offered her the opportunity to join Andras Canavest Hetherington (now Mackie Research Capital Corporation, MRCC) to train with him and eventually take over his business. She joined the firm in September 1985 as the firm's sole woman investment advisor. Thirty years later, Susan is a portfolio manager and a director of MRCC, with \$160 million of assets under management with additional responsibilities in maintaining MRCC's portfolio system and guiding other portfolio managers.

Susan was President of The Rotary Club of Toronto in 2007/08, has been involved with several committees including Research and Appeals, Membership and Fundraising. She currently manages Rotary's executive retreat/build-it-and-paint-it camp weekend. Susan is also the current President of the Rotary Club of Toronto Foundation.

Additionally, Susan is President of St David's Tower, a non-profit apartment on Donlands Avenue.

Susan is married to David Weatherston, whom she met in 1985. She has two children, Alison and Michael, and will be a grandmother in March 2019.

REMEMBRANCE DAY MEETING

They shall not grow old, as we that are left to grow old; Age will not weary them, nor the years condemn. At the going down of the sun and in the morning, We will remember them.




This moving invocation delivered by Honorary Member Jim Bell, Bombardier in the Fox Artillery of the Second Regiment of the Royal Canadian Horse

Artillery in the Korean War and Army Cadet in the Second World War, officially opened our Remembrance Day Meeting on Friday November 9, 2018. Today's meeting was special because it marked the 100th anniversary of the end of the Great War at the 11th hour of the 11th day of the 11th month of 1918 and coming out of that War was the emergence of a generation who answered the call to help save the world from the most powerful and ruthless military machines ever. The theme of today's meeting was The Greatest Generation and there are only surviving four members of our Club who experienced service in World War II. Past President Robert O'Brien paid tribute to that Greatest Generation in the first part of the program which he noted was The Present Looking to the Past. He spoke of the many true stories of the War that need to be shared, preserved and told. He referenced the heroism and sacrifice of Maureen Bird's uncle Abraham Brocklebank who spent three years in a German POW camp after being taken prisoner at Dieppe, Elgin Coutts who was born in September 1917 and was a Flight Lieutenant with the Royal Canadian Airforce, his brother-in-law Flt Sgt. Elmer Muttart who gave his life in October 1941 to save the village of Wons, Holland and to give his crew the opportunity to parachute to safety while he diverted the plane, Jim Bell who did not allow age or the Canoe River Train Crash disaster to deter him from serving his country in the Pacific, John Austin and Jack Robertson both anxiously awaited their 18th birthdays so that they could enlist and serve their country. Past President Jack Robertson then spoke in the second half of the program, which was the Past Looking to the Present. Jack was born in Hamilton on August 4, 1925 and on his 18th birthday went to local enlistment office, produced his identification and volunteered for service in the RCAF which he modestly commented was "something you would have done at the time". Jack gave a highly personal first hand account of what life was like for the twenty months he served in the War. He explained what it was like training to be a pilot in Belleville, Pendleton, Charlottetown and St Jean Quebec. He spoke of the achievement of "receiving his wings" and being promoted to Pilot Officer and Navigator. Jack then took us into the cockpit of the Tiger Moth and by his words we could visualize what it might have been like: the confined space

in uniform with parachute, the switch to start the plane outside the window, someone from the ground rotating the propeller to get a spark, the loud noise of the engine, the two pedals and the rudder stick. There was no GPS as we know today, but Jack navigated using a rudimentary sextant and described how he would line up three stars and use paper maps on board to determine where he was. He spoke of the thrill of ascending in the air and for the audience the nerve wracking landing experience. Jack noted in all honesty that "it sounds difficult and it was difficult and that it was quite the exercise" but overall it was "a good experience, good discipline and I enjoyed it". To hear Jack's story was special for each and everyone in the audience today and it was a rare opportunity for us to hear a first hand account from one of the Greatest Generation which as time goes by is sadly getting smaller in number with each passing year. Jack received an emotional and heartfelt standing ovation from all in attendance. We were also graced today at the Head Table by last year's speaker Colonel Dwayne Hobbs, Saleem Kassum and Harry Figov, who have served respectively in the Canadian Brigades, in the RCAF in Singapore and in South Africa. President Jeff paid tribute and recognized the names of 27 Rotarians both alive and deceased who served. We were also privileged to have with us The Governor General's Horse Guard which played stirring military music before our meeting, during lunch and ended with Col. Bogey's March. Today's meeting was a memorable and poignant occasion and in response to the Jim Bell's invocation which opened the meeting: We Will Remember Them.

What You Missed November 2, 2018 - by Heather Hetherington



Following President Jeff's welcome and Invocation Rotarians and guests remained standing for an "In Memoriam" for our member Knud Westergaard who passed away October 25, 2018. Words of tribute offered by President Jeff were followed by the hymn "Abide with Me" sung in Danish by Brigitte Bogar, in honour of Knud's homeland. Condolences were extended to Knud's wife Yoneko who had joined us for the meeting.

Monitor Michael Morgan introduced four visiting Rotarians along with several guests. Members were reminded to submit to President Jeff, the names of candidates for consideration for nomination for district Governor. A second announcement drew attention to the date of the Children's Christmas Party and the need for volunteers and financial donations.

Following the announcements, two new members were formally introduced. Dr. Carole Chauncey and John Bishop were warmly welcomed by all as Carole received her pin from her sponsor Dauna Jones Simmonds and John his pin from sponsor Bill Morari.



After showing a brief video that pointed out the types and breakdown of active ingredients in Cannabis, Jeff underscored the need for employers to differentiate and be educated on the various effects of each. He suggested that employers review and update any existing policy relating to drug and alcohol issues and If no policy exists then immediately create one. Simply stating "Zero Tolerance" doesn't work – it must be defined. The concept of Fit for Duty must be understood to include physical, mental and emotional states and safety implications clearly defined for employees, e.g. cab drivers. Additionally formal training and education seminars in the workplace were recommended. There should also be a mechanism whereby employees reliant on medical cannabis disclose and know the policy for accommodation in their workplace.

President Jeff thanked our speaker who then drew the Ace of Clubs ticket and a bottle of wine was won by Jackie Davies.
