What You Missed September 22, 2017

There was another great turnout at the National Club this week, with the staff having to add an extra table.... and of course the luncheon was delicious as usual. We had an In Memoriam for John Gregory, one of our long-time members and a great supporter of our club. Monitor Michele Guy introduced a total of 22 guests and Rotarians,

including a large contingent of the Andras family, who were there in support of the speaker. President Pat announced that our Foundation has donated \$15,000 to ShelterBox for latest disasters in the US and has agreed to match any donations made by Rotarians and others up to \$25,000. Brent Thomas, the past chair of our Youth and Children's Committee, along with Catherine Woodford, the vice president of Rotaract Toronto, awarded 2 grants to charities in the GTA that focus on Youth Mental Health. Y&CS and partnering Rotaractors undertook an extensive vetting process to find the top two contestants for each grant. \$3,000 went to Cameron Helps; the money to be used for purchasing sneakers for low-income students so they can participate in their running program. \$8,000 went to the George Hull Centre; the money to be used for 1 personnel trainer and a year's worth of group therapy sessions for 10 family units in the 'PPP' program, shown to improve the relationships between guardians and children with behavioural and emotional issues.

Past President John Andras introduced our guest speaker, his son Alex, to speak on the topic 'Living the Wrong Gender'. What followed was a presentation that was unique to The Rotary Club of Toronto. Personally speaking, having attended hundreds of Rotary meetings, I can say that very few, if any, were more moving or dramatic. Alex Andras was born a girl in 1992. He suffered from gender dysphoria for most of his life and it was only within the last few years that he found the right doctor who made the correct diagnosis and prescribed the proper testosterone treatments to allow physical and mental bodily changes to take place. Alex told the audience about his difficulties in growing up, his inability to relate to other girls, his lack of friends, his 'therapeutic boarding school' in the United States, and his feelings of depression and suicide. As he said, "To stand up and speak to you today is amazing to me. I have a different body shape, a different body size, and a 'good beard'. This can happen to anyone, so creating awareness of people like me is extremely important". Alex is about to graduate from Humber College and is planning on going through the doctorate program for social work. At the conclusion of his speech he asked for a moment of silence in support of all the people like

him. Club members were very silent during his presentation but when he concluded, they stood up en mass and applauded. Alex fielded many questions from the audience and clearly had much support and admiration from his parents and family. This was one of the most illuminating and courageous presentations that we have ever had! After all that, John Joseph Mastandrea (who had sung a commercial for our Food Truck Extravaganza earlier in the programme) managed to get his ticket drawn in the Ace of Clubs Draw. He won the bottle of wine, which I expect he'll take to the Food truck event!
