He was the Global Commercial Director for Chivas Brothers Ltd. from 2002 to 2007, gaining significant experience in markets in Europe, Asia, and the Americas. Prior to that he was the Marketing Manager of Campbell Distillers, and held various positions with International Distillers & Vintners.

On April 23rd approximately 12-14 Rotarians and friends will be boarding an Ethiopian Airlines Flight to Zomba, Malawi. We return May 11.

The purpose of the trip is to help build some more classrooms on the Mbidi School.

Over several trips we will have added and improved eight classrooms. Even though, in general, only about a third of Malawian children are able to finish primary school, our Rotary-sponsored additions have enabled many more to stay and finish.

We will also be working with the amazing women of Kachere. These women have full-blown AIDS but because of antiretroviral drugs they are able to lead a full life. Their average income is only about one dollar per day, yet they are the most giving, positive and spirited women I and others who have been on our trips have ever met!

While we work hard the work is not difficult. The temperature is not too hot, either. We will also take in a short Safari. So far, Rotary Club of Toronto members Paul Truelove, Brian Westlake and Maureen Bird will be going. Join them! The cost is \$4600 and is tax receiptable. We still have a few spots open. ## Donating a Win-Win Situation

Considering a donation to the Rotary Club of Toronto now or in your will? Thanks to changes in Canada's tax laws, you now get maximum bang for your donation buck when you donate stock or other valuable securities.

What's the change and how does it work for you? Simple, now you can donate any publicly traded stock to Rotary. The value to the Club is the same, but the value to you can be significant, because you get to skip right over the issue of capital gain.

Following is an example of how this benefits you. Assume you have stock that cost you \$1,000, now valued at \$2,000 and you'd like to give that value to us. Under the old rules, you'd have had to sell the stock first, incurring a capital gains tax liability. Under the new rules, you can simply give Rotary the stock – and there's no tax obligation!

By KPMG's reckoning the value of the new rules looks like this:

|                                       | Old Rules                       | New Rules                              |
|---------------------------------------|---------------------------------|--|
| Donation                              | \$2000 realized from stock sale | Stock valued at \$2000                 |
| Original cost                         | \$1000                          | \$1000                                 |
| Tax on capital gain                   | \$230                           | n/a                                    |
| Donation tax credit                   | \$920                           | \$920                                  |
| Net tax saving                        | \$690                           | \$920                                  |
| <b>Net cost of donation after tax</b> | <b>\$1310</b>                   | <b>\$1080</b><br>(a \$230 improvement) |

It's a win for you, a win for the Rotary Club and a win for the initiatives we're all trying to support.
