- Once proposed and formally accepted by the Board, the new member(s) makes financial arrangements with the Club, including the establishment of an account with the Rotary office. The new member submits a photo to the Rotary office. A Name Badge(s) is ordered and a date is set for the new member(s) to be introduced to the Club at a regular meeting.
- All new members will be interviewed by the Proposer or a Membership Committee member for the newsletter's Member Spotlight and optional press release.
- Corporate membership: The Lead corporate member can appoint an employee(s) to represent the company or organization should one or more of the designated members be unable to attend a weekly meeting.
- Corporate membership: Company name badge(s) will be available for the designated member upon check-in at the weekly meeting. Any employee(s) filling in for members unable to attend will be introduced as "guests" representing their company or organization.
