Former member Jeff Kemink returns to tell about Africa Unlifted's work in Sierra Leone

Three guests joined Moorhead Rotarians at our April 16 meeting — former member Jeff Kemink and his wife Julie, who presented a program on their work with Africa Uplifted, and Dan Parries, who introdued himself as "first husband" to the district governor-elect.

President Steve thanked those who brought toothpaste, deodorant or shampoo as part of our plan to donate 50 of each to the young adults of Fraser Ltd. The deadline for donations is May 26.

Recital breaks all records!

Recital with a Cause chairman John Andreasen reported on the record-setting concert April 11 and the even more memorable goal reached in raising funds for PolioPlus. A total of about \$112,000 was gathered for the Rotary International campaign to eradicate polio. (Several thousand dollars of that total will also be donated to the two local youth symphonies.)

He said the audience of about 160 was the largest in the concert's 14-year history. Matched two-toone by the Bill and Melinda Gates Foundation, more than \$300,000 will go to the cause.

Sarge Jerry shares facts about Tax Day

On the day after the tax deadline, Sergeant at Arms Jerry Rogers shared its background. Congress passed the first income tax measure in 1861 to fund the Civil War. Before that, federal funds were raised through excise taxes. The income tax as we know it today came to be in 1913 with ratification of the 16th Amendment. The deadline of April 15 was established in 1954.

Jerry initiated the first happy dollars — one in honor of exchange student Ansgar stepping up to receive the club's honors at the District Conference, and another for John Andreasen's 9-year-old granddaughter Cora Gambell, who performed a violin duet at the conference with her mother Karin

Jean Hannig saluted the exchange students who performed at the conference, along with the excellent speakers and everyone who helped organize the event.

Dave Tranby and Violet Deilke both designated their dollars in honor of former Moorhead Rotarian Jeff Kemink and his wife. Tom Riley celebrated the recital's success — "It was amazing!" Keminks tell of work in Sierra Leone village

Many members welcomed Jeff Kemink "home." The former Wells Fargo bank president has worked in Montana, Bemidji and the Twin Cities since leaving Moorhead. Now retired, he and wife Julie have joined forces withe their friends Lance and Julie Burma, who established the nonprofit called Africa Uplifted 15 years ago.

The charity focuses its work on one village, Manonkoh, in the very small western African nation of Sierra Leone. Its first group of volunteers established a clinic that sees After establishing a clinic, water wells and latrines in its first visit in 2009, the group went on to install solar panels to provide electricity to the village. Volunteers have gone on to establish and then expand a village school. It now employs 10 teachers who provide preschool and elementary education to more 300 students.

Africa Uplifted volunteers visit Sierra Leone regularly. The Keminks have participated in four of those two-week trips. Jeff told the club, "Imagine the hottest you've ever been. It's hotter than that. Then think of the highest humidity. It's worse." Some trips focus on medical outreach, while others may have an educational, spiritual or an economic developmental focus.
