"Pangborn Update"

With Trent Moyer, Airport Manager

Trent Moyers is a Certified Flight Instructor and has over 20 years of experience in airport planning, operations and management at commercial service and general aviation airports. His previous positions as Airport Manager at the Elko Regional Airport in Elko, NV and Assistant Airport Manager at Bryce Canyon Airport in Bryce, UT are the foundation of his passion for the airport industry. He will be talking about the recent expansion of the runway and an update on airport operations in general.

Pangborn Memorial Airport is jointly owned and operated by the Ports of Chelan and Douglas Counties. Under a joint operating agreement, the Port of Douglas County is responsible for the management of the airport's business park. The Port of Chelan County is responsible for aviation operations and per an MOU, the Port of Chelan County has the authority of the governing board under the JOA.

The airport plays a vital role in connecting the North Central Washington region to the national and international air transport systems. The daily scheduled service to Seattle-Tacoma International Airport provides the region with one-stop connecting service to 20 major international and 75 domestic destinations.

In addition to commercial passenger and freight service, Pangborn is also the home base of approximately 120 aircraft, an active USFS Rappel Base, and many other businesses. A visitor to the airport might see a variety of aircraft ranging from gliders to experimental aircraft, to business jets to the current mainstay commercial aircraft, Alaska Airline's DeHavilland Dash 8 Q-400.

A 2001 study commissioned by the Washington Department of Transportation found that Pangborn Memorial Airport directly and indirectly supports 632 jobs and contributes over \$47,000,000 annually to the local economy
