- 3. Local Hero Award Pete & Don selected Carmen Bossenbrock for her long Rotary service. **Motion** by Pete, second by Maynard.

- 4. Friendship award tabled.
- 5. Potential new members from a multicultural satellite club. Jim gave status report and stated plans to meet with Dick Reed and Alphonso Lopez to seek ways to recruit members, especially with UNA, who are interested in seeking Humanitarian grant funds. They would be members of our club with their own rules, but under our bylaws. Dues could be an issue but Jim will investigate further. Alice cautioned about giving special considerations. No decisions.

Board Reports:

- 1. Humanitarian Susan reported on two completed cycles. Four completed applications received for cycle 3. All are on track and on budget. They would like to seek some publicity on good things we are doing. Interact video is posted on our web site, and hopes to add to district site. Frank will pursue.
- 2. MDD progress discussion. Donations are coming in and there has been more recognition for Ed Cadman. Jim will ask Wen. World about archive stories on Dr. Cadman.
- 3. Public/media relations, brand awareness Jim discussed a possible Rotary \$2000 grant and Jim Corcoran's proposals and ideas. Lots of discussion and ideas. Deadline is in April. Tabled for lack of a motion.
- 4. TRF/PHF recognition points we are giving <u>Bradi Dahman</u> 1500 points & <u>Mike Noyd</u> 2000 points for donations to the club in support of the MDD (as explained in attached agenda). Action was taken as presidential prerogative; no members objected. [Secretary note: Foundation recognition points, or PHF points are accumulated1:1 for each dollar donated to any fund of The Rotary Foundation, TRF). They may be transferred to any individual in recognition for service to the club or community. Wenatchee Rotary club has accumulated PHF points for past donations and currently owns almost 14,000 points. There are no rules for how points may be transferred.]

New Business :

1. **Motion** by Pete, second by Mario to designate \$5K to YWCA (from auction housing \$30K allocation) as a way of qualifying for a \$5K matching district grant (still under district review). See agenda. **Passed**.

She is donating \$1,000 to Wenatchee Rotary and be recognized in program materials, We thank *Bradi Dahmen, Director of Wealth Management at Cordell Neher & Company PLLC for her support in underwriting the expense of this dinner.* Our Board is matching donations towards a first Paul Harris Fellow, so our Club will give Dahman 1500 points towards Paul Harris Fellow honors, making you a Paul Harris Fellow with 500 points credit for another Paul Harris Fellow level. If she would like, she can nominate a quest at the dinner in your place.

Michael Noyd has pledged \$1500 to Wenatchee Rotary to be paid at \$750 per year for two years beginning on in March 2017. We plan to recognize him as Michael Noyd, of Noyd & Noyd Insurance, for he and his firm's support in underwriting the expense of this dinner. We will reward him 2000 points for his first Paul Harris Fellow and a PHF+1.

New business:

1. Grant submitted for matching funds to upgrade, repair and remodel new housing owned by the YWCA. The grant is currently under review by District 5060 and needs Wenatchee Rotary Board approval. Jill Leonard worked with Jenny Pratt at the YWCA and Laurel Turner to submit this application. Pratt submitted it to Jim Russell on March1, two hours before the deadline of March 1. Grant was approved for consideration but needs updates. Final decision is March 31. Grant asks for \$5,000 with \$5,000 matching funds from Auction. Pete Van Well's name is on the grant because he is authorized to submit grants after he completed the training earlier this year. --- Jill Leonard, Jim Russell, Pete Van Well

Grant language introduction:

What project activities will take place?

YWCA NCW had the YWCA USA Strategic Planning team in Wenatchee to hold strategic planning in 2016. We identified plans to add additional low income housing to our continuum of homeless housing services. Our plans to develop new housing in 3-5 years are great, we need housing now for clients we continue to turn away, due to no vacancy. The YWCA Board of Directors has voted unanimously to purchase property now in 2017 to increase our current capacity in transitional and permanent housing. This will more than double our current units from 15 to a total of 23 total low income housing.

We are asking for funding to support remodeling and repair of property for transitional and permanent supportive housing that we are purchasing. The Board authorized the completion of a purchase and sale agreement with contingencies and a 90-day timeline. They anticipate a close before July 1, 2017 and making the housing habitable within the next 12 months. The Board has back-up properties.

Brand Awareness Grant (Designated 'new business' even though discussed in past meetings but not documented) ---Question for the Board: Should we propose branding and advertising with/to other clubs an event in Rotary Park to serve as an alternative to past activities branding activities (such as handing out free information at the East Wenatchee—Wenatchee High School football game)? Note Jim Corcoran has proposed a radio campaign.
