Action items:

District Conference. .Jim announced that he and Frank are attending in Yakima, May 13, 14.

Discuss having club pay for officers to attend 2016 District Conference at a cost of \$205.

Motion by Pete to pay for President-elect and secretary at full rate, and other board members, with total cost not to exceed \$800. Amended by Susan that for the future, the club seek a permanent plan for engaging new members to attend the event. Motion seconded by Jill. Motion passed.

District Training, Osoyoos. Jim announced that he and Frank are registered for April 23. But due to the travel involved, he suggests we cancel and conduct our own training here. Pete announced that he has received an offer of assistance from Jim Adamson. There was general agreement. Membership committee will work on this.

Grant funds - General discussion based on Jim's agenda. No action at this time.

ClubRunner preliminary club website. Frank presented a development progress report and demonstration of some of the primary features. Time and tech issues limited the extent of the session, but response was positive.

Jim will explore with John McDarment the disposition of the current contract.

## Other items:

Wenatchee Rotary Foundation - Comments added later by Jim Russell: Alice Meyer represented the Wenatchee Board on two issues: The procedures for requesting funds from the foundation beneficiaries is cumbersome and needs to be clarified. Chris Rumbles will work 1. with Bill Murray, Jim Russell and the foundation to create a request authorization that meets the requirements for disbursement of funds and that could be posted on our website. No Board action was taken.

2. The foundation also recommended the two boards consider placing the Foundation president elect on the Wenatchee Rotary Board. It would probably require a change in the by-laws of both organizations. Jim believes that the Board is willing to consider a proposed change. No action taken.
