dollars are spent in Benton and Franklin counties by visitors, with \$16.5 million paid in sales taxes (doesn't include hotel taxes), and generating 5900 jobs. The services of Visit Tri-Cities are free. The organization is funded by a Tourism and Promotion assessment, local taxes, and the 791 members in Visit Tri-Cities.

Visit Tri-Cities supports the Tri-Cities Sports Council, Rivershore Enhancement Council and the Wine Tourism Council, which was started just three years ago. Sports are a huge growth area; both professional and school based sports events and brings many to the Tri-Cities. The best known of their activities is the Three Rivers Convention Center which brought in 228 events, 116,593 visitors and \$31 million. They maintain an interactive display at the airport, and publish a Wine and Arts map, and Shop and Dine guide. Kim commented on the 4 new hotels that opened in 2015 and the 3 more under construction in 2016, which can serve the increasing visits to the Tri-Cities, expansion of the Tri-Cities Airport, and the impact of the new Manhattan Project National Park established last year, which is expected to generate 100,000 visits, all contributing to an even brighter future for Tri-Cities tourism.
