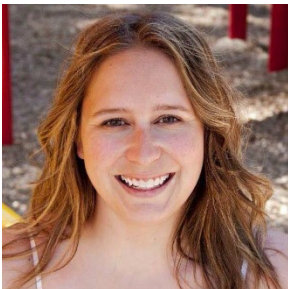





**ROTARY CLUB OF SPOKANE**  
BY-LAWS  
of the ROTARY CLUB  
of  
SPOKANE, WASHINGTON

**ARTICLE I BOARD OF DIRECTORS**

The governing body of the club shall be the Board of Directors, elected or appointed in accordance with Article II of the By-Laws. The Board of Directors of the Club shall also serve as the Board of Directors of Rotary Community Service, Inc.

**ARTICLE II OFFICERS & DIRECTORS**

**SECTION 1. Designation of Officers and Directors:**

- a. The Officers of the Rotary Club of Spokane, Washington (hereafter Club), shall be President, President Elect, Vice President and Secretary/Treasurer. In accordance with the procedures below, the club shall yearly elect a Vice President who shall serve a one-year term with the intention of then succeeding to the position of President Elect for the following year and then with the intention of succeeding to the position of President for one year in accordance with the ratification procedure stated below in Section 3.
- b. The Secretary/Treasurer shall be elected for a term of two years.
- c. Four Directors shall be elected for a term of two years and the following year three directors shall be elected for a term of two years. The Immediate Past President shall serve for one year as a Director.

**SECTION 2. Board of Directors:**

The Board of Directors shall consist of the Officers and Directors.

**SECTION 3. Nomination and Election of Officers and Directors:**

- a. At least 60 days prior to the Club's annual meeting (currently the first Thursday of December), the President and the Immediate Past President shall cause to be formed and shall select and appoint a Nominating Committee to be chaired by the Immediate Past President and consisting of three (3) members of the present Board of Directors, three (3) past presidents, three (3) current committee chairs, and three (3) at large members in good standing.
- b. At least 45 days prior to the Annual Meeting, the presiding officer at a regular meeting shall announce the formation of a Nominating Committee, its membership, the qualifications for nomination to the Board of Directors, the procedure for conveying nominations to the Committee and the closing date for nominations.
- c. **Qualifications for Nomination:** To be qualified for nomination to the position of Director one must be a member in good standing and be or previously have been a committee chair or co-chair. To be qualified for the position of President, President Elect, and Vice President, one must be a member in good standing and be or have been a Director. To be qualified for the Treasurer/Secretary position one must be a member in good standing and have a

background in accounting and/or finance or other relevant experience and have such other qualifications as may be determined by the Nominating Committee.

- d. The closing date for nominations to be considered by the Nominating Committee shall be 1:30 p.m. the day prior to the date set for the Nominating Committee meeting but in no event sooner than 10 days after the announcement to the Club of the Nominating Committee Membership. In consideration of those not in attendance at the regular meeting announcing the Nominating Committee, the membership shall be provided the same information by “due notice” as defined below.
- e. Each announcement and due notice shall advise the membership that any Active Member may nominate any other qualified member by conveying the name of the nominee to any member of the Nominating Committee, having first obtained permission and an indication of willingness to serve by the proposed nominee. Members of the Nominating Committee, having received a nomination, shall convey the name to the Club Secretary/Treasurer or the Secretary/Treasurer’s designee who shall vet the qualifications of each nominee. A list of nominees, along with a uniform biography of each, shall be provided to each member of the Nominating Committee upon the close of nominations.
- f. The Executive Director shall cause to be prepared and regularly updated, a list, by position and in alphabetical order, of all nominees for each position.
- g. At least 30 days prior to the Annual Meeting, the Nominating Committee shall meet for the purpose of electing a slate of Officers and Directors to present to the club membership. A majority of the Nominating Committee present shall constitute a quorum.

**Procedure of Nominating Committee:**

- a. The Immediate Past President shall be the presiding officer at the Nominating Committee. If unavailable, a former Past President, appointed by the current President, shall be the presiding officer. All elections under this article shall be by written ballot.
- b. With respect to the office of President, the current President Elect shall indicate to the Nominating Committee her/his willingness to accept the office. The presiding officer shall then advise the Nominating Committee of said willingness and the proviso herein adopted that the standing President Elect shall be ratified as President by unanimous acclamation unless another member(s) of the committee has an opposing nomination in which case, or if the standing president declines to serve, there shall be an election.
- c. The succession of Vice President to the office of President Elect or the election of a President Elect shall follow the same procedure as the office of President.
- d. Nominations for and election of the Vice President shall proceed next, followed by nominations and elections for Secretary/Treasurer (when applicable) and Directors.
- e. In the event there is an even number of Nominating Committee members present for a vote and only two candidates, the presiding officer shall not vote.

## **Nominating Committee Slate; Further Nominations; Ratification/Election by the Club Active Membership:**

- a. At the regular meeting, two weeks prior to the meeting for election of Officers and Directors, the slate of candidates elected by the Nominating Committee shall be read to the membership. The Secretary/Treasurer or designee shall vet the qualifications of the nominee prior to entry of the nominee's name to the final slate of candidates presented for election.
- b. On the day set for ratification the slate shall be read. Positions shall be called for election by voice vote ratification.

### **SECTION 4. Vacancy:**

A vacancy in the Board of Directors and/or an Officer shall be filled by action of the remaining members of the Board of Directors. A vacancy in the Board of Directors Elect and/or an Officer Elect shall be filled by action of the remaining members of the Board of Directors together with members elect to the Board of Directors.

### **SECTION 5. Successive Terms:**

Excepting the office of Secretary/Treasurer, no member shall serve successive terms as Director or for the same office. This rule shall not be construed to prevent a member from serving multiple terms after a 1-year absence between service in the same office.

### **SECTION 6. Removal from the Board of Directors:**

Upon the motion of any member of the Board of Directors that a member of the Board of Directors should be removed from office, the Board of Directors shall consider and vote on the motion in a timely manner. A vote in favor of removal shall be effective immediately.

## **ARTICLE III DUTIES OF OFFICERS**

### **SECTION 1. President:**

It shall be the duty of the President to serve on the Board of Directors, to preside at meetings of the Club and Board of Directors, and to perform such other duties as ordinarily pertain to the office.

### **SECTION 2. President-Elect:**

It shall be the duty of the President-Elect to serve on the Board of Directors, to preside at meetings in the President's absence, and to perform such other duties as may be prescribed by the President or the Board of Directors.

### **SECTION 3. Vice-President:**

It shall be the duty of the Vice-President to serve on the Board of Directors, to chair the Rotary Community Service Inc., (RCS Inc.) fundraising campaign, to chair RCS Inc. Board of Directors meetings and to perform such other duties as ordinarily pertain to this office.

### **SECTION 4. Secretary/Treasurer:**

The duties of the Secretary and Treasurer shall be combined and performed by one member referred to as the Secretary/Treasurer.

- a. It shall be the responsibility of the Secretary to maintain records of membership and attendance, notify membership of meetings of the Club, Board of Directors and Committees, and arrange for actions taken by the Club, Board of Directors and Committees to be duly

recorded. The Secretary shall be responsible for ensuring that all required reports to Rotary International, Rotary International District 5080, Washington State Secretary of State and the Internal Revenue Service are filed in a timely manner.

- b. It shall be the responsibility of the Treasurer to maintain custody of all funds, account to the Club annually, and to the Board of Directors upon demand. The Treasurer shall be responsible for all funds of the Club and for those of Rotary Community Service, Inc. and shall obtain approval from the Board of Directors for any and all accounts with financial institutions.

## **ARTICLE IV MEETINGS**

### **SECTION 1. Annual Meeting:**

An annual meeting of the Club shall be held the first Thursday in December, at which time ratification of the slate of Officers and Directors to serve the ensuing Rotary year shall take place.

### **SECTION 2. Regular Meeting:**

- a. The regular weekly meeting of the Club shall be at 12:00 (noon) every Thursday. Due notice of any change or cancellation of the regular meeting shall be given to all members of the club.
- b. All members, excepting an Honorary Member (or member excused by the Board of Directors of this Club, pursuant to Article VII, Section 3 of the standard Rotary Club Constitution) in good standing in the Club on the day of the regular meeting, must be counted as present or absent.

### **SECTION 3. Participation:**

Participation is recognized as attending a regular Club meeting, a Club committee meeting, a Club sponsored event, or if 10 Rotarians or more attend the same event or meeting. Members who attain 100% participation shall be recognized annually.

### **SECTION 4. Quorum:**

Twenty percent of the membership shall constitute a quorum at the annual and regular meetings of the Club.

### **SECTION 5. Board of Directors Meetings:**

- a. Regular meetings of the Board of Directors shall be held twice monthly at a regularly scheduled time and place. Upon notice, a regular Board of Directors meeting may be cancelled for lack of business or other good reason at the discretion of the presiding officer. Special Meetings of the Board of Directors may be called by the President as deemed necessary, or upon the request of two (2) members of the Board of Directors.
- b. A majority of the Board of Directors Members shall constitute a quorum of the Board of Directors
- c. A special meeting of the Board of Directors shall be announced to the members as soon as reasonably possible.

## **ARTICLE V FEES AND DUES**

### **SECTION 1. Admission Fee:**

A fee for admission to the Club set by Resolution of the Board of Directors and ratified by the general membership. Such fee shall be paid by each new member before the applicant shall qualify as a member.

### **SECTION 2. Dues:**

Annual membership dues are set by Resolution of the Board of Directors of Directors and approved by the general membership. The annual dues include assessments made by Rotary International on July 1 and January 1 and assessments made by Rotary International District 5080 on July 1. Dues are payable annually on the first day of July for all members of record on June 30. Dues for new members shall be pro-rated based on the month of admission with respect to the local portion of the dues. Members who are not current in payment of dues shall not be considered a member in good standing.

### **SECTION 3. Special Assessments:**

A Special Assessment, in an amount as may from time-to-time be approved by the Board of Directors, may be levied upon members if, in the view of the majority of the Board of Directors, it is determined that a decrease in membership or other extraordinary event has or will adversely affect the financial stability of the Club.

## **ARTICLE VI METHOD OF VOTING**

Except for the election of Officers and Directors, which shall be the business of the Club, the method of voting shall be transacted by voice vote unless the outcome of said vote is deemed uncertain by motion of any active member present in which case a standing vote shall be taken.

## **ARTICLE VII COMMITTEES**

### **SECTION 1. Presidential Appointments:**

The President shall appoint chairs to committees under the following committee categories:

1. Club Service Committees
2. Community Service Committees
3. International Service Committees
4. Vocational Service Committee

Upon recommendation of the President, and a majority vote of the Board of Directors, committees may be added or removed from the roster of committees listed below without an official amendment to these Bylaws as described in Article XV below.

### **SECTION 2. Club Service Committees:**

The Chairs of the Club Service Committees shall be responsible for reporting their activities to the President and the Board of Directors of Directors. The following are examples of Club Service Committees; however, additional committees may be created or dissolved by the Board of Directors:

Budget Committee Classification/Membership Committee Development Coordination Committee  
Greeters Committee

Human Resources Committee Invocation Committee

Marketing & Communications Committee Membership Development Committee Member Engagement  
Committee Mentor/Information Committee

Piano Playing Committee Program Committee Song Leading Committee

**SECTION 3. Community Service Committees:**

The Chairs of the Community Service Committees shall be responsible for reporting their activities to the President and the Board of Directors. The following are examples of Community Service Committees; however additional committees may be created or dissolved by the Board of Directors:

Civic Affairs Committee  
Disability Service Committee  
Foster Kidfest Committee  
Support Our Veterans Committee

Vocational Service Committee  
Vaccinations Committee  
Youth Service Committee  
Paul Harris Fellow Committee

**SECTION 4. International Service Committees:**

The Chair(s) of the International Service Committees shall be responsible for reporting their activities to the President and the Board of Directors. The following are examples of International Services Committees/Positions; however additional committees may be created or dissolved by the Board of Directors:

International Service Committee (ISC)  
Rotary International Foundation Committee (Paul Harris Fellow/PHF)  
Youth Exchange Officer (YEO)

**SECTION 5. Spokane Rotary Foundation:**

The Chair of the Spokane Rotary Foundation shall be responsible for reporting its activities to the President and the Board of Directors.

**ARTICLE VIII DUTIES OF COMMITTEES**

**SECTION 1. The Club Service Committees:** Shall devise and carry into effect plans which will guide and assist the Club in discharging its responsibilities in matters relating to Club service.

**SECTION 2. Community Service Committees:** Shall report to the Board of Directors their activities when applicable.

**ARTICLE IX LEAVE OF ABSENCE**

Upon written application to the Board of Directors, setting forth good and sufficient cause, a leave of absence may be granted excusing a member from attendance requirements for a specified length of time.

(Note: Such leave of absence does operate to prevent a forfeiture of membership; it does not operate to give the Club credit for member's attendance. Unless he/she attends a regular meeting of some other club, the excused member must be recorded as absent except that absence authorized under the provisions of Article VII, Sec. 3 of the standard Rotary Club Constitution is not computed in the attendance record of the Club.)

**ARTICLE X FINANCES**

**SECTION 1.** The Treasurer shall be responsible for all funds of the Club and RCS Inc. which shall be deposited in a financial institution approved by the Board of Directors.

**SECTION 2.** All bills shall be paid with checks signed by two authorized signers. An annual review of the Club's financial transactions shall be completed by a certified public accountant.



**SECTION 3.** Staff having charge or control of funds shall give bond as may be required by the Board of Directors for the safe custody of the funds of the Club; cost of bond to be borne by the Club.

**SECTION 4.** The fiscal year of the Club also referenced as the “Club Year” shall extend from July 1<sup>st</sup> to June 30<sup>th</sup>. The payment of per capita dues and magazine subscriptions to Rotary International shall be made in accordance with R.I. procedures, which currently is on July 1<sup>st</sup> and January 1<sup>st</sup> of each year on the basis of the membership of the club on those dates.

**SECTION 5.** At the beginning of each fiscal year, the Board of Directors shall cause to be prepared a budget of estimated income and expenditures for the year, for both the Rotary Club and Rotary Community Service, Inc., which, having been agreed to by the Board of Directors, shall stand as the limit of expenditures for the respective purposes, unless otherwise ordered by action of the Board of Directors.

## **ARTICLE XI**

### **METHOD OF ELECTING MEMBERS**

The Board of Directors shall establish categories such as honorary members, corporate members, emerging members, etc., and shall determine the dates to be paid by each such membership category, all of which shall be ratified by the general membership.

**SECTION 1.** The name of a prospective member, proposed by an active member, shall be submitted to the Classification Committee. A transferring or former member of another club may be proposed to active membership by their former club. The proposer and prospective member will complete an official application for membership. An application without the proposal of an Active Member in good standing or former Rotary club endorsement will be considered incomplete and thus will not be considered. The Classification/Membership Committee will review the application and either recommend or not recommend a prospective member to the Board of Directors. Should the Classification Committee recommend the Board of Directors not invite a prospective member, the Classification Committee chair will provide the reasons to the Board of Directors. The Board of Directors decision on membership shall be final. Deliberations by the Classification/Membership Committee and Board of Directors shall be kept confidential.

**SECTION 2.** The Board of Directors shall ensure that the proposal meets all the classification and membership requirements in accordance with Club By-Laws and the Rotary 21 Constitution.

**SECTION 3.** The Board of Directors shall approve or disapprove the proposal as soon as practicable, and shall notify the proposer of its decision.

**SECTION 4.** Following publication of information about the prospective member, if no written objection to the proposal, stating reasons, is received by the Board of Directors from any member (other than honorary) of the Club within seven (7) days, that person, upon payment of the admission fee (if not honorary membership), as prescribed in these By-Laws, shall be considered to be elected to membership.

Seven (7) day objections apply to new prospective members, Rotarians transferring from other clubs, and former Rotary 21 members seeking to rejoin Club 21. Seven (7) day objections must be provided in writing, include the objecting member’s name, and delivered electronically or otherwise to the Club Executive Director within the 7-day period. Upon receiving a 7-day objection, the Executive Director

will transmit it to the President, who shall refer it to the Classification/Membership Committee. The Classification Committee will hear the input of the objecting and proposing members and will make a new recommendation to the Board of Directors regarding the proposal. If approved by the Board of Directors over the objection, the proposed member, upon payment of the admission fee (if not honorary membership), shall be considered elected to membership.

**SECTION 5.** If the decision of the Board of Directors is favorable, the prospective member shall be informed of the purposes of Rotary and of the privileges and responsibilities of membership by the Rotary Executive Director, following which the prospective member shall be requested to sign the membership proposal form and to permit his or her name and proposed classification to be published to the Club.

**SECTION 6.** Following the election, the President shall arrange for the induction of the new member and the Club Secretary shall report the new member to RI.

### **ARTICLE X11**

A member in good standing shall be defined as a member who is current in the payment of all dues and assessments.

### **ARTICLE XIII RESOLUTIONS**

A resolution or motion to commit the Club on any matter shall first be considered by the Board of Directors. Resolutions or motions, if first offered at a club meeting, shall be referred to the Board of Directors without discussion. If the Board of Directors fails to consider the resolution or motion within a reasonable time or if the Board of Directors declines to bring the resolution or motion to the Club, the proposing member shall then have the right to bring the resolution or motion to the entire membership at any regular meeting upon 30 days' notice to the Board of Directors. Membership approval of any such resolution requires 75% approval of the entire club membership in good standing.

### **ARTICLE XIV DUE NOTICE**

Due notice requires announcement at a regular meeting, together with a conspicuous posting on the Club's web page, and an e-mail, or other electronic communication to every member who has requested electronic notice. It shall be the duty of every member desiring electronic Notice from the Club to provide the Club Secretary with a current electronic address.

### **ARTICLE XV AMENDMENTS**

These By-Laws may be amended at any regular meeting, a quorum being present, by a two-thirds vote of members present, provided that due notice of such proposed amendment shall have been provided to each member at least ten (10) days before such meeting and the amendment has arisen in accordance with Article XIII. No amendment or addition to these By-Laws may be made which is not in harmony with the Rotary Club 21 Constitution and with the Rotary International Constitution and By-Laws.

Approved unanimously by voice vote at our regular Club meeting on December 1, 2022.
