## About Membership

Rotary 21 offers multiple tiers of membership:

-  Full Membership – Any persons may apply for an individual Full Membership.
-  Couples Membership – Established couples may apply for a Couple's Membership.
-  Emerging Rotarian – Any persons under the age of 40 may apply for an Emerging Rotarian membership.  
*Emerging Rotarians are unable to serve in Executive Roles on the Club 21 Board of Directors.*
-  Corporate Memberships – Any business or organization may apply for a Corporate Membership which allows for 2 full memberships with the option to add additional memberships. Billed annually to the business.
  - Includes organizations logo in the club directory, website, and pre-meeting slideshow
  - Ability to sponsor membership engagement events

## Application Process Outline

Selection into Spokane Rotary Club 21 will be based upon a track record of service above self and leadership. After a thorough review of an applicant, an invitation to join may be extended. New member applications take approximately 4-6 weeks to process.

While your application is being reviewed, you are welcome and encouraged to attend Thursday luncheons as a guest to start getting to know the club.

1. Membership applications are available on our website, [www.rotaryspokane.com](http://www.rotaryspokane.com) on the "Join 21" section, or by request via email, from the Rotary office.
2. All applicants are required to have a proposer who is a current member of the Spokane Rotary Club 21. The proposer assists the applicant in filling out the application, then reviews the proposed member's application for completion and submits all paperwork to the Rotary office.
3. Applications are accepted on a rolling basis. To be reviewed in a given month, applications must be complete and submitted by the first or third Monday of the month.
4. The Rotary office assigns a member of the Classification Committee to review paperwork, interview references, make recommendations and report at its next bi-monthly meeting.
5. The board receives a recommendation from the Classification Committee and votes upon the candidate's membership (unless additional information is needed) at its next bi-monthly meeting.
6. If approved, the candidate's name is published in the weekly Monday morning E-News newsletter with seven days allowed for member comments.
7. After a satisfactory conclusion to this process, a Rotary Information Committee member will connect with the applicant to have a meeting with the applicant and present membership information.
8. Applicant completes membership payments, and the Rotary office sends welcome information.
