We have been anxious about our jobs, our ability to pay our bills and about our children. We've been stuck in our homes and away from loved ones and friends. We have missed holidays, graduations, weddings, anniversaries and birthdays. We've worn masks, washed our hands, kept our distance, and gone through more Clorox wipes and Lysol than we ever imagined was possible. People who have donated to food banks, now find themselves standing in line for food to feed their families. It has also been an extraordinary year to witness the compassion of our fellow humans. We can be very good at that too. Especially Rotarians.

Despite the obstacles, the Board and Club have continued to meet (although I will share not as many members regularly attend Club meetings via Zoom as I would like - what can we do to fix that?). Most importantly, despite the obstacles we have continued to support our community. We provided Chrome Books for children who otherwise had no ability to attend school remotely. We donated food to Spokane Valley Partners and to the Malden and Whitman communities devasted by fires so that people had food to eat. To date, since COVID began, the Club, the Club's Charitable Fund and <u>you</u> have donated more than \$60,000 to our community so that those of our partners who feed, clothe and otherwise look after our community's most vulnerable can continue to function.

Father William Eugene O'Brien, Jr. was born in Glen Ridge, New Jersey on June 30, 1949, son of the late William Eugene O'Brien, Sr. and the late Dorothy Eileen Finley O'Brien. He attended Catholic elementary and high schools in New Jersey and received a B.A. degree in Communications from Seton Hall University South Orange, New Jersey in 1978. He worked as a computer programmer. He moved to Foster City, California in 1981. He entered SS Cyril & Methodius Byzantine Catholic Seminary Pittsburgh, Pennsylvania in September 1984 as a seminarian of the Eparchy of Van Nuys. He was ordained to the holy priesthood by the late Bishop Thomas V. Dolinav on May 8, 1988. His assignments include: Administrator of Saints Cyril & Methodius Byzantine Catholic Church in Spokane, Washington; Administrator of St. Basil the Great Byzantine Catholic Church in Los Gatos, California: Administrator of Saint Philip Byzantine Catholic Church in Sacramento, California; and Parochial Vicar of Saint John Chrysostom Byzantine Catholic Church in Seattle, Washington. Father O'Brien once again became the Administrator of Saints Cyril & Methodius Byzantine Catholic Church in Spokane, Washington on January 2, 2003.

Year in Review 2019-2020

Thirty-Seven people of action:

- volunteered more than 2500 hours,
- hosted 5 community events attended by 3000 people, fed 600 children and families,
- donated \$72,816.56 to 13 non-profits,
- awarded \$13,000 in scholarships to 7 graduating seniors,
- delivered \$7,492.56 in new books to 2,403 elementary students.

By the Numbers

The **Club** ended the year with **\$50,734.23** in the bank. This total consists of **\$14,485.13** in our Club operating accounts, and **\$34,622.91** in our "event" accounts, representing funds we have fundraised in years prior.

The total **Fundraising** income for 2019-20 was **\$53,786.80**, generated from our Corn Booth. We paid **\$31,323.30** in expense for the Corn Booth, leaving us a net of **\$22,463.50**. From these funds, we paid **\$7,482.56** for the Book Program, **\$2,500** to Rotaract, and **\$1,500** to STIX Diabetes Programs.

Club Giving

Report on Trusts and Endowments

The Club has five trusts, endowments or charitable associations under its management. A Board of Trustees composed of Ron Schoenberger, Maria Trunkenbolz, Casey Getty, Bill Roe and Paul Fletcher provide fiduciary oversight of the funds. Annual giving budgets are established by taking 5% of the 30 June balance in the accounts which allows for a slow growth of the funds. The monies are invested either in Washington Trust Bank or with Edward Jones. All of these accounts are part of the Rotary District 5080 Charitable Association which provides an IRS Code 501(c)(3) status so that any charitable donations to the trusts, endowments and associations are tax deductible. Gary Bowe, a former member and the District 5080 Treasurer, provides all bookkeeping and tax service for the funds. Following is a breakout of where these entities came from and what the proceeds are used for.

The Henry "Hank" Grinalds Trust. The Grinalds trust was established nearly 25 years ago when Hank, a former member, very benevolently included the Rotary Club in his will. Hank bequeathed us a 5% share of his wealth which at that time was over \$550,000. Monies from this trust are used to assist the elderly in need in the Spokane Valley as specified in his will. The trust has grown over time and at the end of June 2019 was valued at \$679,301. The monies are invested with Washington Trust Bank. This year **\$33,874** was provided in grants to the following organizations:

Over the past five years, the Hank Grinalds Trust has provided, through the Club, over **\$182,000** to the Spokane Valley Community.

The Spokane Valley Rotary Charitable Trust (SVRCT) for Youth. This trust was established over three decades ago from monies donated by Rotary Club members who wanted to see their monies go to youthbased causes in the Spokane Valley. The trust had \$127,106 as of June 2019. The monies are invested through Edward Jones. Last year nearly **\$6,000** was distributed to the following organizations:

Over the past five years nearly **\$30,000** has been provided to youth organizations in Spokane Valley.

The SVRCT Scholarship Endowment.

The monies were generated long ago by a Rotary program known as Upward Bound. The original program sought to mentor youth and to provide them scholarships to secondary level educational opportunities. The program eventually played out and the remaining monies were transferred to the SVRCT to be used for scholarships for graduating seniors from the Spokane Valley Schools. The money totaled \$36,438 last June and is invested with Edward Jones. The budget supported \$2,000 which was provided to the overall club scholarship program which with the club's money provided:

Six \$1,500 scholarships to graduating seniors

The Al Stevens Music Scholarship. Al Stevens was a generous Rotarian who loved music and had a wonderful voice as those who knew him would attest. Al wanted to establish a scholarship fund for students who were to major or minor in music in their college pursuits. There is \$35,560 in the fund and the money is invested with Edward Jones. The scholarships are for graduating seniors from the valley schools or Rogers High School where Al attended. The proceeds from Al's endowment provided **\$1,800** for scholarships. (This year, two students from Rogers High School were selected for the music scholarships and both had tremendous obstacles to overcome to get to go to college. Generous Club members raised another \$1,600 so that we could provide):

Two **\$1,700** music scholarships

Valley Rotary Charitable Association (VRCA). The VRCA was originally established to provide a place where charitable fundraising proceeds would reside and provide an IRS 501(c)(3) tax deductible status. Following the club merger, research showed that the tax status documentation was never properly filed, so the IRS status now comes from the Rotary District 5080 Charitable Fund where the money is accounted for. The proceeds are not invested and are paid out to any charitable organization the club wishes to support. The account has \$24,239, which originated from the prior fashion show and golf tournament. This year, the VRCA was used to fund:

\$7,000 for scholarships for graduating seniors (part of the \$9,000 for six \$1,500 scholarships given out)

Corn Booth

1600 volunteer hours, 1800 turkey legs, 2400 cobs of corn, 2000 baked potatoes, 55 cases of soda, 6 volunteer partners **\$53,436.80 raised.**

This year would have been the 27th year of the Rotary Corn Booth at the Spokane Interstate Fair. The Corn Booth was originally operated from a temporary stand set up by members at the fair each year and sold only corn on the cob and soft drinks. Over the years, the Club moved into a permanent facility, added baked potatoes and turkey legs, which have become a fair favorite. The Corn Booth has been the financial life blood of the Rotary Club, so far raising more than \$675,000, which the Club has donated to the Spokane Valley community in the form of grants to organizations and individuals, to fund scholarships and our Books for Kids' program. Many members of other Rotary clubs have worked in the Corn Booth. And, we have added partners over the years, the longest being the Spokane Rotaract Club, and more recently Joya, the HOPE School and STIX Diabetes Programs. These folks help make up the 150 volunteers working some 1600 hours to make the Corn Booth a reality. In addition to raising funds, the Corn Booth has been an opportunity for fellowship for Rotarians and non-Rotarians.
