Secretary's Report: Pasche

Grants Report: Storrer/Charters

- Pat asked Tim to please remind the club that the Rotary Endowment at the Community Foundation provides \$1 for \$1 match for gifts to eligible nonprofits made by individual Rotarians in our five-county region, up to \$250 annually. - Julie mentioned that several lakeshore clubs are using district grants for lighthouse maintenance/restoration projects and we could too.
- District grant (7th Street steps) progress report due June 30.
- Pat and Julie explained how club "annual share" eligibility works. "Rotary clubs are expected to contribute at least \$100 per capita annually to the Rotary International Annual Fund-SHARE. Additionally, every dues-paying Rotarian should contribute a minimum of \$25 personally to the Annual Fund. This per capita contribution requirement is crucial for clubs to be eligible for Global and District matching grant funds. Clubs that meet this requirement are recognized as Every Year Club". - Julie reported on her experience at the District Empowerment Summit. She brought several ideas:
 - o Creation of a Community Services Committee to focus on service projects.
 - Creation of a Club Connections Committee to focus on social events, publicity, and camaraderie.
 - Creation of a Fundraising Committee to create a new club fundraiser (e.g., a car or boat raffle, an online or in-person auction, etc.)
- We acknowledge there has not been great success in volunteer recruitment in the past. For
 example, it has been difficult to get volunteers to help with spring clean-up of Rotary Park (only 2
 volunteers out of 64 members). Despite this, we have new members who may be seeking more
 community engagement and there is no harm in trying.
- Committee recruitment might be more effective at the fall Assembly meeting rather than July, as July is a very busy time for most members.
