### Speaker Round-Up:

The Hon. Duncan Beagle, Chief Judge Circuit Court, and Barbara Menear - Circuit Court Administrator, spoke to us about the difficulties associated with COVID-19 and shutting down of Courthouses.

Menear discussed why the Courts cannot just close and discussed the importance of its responsibility to the public to continue operating.

For example, with Criminal Cases there are issues with judicial guidelines to resolve the cases from 1 year from the date the case is filed. Only two criminal jury trials have been held since March of 2020, with appropriate restrictions before further restrictive shutdowns were imposed.

Today, 567 people are in the County jail and 49 people are in the bullpen, with an additional 201 people on tether. The total jail capacity is 580. The issue of overcrowding is a possibility in the future and has been an issue in the past.

The Court is attempting to resolve as many cases as possible without trials, without the possibility of trial during the pandemic.

Communication was difficult as it was problematic to set up Zoom conferences for the inmates and in-person meetings at jail.

An order signed by Judge Beagle reinstated criminal jury trials effective June 8 is awaiting approval of the State. Juries will be selected on June 8 at the Harris Auditorium and the Circuit Court will return to trials (three trials simultaneously is possible).

Normally there are 30-40 criminal jury trials per year. Due to the system coming to a halt, the negotiated pleas are becoming more difficult. A major question is "How are you going to get jurors?" Typically yield is 70% of called jurors show up. Those with apprehension of serving in-person are requesting the right to reschedule. The two trials that were held were very comfortable and safety protocols were kept, and Continued on Page 2

# More Speaker Round Up – May 14 Meeting

Joe Serra, Chairman of Serra Automotive, spoke to us May 14 about the auto sales business. Serra has 51 dealerships in seven states. His operating mantra is "BePrepared, Plan on Hard Work, and Learn From Failures."

Serra Chevrolet was acquired by his father, Al Serra, in 1973 in downtown Grand Blanc. Joe joined his Dad in 1983. Eight years ago, the next generation has joined the firm. Matt Serra, who is the current Executive Manager of the Serra Dealership in Grand Blanc, assures the continuity of this independently family-owned automotive corporation. Joe is especially pleased to have his brother, Terry Serra, involved in the new Serra Corporate Headquarters in Fenton, Michigan.

Statistically, Serra Automotive operates in seven states with 2300 dedicated employees. Sales in 2020 were \$ 2.2 Billion consisting of sales of 64,000 automotive units.

Sales were dramatically impacted in March, April, and May of 2020 due to Covid `19. However, after those initial three months, sales slowly improved.

As you look at the automotive industry, approximately \$110,000,000 in sales were lost by the dealers in 2020. Today's current problem is the lack of new car inventory. The lack of semi-conductor chips is preventing the automotive manufacturers of providing the necessary inventory.

Serra Automotive is not comfortable with its current less than 30 -day inventory, preferring instead to have a 90-day inventory.

Lack of new unit sales leads to less trade-ins which are currently selling at a 20% premium. There is pent-up demand but it will be sometime before the automotive manufacturers can satisfy that demand. Therefore, new unit pricing has increased by approximately 24%. A function of Supply vs Demand which will eventually smooth out.

Joe is a huge fan of Electric Vehicles. He realizes that there are challenges to be addressed:

□ Pricing must be brought down.
☐ The Charging Infrastructure must be
significantly increased. Universal Charging will
happen by utilizing charging adapters.
☐ Government must continue to promote.

Autonomous Vehicles will be a reality but not in Joe's lifetime. Most likely, large semi-trucks running on inter-states highways will be the first to achieve that Autonomy.

Joe was asked about his new Ford dealership in Detroit. The fact is that the vehicle market is dominated by Ford in the Detroit area. He said 10% of all Fords sold are in the Detroit marketplace. The Ford F-150 Truck represents the best-selling truck in America for the last 8 years.

It's a PEOPLE Business and Serra Automotive Employees are dedicated to meeting all of its customers' needs.

Joe said Matt Serra is doing a great job of leading the Grand Blanc store by focusing on its employees and customers. Besides, he added, "Matt is better looking than I am on TV."
