## **PROGRAM**

John Hale introduced Adam Greshin who will give us an update on the Vermont legislature.

Adam said he planned to tell us what the big issues are for the next session in the legislature.

1) Reapportionment. Our district is too large. Each district is supposed to contain 4,172 people. We are too big for one and too small for two reps. It has been proposed to add Duxbury and Moretown, but the people of Duxbury wish to remain with Waterbury. This makes it a big challenge. We are the only district not settled, and it needs to be finalized by the end of next week.

2) Education Report - There is a big hassle over how to finance it. Act 60 is ten years old and pleases the majority of the towns, but is our education any better for it? It achieved its goal of equal resources for each town, but could we better control the method of deploying our resources?

3) Health Care - Debate over the Omnibus Health Bill - Are the benefits better for those who choose to purchase Green Mountain Care? The Catamount Blue Plan calls for a majority to participate.

How to fund it will be discussed next year (after the election).

4) Administration of the Alternate Energy Program

This includes all methods to reduce the use of fossil fuels. Much of it is already happening. All debates in the legislature and committee meetings is recorded and is being reviewed by the courts to help them make a decision on Vermont Yankee.

5) Irene Recovery costs. In particular, what to do about Waterbury. Keep the State Hospital where it was? With a different set-up? etc.
