## **PROGRAM**

Dave Babic's firm , Edward Jones, is for serious investors, but don't sell their own products.

He brought Ryan Nelson to discuss Social Security concerns and what the system will be in the future especially for the pre-retirees. He called for a show of hands for people who are retirees and got a response of about 90%.

For retirees, what will the system be in the future? Social Security was never meant to be the full source of income, it was just supposed to fill in the gap. It allowed people to plan ahead. You are notified 3 months prior to your 65th birthday.

It is never too soon or too late to plan. It takes only 4 quarters of paying into the system to be eligible. They use the high 35 years of earnings to determine your benefits.

Social Security is a social program to help people with lower incomes. DRC (Delayed Retirement Credit) works up to your 70th birthday - 8% credit prorated.

Earnings Test - some people may not be able to collect at 62.

Taxation depends on earnings from all sources. A couple making more than \$44,000 will have to pay up to 85% in taxes on their S.S.

For most of the elderly, medical costs are their greatest expense.

If you are still working after age 65, you will have to pay FICA. but you will get a rebate

Medicare - it is necessary to sign up for Medicare when you reach 65, otherwise there will be a penalty for the rest of your life. The Medicare premium is based on your income each year.

Health of System - was expected to last until 2041 without changes, but latest estimate is 2033 - after that payments may be reduced to 3/4.

System is earning enough now to work with subsidies to cover losses until 2022.
