PROGRAM

John Basile introduced our speaker starting with Bob Cummiskey who has published articles in the Valley Reporter. After Bob graduated from college, he became a CPA, and worked for several firms before joining the firm of Edward Jones. Fortune Magazine rated Ed. Jones as the 2nd best company to work for. He and his wife Susan, own and operate the Sugar Lodge on the Access Rd.

Bob told us that this bad time will pass. Since 1929, there have been 11 recessions - similar to the one in 2003 which hit the technology stocks. Over and over again we have come back.

His best advice is: Buy Quality stocks/Bonds Diversification - No more than 5% in one stock Hold for long periods of time e.g. 10 years

The above policy almost always works. Trying to outguess the market earns you less than doing nothing. Predicting the market is like steering a car while looking out the rear window.

Lower prices give you greater investments - now is the best time to buy. High yields often mean high risks. Even now some companies are paying dividends. Get stocks that have a good track record of paying dividends. The current issue of 'Perspective' contains a spread sheet listing companies' price, yield, 5 year div. growth rate and number of year paid dividends.

To save on income taxes, you may want to buy high rated Municipal Bonds.
