Program

Bruce Bertholon spoke on Medicare. His history is 30 years administering and enrolling voluntary group overage.

It is important that you understand how care is delivered, paid for, and provided. There are two ways:

- 1) Indemnity Plans Point of service or fee for service. Pays you or the provider a fee for the service provided.
- 2) Coordinated Care Plans. These are HMO or a facility with a staff. PPO is a network of facilities and Physicians in a Geo. area. An HMO provides the service using it facilities and staff.

A PPO provides a service using a network of Phys .and facilities.

An indemnity plan allows you to make the choice of the point of service

An HMO controls where and who

A PPO provides you with a group to select from within a set area.

Medicare Original: Part A - hospital; Part B - Physician, Part D - Drugs. Medicare Advantage - Part C - combined A,B,D and supplemental + extras

Original Medicare has gaps - so Medigap (new speak - supplemental) closes gaps. You can't get Medigap unless you have Medicare Parts A & B. The cost of Medigap is about \$2,200/year.

The plans all vary depending on which combo you choose. You can take the plan with you to another state. You must sign up for the Advantage plan between Nov 15th & Dec. 31 to cover the following year. The new health law effective Jan 1st may change everything.

Every facility in Vermont accepts Medicare. To be sure, call your doctor or the facility and ask if they will accept Medicare as payment in full.

Some small facilities can't afford to wait for Medicare to pay and will ask you to pay them at the time of service, and they will fill out the forms and have Medicare refund the fee to you.
