PROGRAM

To start the assembly meeting, Audrey gave everyone a summary of information about our club It was chartered in 1976 in Waitsfield, VT

The club expects each member to be an active member: attend meetings, donate time and money to our fund raising efforts, volunteer for public works, etc. The time and money put into the MRV Rotary Club will come back to you in satisfaction of having made a difference.

Dave Ellison started a discussion on what is tax deductible and what is not. Our club account is taxable, this includes dues, breakfast, purchase of raffle tickets, etc.; the

Foundation account is a 501c3 tax deductible account and contains money for charities (but no club expenses).

If you buy the raffle tickets assigned to you, they are not tax deductible but if you make out a check to the Foundation and tear up the tickets (then you have received nothing of value) this is tax deductible.

John Straub (former tax lawyer) explained about sponsors. Their gifts are deductible, but if they are given \$100 worth of tickets, that \$100 is taxable. If it is a business, all of it can be considered a business expense. It gets quite complicated

Other suggested fundraisers; so far only the Chili Cook-off is on the schedule.

Politics - At present, our club does not allow politicians to campaign at our meetings, but Jim Leyton would like to allow all sides to speak to us so we would be better informed on what each one stands for.
