### **PROGRAM**

Catherine Kalkstein told us about the Washington County Diversion Program.

This court rules on cases of young people who are first time offenders of misdemeanors. The offender must be remorseful and willing to go thru the Diversion program, repay any damages and pay the program fee (minimum is \$175.)

This program is an alternative to a formal police court process.

If successfully completed, the state's attorney then dismisses the charges and the court record is sealed two years from the date the charge(s) were dismissed. Thus the kids will be able to get scholarships, travel and have all the privileges of citizens with no criminal records.

80% of the kids going thru this court become responsible citizens.

Cases usually involve such things as underage drinking, vandalism petty theft etc.

Volunteers receive training before sitting on a Board. Prior to a Review Board meeting, members receive information about each case along with a victim impact statement (if pertinent) and a statement from the offender.
