This letter describes the Club's annual process for charitable giving. A two-part contribution form is enclosed for your use. The form gives you the option to give to The Rotary Foundation (TRF) or the Rotary Club of Dexter Foundation (RCDF) or both. Both the TRF and RCDF are 501(c)(3) charitable organizations so your contributions are generally tax-deductible. Following is additional information on each foundation:

The Rotary Club of Dexter Foundation (Part 1)

General Gift to Rotary Club of Dexter Foundation: These gifts will be distributed by the RCDF in the form of grants and scholarships.

Faith-In-Action (FIA) Weekly Produce Program: Our Club has been a supporter of FIA for many years. For the past two years, the RCDF has supplied fresh produce to the FIA pantry. Many club members desire to support this program by covering a week's worth of produce. This contribution allows members to accomplish this support.

The Rotary Foundation (Part 2)

Every Rotarian Every Year (EREY): This campaign supports the Annual Fund-SHARE of TRF. Contributions are used for district and global grants. TRF suggests a donation of \$100 but, of course, any amount is appreciated.

PolioPlus: Since this program was established in 1985, more than one million Rotary club members have volunteered their time and personal resources to protect more than two billion children around the world. The big push now is to eradicate polio completely. Your contributions to the PolioPlus campaign will assist in this effort. The Bill and Melinda Gates Foundation continues to support PolioPlus through its matching of gifts to this fund.

Your contributions to both EREY and PolioPlus are credited toward the \$1,000 total needed for the donor to achieve their first or next level of a Paul Harris Fellow. Again this year, the Club is matching a member's contribution to TRF up to \$100. These matching contributions are available to the first 20 club members making TRF contributions each Rotary year.
