President's Report - Jim Bruhn

Jim proposed to amend Article III, Section One of the Bylaws adopted on June 19, 2015 to provide the vote may be taken viva voice or by secret ballot. Ida will email notice of the proposed amendment to members before May 26, 2017. Motion to recommend to amend the Bylaws was made by Norlan and seconded by Shannon. . M/S/U

It was agreed to defer "Plant a Tree" until July under Rich Klahn's presidency. Rich noted that the cost would be \$20/tree.

Jim informed the board that the International Project Committee (David Pillers, Lori Freudenberg, Doug Bertrand, Dennis Lauver and Norlan Hinke) reviewed several projects for consideration. The committee recommends the "Agricultural Training Project in Haiti. The project is coordinated with Keith Holesinger of Fulton, IL. The project includes purchase of 1.5 acre plot of land, installation of a well and irrigation system and hiring of local personnel. The committee recommends committing \$3,500 towards the project, contingent upon the local group raising \$3,500 to match our contribution.

Norlan suggested inviting a representative from Haiti to speak to the club. Motion to recommend committing \$3,500 toward the project, contingent that matching funds will be raised was made by Norlan and seconded by Shannon. . M/S/U

It was noted that the legal name of the club's foundation is: "Clinton Rotary Foundation."

Jim said that Rotarian Dave Sivright is working on a project for the Clinton Showboat to refurbishing and painting the decking. Deadline to submit for a community grant is August 1. We need to show in the grant application that the club is in control of the project.
