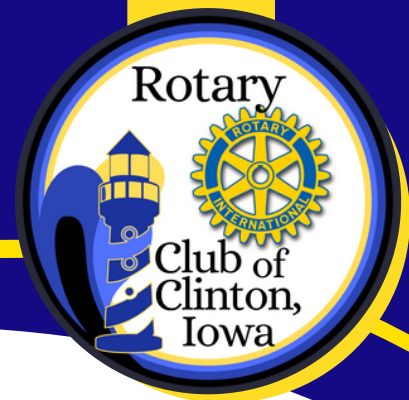

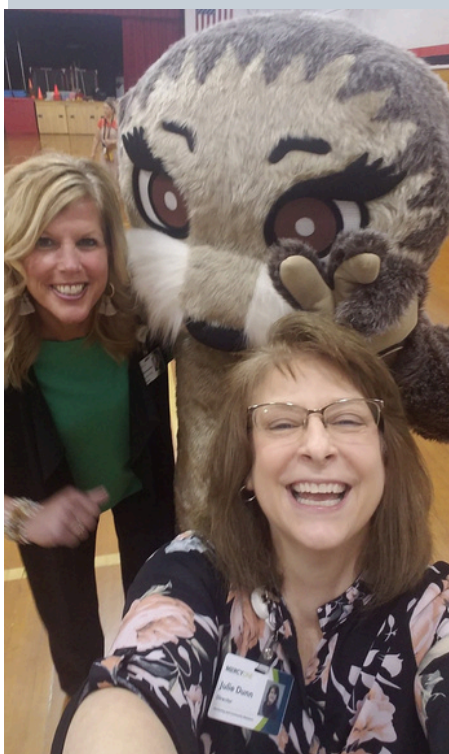

Adam Simpson from Atlas Roofing joined us on Monday. Simpson is the Senior Director of Operations and has worked with Atlas for nearly fifteen years. He operates a plant in Franklin, Ohio, but is the Project Executive for "Project New Horizon," the project that is being built at the Lincoln Way Industrial Rail Park, right across from the airport. Simpson introduced some background information on Atlas Roofing to us! Atlas Roofing is owned by one individual - Mr. Warren Hood, who established the company in 1982. Atlas Roofing Corporation has grown from a single roofing shingle manufacturing facility in 1982 into an industry leader with facilities in North America and worldwide product distribution. Atlas Roofing Corporation is made up of 4 divisions: Roof and Wall Insulation, Shingles & Underlayments, Web Technologies, and Molded Products. Simpson noted that, "it's truly a family company and we strive to keep that environment part of our business."

The Clinton plant will be the asphalt and shingle plant, so "we're manufacturing shingles for residential applications, so in your house, you have a laminate shingle or a three-tab shingle. That's what's going to be manufactured here. We're also going to make the accessories with it and what we're building in Clinton will be our Flagship plan. It's going to be our largest facility. It'll have two production lines, where most of our plants have one and we'll have 150+ employees working there at any given time. The intent is to operate 24/7 so once we fire up, we will run full-time, straight through, and continue to operate that way. It is our single largest investment Capital in this division since the purchase of the original four plants that came along and that make up Atlas," explained Simpson. In October, the Clinton area will start seeing the plant's construction. Simpson states that the only odor we will notice is a slight asphalt smell, which has been described as "sweet."

Thank you, Adam, for coming to our meeting! We look forward to Atlas joining us in Clinton!

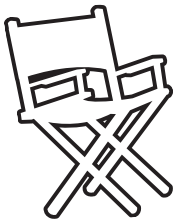
