THE FINANCIAL OVERSIGHT COMMITTEE MEMBERS COMPLETE A WRITTEN CONFLICT OF INTEREST DECLARATION TO ASSURE MEMBERS DO NOT HAVE A CONFLICT WITH THE EXECUTIVE DIRECTOR. ON A THREE YEAR BASIS, THE FINANCIAL OVERSIGHT COMMITTEE COMPARES DATA WITH OTHER LARGE ROTARY CLUBS HAVING AN EXECUTIVE DIRECTOR IN A FUNCTIONALLY COMPARABLE POSITION AT A SIMILARLY SITUATED ORGANIZATION. THE AUDIT COMMITTEE MAINTAINS MINUTES TO DOCUMENT THE DELIBERATION AND DECISION REGARDING THE COMPENSATION ARRANGEMENT OF THE EXECUTIVE DIRECTOR. THE FULL BOARD REVIEWS THE RECOMMENDATION OF THE FINANCIAL OVERSIGHT COMMITTEE AND VOTES ANNUALLY ON THE EXECUTIVE DIRECTOR'S COMPENSATION PACKAGE.
