Our immediate past president not only made it to his first meeting, he also provided the program for the day.

Did you know?:

- Paul Harris was a Lawyer who graduated from the University of Iowa.
- He was kicked out of more than one school.
- He was a cowboy who traveled to Europe on a cattle ship, in search of himself.
- He was raised mostly by his grandparents, attending boarding school in Vermont.
- He worked for a bank in lowa; a newspaper reporter; a business teacher; and a stock company actor before becoming a lawyer, practicing in Chicago.
- He was very involved in the peace movement. When he was on his dying bed, he wanted to be placed near a window overlooking his peace garden.
- He initiated Rotary by calling together three friends to meet and talk about each of their professions (February 23, 1905). His aim was to enhance his career:
 - Silvester Schiele, a coal merchant;
 - Gustavus Loehr, a mining engineer;
 - Hiram Shorey, a merchant tailor.
- He was involved with other civic and professional work:
 - First chairman of the board of national Easter Seal society of Crippled Children and Adults USA;
 - Member of the Board of Managers of the Chicago Bar Association;
 - Received the Silver Buffalo Award from the Boy Scouts of America for distinguished service to youth;
 - Was decorated by the governments of Brazil, Chile, Dominican Republic, Ecuador, France and Peru.
- When he passed away on January 27, 1947 his dream had grown from an informal meeting of four men to some 6,000 clubs. In the past five decades, the organization has grown to more than 27,500 clubs with 1.2 million members.

How did he have the wherewithal to found such an organization? HE KEPT TRYING.

July was renamed for Julius Caesar, and is the seventh month of the year in the Gregorian Calendar, and is 31 days long. In prior years, it was called Quintilis. If you know your latin, that "Quint" thing is screaming "# 5". That makes perfect sense since it was the fifth month in the Roman calendar, which started in March.

July and April start on the same day in each year.

July is the seventh month of the year in the Julian and Gregorian Calendars and one of seven months with the length of 31 days. It was named by the Roman Senate in honor of the Roman general, Julius Caesar, it being the month of his birth. Prior to that, it was called Quintilis.

THIRD. The application of the ideal of service in each Rotarian's personal, business, and community life;

FOURTH. The advancement of international understanding, goodwill, and peace through a world fellowship of business and professional persons united in the ideal of service.
