The Rotary Foundation has moved up 14 places in the Chronicle of Philanthropy's annual survey of the top 400 fundraising charities in the United States.

In the survey, based on fiscal year 2010, the Foundation is 61st on the list of charities that raise funds from private sources, compared with 75th the previous year. Funds raised for Rotary's US \$200 Million Challenge contributed to the ranking.

The Chronicle, which covers nonprofit news around the world, ranks the fundraising performance of charities based on cash donations, as well as gifts of stock, real estate, art, medicine, food, and other noncash items.

An article published on 16 October provides an overview of the survey and highlights the Foundation's fundraising efforts for polio eradication, particularly among younger donors.

Hy-Vee

Josh Asche, Director of the HyVee Grocery Store at 86th and Douglas, told us the story of the new construction taking place at that location. The new store, scheduled to be completed approximately a year from now, will be the largest of the 235 stores in the chain, at 95,000 square feet. It will have a large, restaurant-style dining area and food court, with seasonal outdoor seating and a bar with TV screens. In addition to the traditional grocery items, the store will emphasize a wide range of fresh products, including organic produce, artisan breads and other specialty baked goods, ethnic food centers, fresh sushi, a sandwich shop, other carry-out meals, and three or four professional chefs doing cooking classes and demonstrations. The new store is being designed for energy efficiency and expects to be LEED certified, though the level is yet to be determined.

HyVee runs its own educational program for prospective managers, starting them with a three-month crash course to test their vocational interest, and then followed by a oneyear training program to learn store management in depth. Mr. Asche himself is a 20-year veteran of the HyVee system, having started with the organization at age 14 as a bag boy, working up through eight stores and multiple positions to become director of this store, which has 94 full-time employees and 240 part-time employees, and expects to hire

substantially more when the new building opens.
