Judge Larry Eisenhauer

Judging on the Frontier Iowa Judges in Europe

Judge Larry Eisenhauer joined us to relay his experiences as an international judge in working for the United Nations in Kosovo. Judge Eisenhauer is a Drake University alumnus, past president of the Rotary Club of Ankeny and a Paul Harris Fellow!

Judge Eisenhauer framed his personal experiences with the stories of two other Iowan's experiences as international judges: Charles Wennerstrum and Leon Powers. Both men served as international judges during the Subsequent Nuremberg Trials in 1948.

Judge Powers heard what became known as the "Wilhelmstrasse Trial" involving the various war crimes. Judge Wennerstrum was the presiding judge in the "Hostages Case" which considered the actions of German Generals stationed in Yugoslavia.

This case centered around Nazi reprisals against the civilian population for Partisan attacks on German targets. The status of the Partisan's as combatants, whether lawful or unlawful, was at the care of the court's deliberations. These issues continue to be pertinent today as our justice officials consider the standing of prisoners held at the US base at Guantanamo Bay, Cuba; are they lawful or unlawful combatants, and how should they be treated based on that determination?

Judge Eisenhauer arrived in Kosovo in 2005 following years of conflict in the former Yugoslavia as Serbian forces attempted to drive Albanian populations from the country.

His case experiences in Prizren and Pristina included a human trafficking case, a murder case and work as the investigating judge on a bridge bombing case. He observed how deep and powerful the ethnic conflicts in the former

Yugoslavia really are, noting the local ability to describe the deep impact of the Battle of Kosovo as if it had just happened, even though it occurred in 1389.

Rotary Minute...

Literacy Projects

The month of March is literacy month. I would like to talk with you about how much literacy is a problem in the world around us. An estimated one billion people - one-fourth of the world's adult population - are unable to read. Illiteracy among adults and children is a global concern in highly industrialized nations and in developing countries.

The tragedy of illiteracy is that those who cannot read are denied personal independence and become victims of unscrupulous manipulation, poverty, and the loss of human dignity.

Many Rotary clubs have surveyed the needs of their community for literacy training and developed projects to meet those needs. In our case, we began reading with the children at Longfellow Elementary over 15 years ago.

I can remember stories that told us that only about 30% of these kids could read at or above their age level. All others were well below.

A few years ago a new school was built where Longfellow once stood. It has been renamed George Washington Carver Elementary and the number of kids attending has increased dramatically. Many of our members read with these kids every week and it is just amazing what an hour of our time each week can do to improve the literacy of these children. Thanks again to all of our volunteers.
