# Burro BBQ succeeds again

Standing there on Saturday, amidst all of the organization and activity spread through the Rotary Ramada and the Community Park, one Rotarian surveying it all commented in awe, "This really is something, isn't it?"

The Burro Barbeque is indeed something remarkable in its size, scope and longevity. In its 58th year, few Rotary clubs anywhere can boast any event of this magnitude or duration. More than 40 vendors set up this year. Numerous activities for families and kids were offered, including a kids' coloring contest. Entertainment was non-stop from 9:00 to 5:00, including numerous musicians, a magician and a number of kids' dance troups. Some forty participants pitched horseshoes in that tournament, and the Mad Dog Bar & Grill reclaimed the giant Tug-of-War trophy in this year's competition.

From the time the food serving began at 11:00, a hungry line stretched to the end of the ramada most of the afternoon. Burlap-wrapped packets containing 1,400 pounds of beef were pulled from our pits after 24 hours of slow roasting, and relatively little was left over when the crowd had eaten their fill of the beef, beans, potato salad and rolls we served.

So many of our members could be cited for their outstanding efforts in coordinating the many different areas and activities that went into making this event the truly remarkable success that it was. Our hats are especially off, though, for the great job Frank Hart did in stepping up to coordinate the BBQ this year.

And the best part? Frank said he got so much help from the club members, he's willing to do it again next year! *Yeah, Frank!!*

### **Proposing changes to Rotary**

You are probably aware that changes to Rotary International are made by an international Council on Legislation that meets once every three years.



This Council is comprised of representatives selected by every Rotary district around the world. RI's next COL will be held in Chicago in 2010.

You may not be aware, though, of how the proposed Enactments (which are intended to change RI's constitutional documents) and Resolutions (procedural changes that would not require alterations to those constitutional documents) originate. The fact is that any Rotarian, in any Rotary club in the world, can initiate an Enactment or Resolution.

Here is the way the process works. If you want to propose a change in the way Rotary is structured or functions, you would begin by typing up your proposal in the required format, per the RI Manual of Procedure. Our club would have to first adopt your proposal at a regular club meeting. After its adoption by the club, it would be forwarded to our District Governor, John King, with a letter signed by our club president and secretary, certifying that it has been adopted by the club. The proposal and accompanying letter must be received by DG King no later than May 23, 2008. The proposals received from the clubs are then considered and voted on by the clubs' delegates to the District Council on Legislation, to be held at the District Conference in Phoenix on May 30 - June 1). Districts may also propose legislation, but each district is permitted to submit a maximum of 5 proposed pieces of legislation to the RI COL.

The proposals adopted by the District Council on Legislation must be received at RI headquarters in Evanston, IL, no later that December 31, 2008. The RI staff first reviews each piece of proposed legislation to ensure that it has been endorsed by the district, certified by the governor and that it has arrived by the 12-31-08 deadline. The staff committee then reports its findings to the RI Board of Directors, which makes a final determination as to whether the legislation is duly proposed. An enormous amount of work also goes into the analysis of the proposals, organizing of them by subject and the printing and distribution of them to the districts' chosen representatives to the RI COL well in advance of the meeting of that legislative body, to give these representatives, along with the clubs and districts, an opportunity to thoroughly review them.

Want to change Rotary in 2010? If so, you need to act quickly. Time is running out for submitting club-adopted proposals to DG King by the May 23, 2008 deadline. By the way, PDG Don Schiller, of Prescott, will be representing D5490 at the 2010 Council on Legislation.
