Make those year-end contributions that count!



Your tax deductible contributions to Rotary's Vocational Fund and our Interact Club can translate into dollar-for-dollar state tax credits. *First*, your \$400 contribution as a couple (or \$200 as a single) to the Rotary Vocational Fund of Arizona qualifies for a \$400 state tax credit on AZ Form 321 - Credit for Contribution to Charities that Provide Assistance to the Working Poor. (You must be itemizing deductions, and some limitations may apply. Consult your tax professional.)

Second, your \$400 contribution as a couple (or \$200 as a single) to Mohave High School for our Interact Club qualifies for a different \$400 credit, claimed on AZ Form 322 - Credit for Contributions Made or Fees Paid to a Public School.

If you make these two donations before Dec. 31st, you get the entire \$800 back as a state tax credit when you file your tax return in January (or whenever). *Plus* - if you are in a 25% tax bracket, *you also save yourself \$200 in federal taxes* by taking that \$800 as charitable deductions on your Schedule A. The higher your tax bracket, the more you save (until you hit the phaseouts for the wealthy).

Donation forms are available at our club meetings, or they can be e-mailed to you for your convenience.

Donate now and save money on your 2007 tax returns.
