On November 18, while volunteering her time with the local youth soccer program, Maureen suffered a stroke and a brain aneurysm. She has undergone two brain surgeries and is in a coma, with her condition still critical.

A Maureen Smith Relief Fund has been established, and contributions can be made to that fund c/o The Rotary Club of Bullhead City, P.O. Box 21026, Bullhead City, AZ 86439. An article by our club president, Kelly Burgess, appeared in the local papers last week, informing the community of this need.

### New minimum wage law has teeth

Arizona voters passed in November a new \$6.75 minimum wage that takes effect January 1, 2007. The new law is tough, and it has some sharp

teeth.

First of all, the law applies to almost all employers - except the State of Arizona, the federal government and small businesses with less than \$500,000 gross annual income, and who are not subject to the Federal Fair Labor Standards Act. Since most businesses are subject to that act, in one way or another, that exempts very few small businesses.

Restaurants need to read this new law carefully. For employees who customarily and regularly receive tips or gratuities, an employer may pay a wage of up to \$3.00 less than the minimum wage, but not less than \$3.75. However, if an employee's tips,

combined with the employer's direct wages, do not equal the new Arizona minimum hourly wage, the employer must make up the difference.

There are some stiff recordkeeping and posting requirements required of employers by this new law as well. Employers must maintain payroll records showing the hours worked for each day worked, and the wages paid to all employees - for a period of four years. If an employer fails to do so, the Commission is empowered by the law to presume that the employer did *not* pay the required minimum wage rate, and to take authorized action against the employer. A first negligent violation results in a civil penalty of \$250, with subsequent or willful violations costing \$1,000 or more for each violation.

So what happens if an employer fails to pay an employee the minimum wage after January 1st? The law requires that employer to pay the employee the balance of the wages owed, plus interest. But that's not all. In addition, the employer is required to pay the employee an *additional* amount equal to *twice* the underpaid wages.

A word of warning to any employer who may consider retaliation against an employee who has filed a claim for payment of these wages: *Don't even consider going there!* 

Any employer who retaliates against an employee or other person in violation of this new minimum wage law is required by the law to pay the employee "an amount to be set by the Commission or a Court sufficient to deter future violations, but not less than one hundred fifty dollars for each day that the violation continued, or until legal judgment is final."

Will the new minimum hourly wage remain at \$6.75? No, it will be raised on January 1 of each succeeding year by the calculated increase in cost of living.
