Featured that evening will be the Melody Lane Duo. You will appreciate their music!



## Interested in being a club leader?



Our Club Board this year is giving club members the opportunity to



either nominate or to volunteer for the following club officer positions for the next Rotary year (beginning July 1):

- President-elect
- Secretary
- Treasurer
- Foundation Chairman

Changes are being made in our leadership structure. The board adopted, and the club will be implementing, the new Club Leadership Plan. Clubs already utilizing this new structure claim it has done some great things to help their clubs to become more focused on the essentials that make Rotary clubs effective and successful.

Nominations will be closed on November 30th. The resulting slate of officers approved by the Board will be presented to the club on December 7th, at which time additional nominations can still be made. Help for the TRF Permanent Fund by Art Harrington



### The Rotary Foundations's Permanent Fund could benefit significantly from the Pension Protection Act of 2006.

In 2006 and 2007 only, donors who have reached the age of 70 1/2 may annually transfer up to \$100,000 from their Individual Retirement Account (IRA) to The Rotary Foundation - *without increasing their federal gross income by a cent!* 

This is great news for supporters of The Rotary Foundation who would like to turn retirement assets into charitable gifts during their lifetimes, but have been discouraged from doing so, due to increased income taxation. (Their gross income has always increased by the amount they have withdrawn from their IRA, and they have had to pay tax on that amount - even if they intended to give it to a qualified charitable organization.)

For this limited window of opportunity that circumstance is changing. Up to \$100,000 can be transferred to the Foundation. The individual's gross income does not increase by any amount, and no tax is due on the withdrawal of this tax-deferred income. (A couple could transfer as much as \$200,000 per year from their IRA accounts.)

However, the person cannot also deduct the gift as a charitable contribution, after being allowed to escape the taxes on the transferred amount. IRS would regard that as "double-dipping."

Immediate action is required, though, to take full advantage of this recently-passed
